TITLE : RELATING TO MOTOR VEHICLE TOWING.
INTRO : Espero W (first primary)
DESCRIPT : Establishes provisions relating to the regulation of towing operations. Authorizes the counties to enact and enforce ordinances regulating towing operations. -- Amends provisions relating to vehicles left unattended on private and public property; tow truck signage and insurance requirements; and motor vehicle towing and storage settlement by limiting their application to a county that has not adopted ordinances regulating towing operations. Increases storage fees allowable. --SB0295 CD1

INTRO : Espero W (first primary), Chun Oakland S
DESCRIPT : Appropriation to the public utilities commission to continue a telephonic reading system service that provides individuals who are blind or visually impaired with toll free telephonic access to time sensitive information. Authorizes the commission to contract with a qualified private, nonprofit organization to provide these services. (\$\$) -- SB1647 CD1

DESCRIPT : Establishes provisions relating to release or waiver of construction defect. Provides that any release from or waiver of liability by a seller to any government agency is a material fact that shall be contained in a disclosure statement. -- SB2704 CD1

TITLE : RELATING TO CHARITABLE ANNUITIES.
INTRO : Espero W (first primary)
DESCRIPT : Amends provisions relating to life insurance. Clarifies that the transacting of life insurance includes contracting to provide additional benefits in the event of death or dismemberment by accident or accidental means. Further clarifies that transacting of life insurance includes the granting of annuities and endowment benefits that are provided under charitable gift annuity agreement with a donor and issued by a nonprofit educational foundation or a nonprofit corporation. Establishes requirements for nonprofit educational foundations or nonprofit organizations issuing charitable gift annuities. -- SB3049 CD1

INTRO : Espero W (first primary), Kanno B
DESCRIPT : Provides that the Center for Cultural and Technical Interchange Between East and West, Inc., may submit for approval by the state, a plan for extending the benefits of social security. Requires the Center for Cultural and Technical Interchange Between East and West, Inc., to fund all costs incurred as a result of the extension of benefits. -- Amends provisions relating to federal social security for public employees. Changes the phrase health, education, and welfare to health and human services. -- SB3175 CD1
