Aloha Friends and Neighbors,

The 2011 Legislative session is over and now we are in our first full month of the interim. The final days of the session was surely eventful with intense conference negotiations between the State Senate and State House.

In conference committee meetings, the Senate Ways and Means committee was able to convince the House Finance committee to hold on any type of taxation on pension income or any consideration to increase the General Excise Tax (GET). It was a challenge to the end, but the Senate held its ground and stood firm for the tax payers of the state and especially those that are pension recipients.

Balancing the state budget continues to be a great concern for legislators and the Administration. At the close of session, Governor Abercrombie commented on calling for a special legislative session if the state deficit grows. This decision would be based on economic indicators such as the Council on Revenue's projections and the State's monthly tax collections.

The Council on Revenues (COR) met at their regularly scheduled meeting on May 26th and maintained their projected revenue growth at –1.6%. At the meeting, the COR members concluded that the economy is gradually recovering and tax collections will steadily increase in the coming years.

Shortly after the COR meeting, Governor Abercrombie announced that with the revenue projections unchanged from the amounts used to approve the upcoming two year budget, his Administration remains committed to working the budget agreed upon with the Legislature and a special session is not necessary.

We are now awaiting the June 30 tax collection report. The April 30 report showed a rebound in collections we are hoping the same in June.

I have been continuing my duties as Chair of the Committee on Tourism.

Currently, I am conducting walkthroughs of our tourism infrastructure across the neighbor islands. A major area of my attention has been on our airports—currently in the 5th year of a 12-year \$2.3 billion modernization project. Additionally, I was also able to follow up on issues and concerns that I have investigated over the past several years at various airports around our State.

Hawaii State Senate Stays Green!

This year's 2011 Awardees in Green Business and Government include both the Hawaii State Senate. In 2008, the Hawaii Senate began a Paperless Initiative which resulted in the reduction of paper waste by 60% from the previous year's five month session. Pilot efforts in paperless committee hearings in 2009 reduced paper waste by an additional 20%. Senate members and staff promote Aloha Aina community recycling events and green office practices. The Senate also participated in the Green Government Challenge, the Capitol's conservation initiative including the areas of energy conservation, recycling, emissions reduction and water conservation. The Green Business Program is a partnership of the Hawaii State Department of Health, Department of Business, Economic Development and Tourism (DBEDT) and the City and County Department of Environmental Services Recycling Office and Board of Water Supply, and the Hawai'i Chamber of Commerce.
