### LEGISLATIVE UPDATES

While May 3, 2012 marked the adjournment of the Hawaii State Legislature's 2012 Regular Session, Governor Neil Abercrombie had already signed more than 50 Senate Bills into law before the end of the session. During this legislative session, the Legislature passed 345 bills, of which 166 were Senate Bills. Many of the bills that were sent to the Governor for consideration still await his signature.

**Notice of Intent to Veto Deadline:** If the Governor has any intent to veto a bill, he must give notice to the Legislature by the 35th day after adjournment. This year, the 35th day after adjournment falls on *June 25, 2012*. Any bill for which notice is not given will become law, either by the Governor's signature within the next ten days or by effect of law on the 45th day. The Governor's notification of intent to veto does not necessarily mean that a bill will be vetoed. The Governor can still change his mind and sign the bill, or simply allow it to become law without his signature.

**Veto Deadline:** After the Legislature adjourns, the Governor has forty-five days (excluding Saturdays, Sundays, and holidays) to consider bills presented to him. This year, *July 10, 2012* marks the 45th day after adjournment and is the last day for the Governor to veto bills from his intent to veto list. Any bills not signed or vetoed by this date will become law without the Governor's signature.

**Special Session:** The Legislature may convene at or before noon on the 45th day in special session to amend a returned bill to meet the Governor's objections or to override the Governor's vetoes. The Legislature may override a veto by two-thirds vote of all members of the Senate and House of Representatives.
