(1) Why do you wish to be a member of the Psychology Board?

I love psychology and being a psychologist. The field of psychology has provided me with the opportunity to utilize my training, knowledge, experience, and skills to make a difference in meaningful ways for those in need of mental health services and to educate Hawaii's community about access to behavioral health resources. It would be an honor and privilege for me to serve on the Board of Psychology as a means of giving back to Hawaii's community where I have dedicated over 40 years as a licensed practicing psychologist.

(2) What do you perceive are the roles and responsibilities of a member of the Psychology Board?

As a member of the Board of Psychology, I would be deeply committed to upholding licensing policies and maintaining standards of excellence in psychology practice that provide public health, safety, and welfare, while promoting the best practice by those licensed to practice within our state.

The role of the Board is also the regulate and protect the public from the practice of psychology by unqualified persons and from unprofessional conduct by persons licensed to practice psychology.

(3) Given your understanding of the roles and responsibilities of a Psychology Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

Educationally, I earned my B.A. with honors from the University of Hawaii in 1973 and pursued graduate studies with a M.Ed. from Harvard University in 1974 and a Ph.D. in Clinical Psychology from Northwestern University in 1980. Upon receiving my doctorate, I became a licensed psychologist in Illinois, where I worked for a few years at the University of Illinois, Chicago Campus Counseling Center in addition to establishing a part-time independent practice.

In 1981, I returned to my home state of Hawaii and have pursued my lifelong passion in utilizing psychology to promote, advance and deliver culturally informed mental health services to our communities. I am a Hawaii licensed psychologist, having earned Board Certification from the American Board of Professional Psychology in Clinical Psychology. My clinical and professional practice has specialized in the diagnostic assessment and treatment of a culturally diverse population of children, adolescents, adults, couples, and families. I have expertise in the treatment of children, parents, and families undergoing the divorce process and in the forensic investigative interview of minors with allegations of sexual abuse, felony physical abuse, and witness to interpersonal violence. My other areas of focus have included the diagnosis and treatment of attention deficit hyperactivity disorder and learning disabilities, trauma, anxiety, depression, parenting, relationship difficulties, and coping with major life stresses.

As a member of the Board, I plan to utilize additional knowledge and skills that I developed through experiences as a psychological consultant to judiciary programs, multi-disciplinary teams and non-profits; Chief Psychologist and training director of an accredited psychology predoctoral internship program; APA accreditation site visitor; university faculty/lecturer; public education coordinator; expert witness in civil and federal courts; guardian ad litem; child abuse forensic investigative interviewer and statewide trainer; editorial board member and peer journal reviewer; supervisor and mentor; program developer; and national conference presenter.

(4) What do you hope to accomplish during your term of service?

Our psychology licensing laws serve to protect the public by enforcing standards that restrict practice to qualified individuals who have met qualifications in receiving a doctoral degree in psychology from an accredited institution of higher education, accrued the necessary formal supervised training hours, and pass the Examination for Professional Practice in Psychology. I plan to contribute my time and expertise to ensure that prospective applicants for licensure are qualified to practice psychology based on Hawaii's licensing laws and regulations. I am also invested in ensuring that licensed psychologists actively practicing within our state pursue the requisite approved continuing education to keep abreast of the field in our diverse and multicultural communities.

(5) Name three qualities that best describe you and how these qualities will benefit the Psychology.

A psychology colleague who served previous two terms on the Board of Psychology and worked closely with me over the years shared her impressions of my qualities and how they will benefit Psychology "Dr. Ching has served in many leadership roles, both locally and nationally and is an excellent role model for early career psychologists...I strongly believe that Dr. Ching's integrity and professionalism will be an asset in furthering the Board's mission. She has consistently committed to excellence in training psychologists, worked tirelessly to educate the community about the scope of psychological practice, devoted time and effort to HPA and APA guild activities and maintained the highest ethical and professional standards in her work."

Dedication and unwavering commitment to psychology and psychologists.

This is exemplified by ongoing professional engagement in the delivery of culturally competent clinical services to patients, investment in the education, training, and consultation for psychologists at various stages

of their careers, advocating for scope of practice and access to services for underserved populations, championing diversity and inclusion in all my activities, coordinating psychoeducational public education activities, and leadership service in state and national association matters.

Professionalism.

My pursuit of a high level of competence, knowledge and skills as a practicing psychologist has kept me abreast of the most relevant issues for professional psychology and standards of practice for licensing Boards locally and nationally. I will enter the Board with a keen understanding of current considerations for practicing psychologists, standards of care, licensing requirements, and interjurisdictional matters. On the forefront of licensing boards are emerging issues of equity, diversity, and inclusion concerns, PSYPACT, ASPPB's efforts to implement the EPPP-2 exam for assessment of clinical competence, along with healthcare access through telehealth.

I have received feedback that I am well respected by my peers and those in the community. I strive to lead by example, be of service to others, and model integrity and highest ethical and professional standards in all my undertakings. My collaborative approach, conscientiousness, willingness to "step up to the plate", inclusiveness of others, and appreciation of differences are qualities that have been welcomed by committees, task forces, and boards that I have had the honor to serve on.

(6) Name a previous experience you've had that will be beneficial as a Psychology Board member.

My sense of commitment has also extended to state and national guild activities involving volunteer leadership positions in the Hawaii Psychological Association (HPA) and the American Psychological Association (APA). I have served as president of HPA and APA's Division 42 (Psychologists in Independent Practice), along with serving on the National Register Board for Health Care Psychologists, and APA Boards such as the Committee for the Advancement of Professional Practice, Board of Professional Affairs, Board for the Advancement of Psychology in the Public Interest, Membership Board, and the APA Council of Representatives. Having served on HPA and APA advocacy committees, I am knowledgeable about legislative advocacy efforts that advance psychology practice. My other public service activities involve being a member of the Diocesan Review Board and past advisory board member for Prevent Child Abuse Hawaii.

(7) Can you foresee any possible conflicts of interest that could arise during your service on the Psychology? How would you overcome conflicts of interest?

I am not aware of any existing conflicts of interest in my service on the Psychology Board. If any possible conflicts of interest arise, I plan to seek immediate consultation with the Board staff and AG for their input and guidance.
