My name is Marleen Akau, and I am the V. P., General Manager of The Royal Hawaiian Center, managed by The Festival Companies (TFC). I am **very much in support** of the appointment of Susan Todani to the Hawaii Community Development Authority.

I first met Susan in 2001 when she was appointed by the Trustees of Kamehameha Schools (KS) to three different Boards which oversaw the *for-profit subsidiaries* of KS. She was the only KS staff member who served on the Boards for these subsidiaries, with the others being external directors. As a Board member, she was professional, easy to work with and concerned about meeting goals from multiple value perspectives. On a personal level, she was helpful and supportive of me especially when there was a vacancy for the General Manager position at the Royal Hawaiian Center.

Susan also was the Development Director which oversaw the redevelopment of the Royal Hawaiian Center. KS had made several attempts over the decades to renovate the Center but was never successful in starting. Through her formation of a new Development and Planning Division, hiring of staff, and clearer vision from the KS Strategic Plan, she was able to convince the organization to move forward with its' first major renovation of the Center in its 26-year history.

TFC (based in Los Angeles) also aided Kamehameha Schools as fee developer of the Royal Hawaiian Center. Susan was KS' team leader. As part of the redevelopment team, I was able to see how she guided us through internal workshops, community and tenant meetings, weekly Owner/Architect/Contractor (OAC) meetings and at public events in media communications to support multiple organizational goals. These included:

- Honoring the history of Helumoa and its connection to Princess Bernice Pauahi Bishop.
- Creating a community gathering place for kama'aina and malihini alike.
- Working with TFC on bringing in a vibrant mix of retailers (beyond just luxury stores) which could capitalize and supply synergies within the site's dominant Waikiki location.
- Working with KS educational and cultural staff to supply input on commercial projects (a first for KS).
- Supplying the economic, cultural, educational and community justification for the Trust to support the renovations.

Susan sees the big picture and can move initiatives, teams, and organizations forward, under new and challenging environments. She also actively collaborates with the community as a Board Member of the Waikiki Community Center. I believe that she could do the same for Hawaii Community Development Authority.
