Mahalo for the opportunity to submit testimony in **STRONG SUPPORT** of GM 557 regarding the confirmation of Vernon Inoshita's appointment to the Hawaii Community Development Authority. I have known Vernon Inoshita for 30+ years. He has a wealth of knowledge and experience that he brings to the table. Vernon Inoshita is a founding Principal & President of Design Partners Incorporated and is responsible for the management of the firm, parlaying it into the number one Architectural Firm for 2018 and 2019, PBN. Mr. Inoshita also serves as Lead Designer and Principal in Charge of the firm's largest and most complex projects. His experience spans the entire spectrum of design, from high-rise luxury condominiums, resort and hospitality, multi-family affordable housing, to airport improvements and educational facilities.

Since the Inception of Transit Oriented Development in Honolulu, Vernon has been at the forefront of this urban growth, forging the community connections that are enabling the healthy growth of Kaka`ako and the Kapi`olani Corridor. Current projects include the award-winning Kapi`olani Residence, Azure Ala Moana, Sky Ala Moana, The Park on Keeaumoku, The Central Ala Moana, and Waihonua at Kewalo.

Working with DPP, two of the projects required changes proposed by Vernon amending the Ala Moana Master Plan, which was then successfully implemented. Prior to his career at Design Partners Incorporated, he served as a senior designer for a number of firms on the mainland as well as in Hawai`i. On the mainland, Vernon was a designer with Minoru Yamasaki, working on the World Trade Center in New York and the Century Center Towers in Los Angeles.
