Through my previous work as acting supervisor of the Health Division and my current role as FDAG, I have had the opportunity to work very closely with Holly. I am continually impressed by her institutional knowledge of the department, depth of management and leadership skills, her integrity and strong sense of fairness and honesty, as well as her legal insight gained over a period of over thirty years in public service working up the ranks in the department and five years before that in private practice.

What is most impressive, however, is her dedication to being in the trenches with her deputies. Holly is always willing to listen and provide feedback on the many complex cases the department faces. In order to do so, she is frequently the first person in and the last person out of the office so that she can review and understand the non-stop briefs, written opinions, legislative testimony, and critical legal decisions that must be made on a daily basis. Her exceptional standards of professionalism and public service as well as energetic and positive attitude are an inspiration, and she is a role model for the department who leads by example.

There are few attorneys who have the intelligence, experience, temperament and character to lead the Department of the Attorney General. Holly Shikada is that rare individual and it has been an honor and a privilege to work alongside and learn from her. Therefore, I respectfully and strongly urge the Committee and the Senate to confirm Holly Shikada's appointment as Attorney General. STRONG OPPOSITION IN HOLLY SHIKADA BEING CONFIRMED AS THE ATTORNEY GENERAL, STATE OF HAWAII-GM596

Good morning Chair Rhoads and members of the Senate Judiciary Committee. I am Daniel Hanagami, the Chief Special Investigator for the Investigations Division of Department of the Attorney General. I am submitting this testimony in my personal capacity and on my own time.

I have held my position as Chief Special Investigator for over eight years. Prior to that, I served in the Honolulu Police Department for 27.5 years and 8 years as a private investigator. Retiring as a Major in the Honolulu Police Department, I have investigated the majority of the complex financial fraud and government corruption cases in Honolulu. I had a stellar, accomplished, decorated, and unblemished career in serving our community. I take pride in upholding and maintaining the integrity of the Investigations Division and the Department as a whole. Because of my belief in fairness, integrity, and honesty, I am compelled to <u>strongly oppose the nomination</u> of Ms. Holly Shikada for the position of Attorney General.

Currently, I am a subordinate to Attorney General Holly Shikada, and she is my supervisor. She was also my designated supervisor when she was the First Deputy Attorney General, since the prior Attorney General had to recuse herself from supervising me due to the civil rights violation she committed against me.

I am strongly opposing the confirmation of Holly Shikada as the Attorney General for the State of Hawaii based upon my interactions with her. I personally observed that she lacks the following essential qualities in being the Attorney General for the State of Hawaii: integrity; honesty; legal ability; leadership and managerial skills; common sense; communication skills; problem solving abilities; ability to be fair; and she is not ethically sound to uphold this esteemed position as the top law enforcement officer and legal counsel for the State of Hawaii.

Attorney General Shikada has participated and schemed, with the prior Attorney General and her staff, to violate my civil rights, utilizing fraud to discriminate against me. I addressed my complaint to a federal agency last year and that agency has determined that their fraudulent conducts warranted the Department of the Attorney General to be charged with a civil rights violation. The charge is currently being investigated by that federal agency. What the Office of the Attorney General did to me was similar to what the Kealohas did to their uncle. In my situation, the Office of the Attorney General filed false reports against me and sent it to the Department of Public Safety for investigation (as of this date, after about eleven months of their requested investigation to PSD, I have not been contacted by any investigator to be interviewed, nor has the Human Resources Division informed me of the status of these false charges after I made inquiry with the administrator).

As part of her fraudulent conduct with others in the Office of the Attorney General, to include her Special Assistant Gary Yamashiroya, Attorney General Shikada failed to allow me proper due process under the civil service laws in the Hawaii Revised Statutes. In matters of fabricating false reports, she was instrumental in creating a hostile work environment to harass me, with the intent of having me resign, even when the documentary evidence of their false charges clearly exhibited that I was not conducting any administrative violations nor jeopardizing an investigation. This type of conduct is not within the character of an ethical and honest Attorney General, who should always assess facts before coming to conclusions.

STRONG OPPOSITION IN HOLLY SHIKADA BEING CONFIRMED AS THE ATTORNEY GENERAL, STATE OF HAWAII-GM596

Attorney General Shikada participated in initiating a fraudulent report of my arrest of a violent homeless individual that assaulted me on State property. Even after I convicted the suspect with the Honolulu Prosecutor's Office (who found no wrongdoing in my investigative report, nor my conduct during the arrest) Attorney General Shikada participated in accusing me of improper use of my pepper spray in my self-defense and the illegal use of blue lights mounted in an approved State of Hawaii vehicle in the parking lot of a State of Hawaii building.

Attorney General Shikada also participated in filing another false report stating that I jeopardized and compromised the safety of my Special Agents by submitting a billing for services to another State agency that disclosed the identity of my Special Agents. The documentary evidence clearly showed that I was not involved in the submittal of that billing and I committed no wrongdoing. Attorney General Shikada should have been aware of this had she done her due diligence to investigate this matter as an attorney.

This is not an isolated incident, whereby, their vile actions were made only against me. Ms. Shikada's conduct of participating in false allegations against employees is corroborated by a current lawsuit against the Department by a former Supervising Deputy Attorney General. In that case, Attorney General Shikada participated in establishing a hostile work environment and utilizing fraudulent conduct to force that Supervising Deputy Attorney General into constructively dismissing herself from the Department of the Attorney General. This lawsuit is public records, and the evidence of that civil suit identifies the fraudulent employment practices of the Office of the Attorney General against that Supervising Deputy Attorney General.

Attorney General Shikada attempts to weaponize the legislative process by retaliating against me in order to take away my law enforcement powers because she cannot do it legally with just cause. She schemed with others in her Office of the Attorney General to submit a bill to take away the civil service status of my position and that of the Administrator of the Hawaii Criminal Justice Data Center with no valid or logical justifications. It appears Ms. Shikada and her Office of the Attorney General want to sail into unchartered waters by executing employment actions contrary to what competent government managers would do. A responsible manager would never change civil service positions into exempt positions, which is an unlikely action done in Hawaii government with a union atmosphere.

Attorney General Shikada also planned to disassemble my Investigations Division by participating with the Department of Public Safety to send my Special Agents to the Department of Law Enforcement with no competent reorganizational plans, coordination, and logistics. These deficiencies of a failed reorganizational plan would render my team ineffective in serving this community as Special Agents that address complex financial crimes and government corruption.

Attorney General Shikada also schemed, without collaboration with me, to remove approximately half of my Special Agents and transfer them to her Criminal Justice Division; even though these special agents objected in being sent to that division. She did this in retaliation against me to reduce my supervisory capability. This lack of collaboration violated the spirit of her own office policy, which encourages all employees to work collaboratively. She never discussed these changes with me, her Chief Special Investigator. This behavior, by restricting her Chief Special Investigator from participation, is contrary to and violates the spirit of Hawaii Revised Statutes **§89-1 Statement of findings and policy**, where public employees have been granted the right to share in the decision-making process affecting wages and working conditions, when this is done, they have become more responsive and better able to exchange ideas and information on operations with their administrators.

STRONG OPPOSITION IN HOLLY SHIKADA BEING CONFIRMED AS THE ATTORNEY GENERAL, STATE OF HAWAII-GM596

Attorney General Shikada has made admissions to me that she has little knowledge of what law enforcement does in the State of Hawaii and she must rely upon her Special Assistant to the Attorney General as a resource. Her Special Assistant serves as her enhancement to vile and retaliatory actions against me and my Investigations Division with both resorting to skullduggery behaviors.

Recently, the public was made aware of corruption within our community. Confirming Ms. Shikada as the Attorney General, without scrutinizing her conduct and skills, will undermine the integrity of the Department and will severely jeopardize public safety and enhance further distrust in government.

Should there be any doubt as to what I have testified, I would invite this legislative body to conduct your own investigation with your subpoena powers.

1. While Acting Attorney General Holly T. Shikada has a great resume and oversees a staff of 650+ people, respectfully I ask the Senate to **not confirm this nomination**. As noted in this "Overview" piece from our Hawaii Attorney General website, the position is designated as the "chief law enforcement officer of the State of Hawaii". Surely that should also mean enforcing decisions handed down by the Hawaii Supreme Court, in my humble opinion.

[From the Attorney General website] OVERVIEW

Mission Statement: To provide excellent legal and public services in a timely manner.

Roles and Responsibilities. The Attorney General is the <u>chief legal officer and chief law enforcement officer of</u> <u>the State of Hawaii</u>. The Attorney General is appointed by the Governor. 180 attorneys and over 500 professional and support personnel assist the Attorney General in fulfilling the responsibilities of the office.

2. In the role of "Chief law enforcement officer of the State of Hawaii", that should include enforcement of Hawaii Supreme Court decisions affecting our Legislature. More specifically, on 4 November of 2021 the Court ruled the practice of 'Gut and Replace' schemes practiced by law makers at an end. While amendments still can be made to Bills, they must be "germane".

3. On <u>16 February 2022</u>, during a public Hearing on **SB2852** the Committee Chair gutted the Voting Rights Bill for taxpayers who own properties in Home Owners Associations. None of the sitting Committee Members dared to question her action, instead rubber stamping approval, without comment.

4. Due to public media accounts of the Hawaii Supreme Court decision, to include news stories and comments by some Legislators, I decided to ask our State Attorney General to enforce the 'Decision'. First I called the AG Office on Friday 25 February 2022, and after discussion with a staffer, decided to make it a formal email letter. Sent the email message out two days later on 27 February 2022. After not getting a timely reply, not even an acknowledgement, phoned that Office again on Wednesday 2 March 2022. A different staffer promised to check on the request. Never heard from her again.

5. I am embedding the 27 February 2022 email letter below. The statement about being the State Chief Law Enforcement Officer apparently does not include our State Supreme Court. And, there is no 'timely' response being made. So, this means Legislators are again free to 'Gut and Replace' any Bills they wish to. This really makes lobbyist happy.

6. The Senate had declined to confirm a previous appointment, that of Judge Dan Gluck. You should do the same with this one, in my opinion.

Aloha:

1. I am writing today regarding non-compliance with the Hawaii Supreme Court (HSC) decision (issued 4 November 2021) which prohibited 'Gut and Replace' schemes in our Legislature - Specifically by **Senator Rosalyn Hestor Baker** in her capacity as Chair of the Hawaii Senate Committee on Commerce and Consumer Protection (CPN). And, also, misuse of this same HSC decision by Representative Aaron Ling Johanson in his capacity as Chair of House Committee on Consumer Protection and Commerce (CPC). Particulars are as follows -

- 2a. Maui state Senator Rosalyn Hestor Baker, after taking testimony during a video • recorded Hearing of **SB2852.** which accorded the right for members of Home Owners Associations to cast their vote(s) by US Mail, over the Internet, or by other electronic means (meaning telephonic to a neutral 3rd party business that specializes in conducting elections), *amended* the Bill passing such a decision on to the Board of Directors of an HOA (of which there are now about 1,800 in Hawaii (a figure that fluctuates from year to year). With the amendment in place this preserves status quo ante wherein about **70%** of HOA members, being investors and not owner occupants of their properties, are **blocked** from casting their own vote. [Note - Back in 2005 the Legislature promulgated Hawaii Revised Statute 514b-123 which specified an Association member must be '*present in person*' at an election meeting in order to cast their own vote. This action screened out a majority of owners as they are investors. It also blocked frail elderly and disabled owner-occupants who are mobility challenged from exercising their 'right to vote' as they too cannot attend a meeting. Presently there are about **173,000** condominiums in Hawaii, with **70%** of owners being investors, this means over 121,000 owners are denied the right to vote (in an HOA election.]
- 2b. As the Hearing was recorded and posted on YouTube, it can be viewed at this link: <u>https://www.youtube.com/watch?v=P34t0BGSkZE</u>
- 2c. While viewing the above link, simply pull your cursor on that video screen to timestamp 45.28 (meaning 45 minutes and 28 second mark), to view when Senator Baker amended SB2852 thereby perpetrating a Gut and Replace maneuver which is then titled as <u>SB2852 SD1</u>. I offer my own comments, earlier, about the right to vote being suppressed at time mark 14.58, that over many many years people have died to win the right to vote.

2d. While the Committee supposedly passed as **SB2852 SD1**, pushing off onto HOA Board of Directors to decide the question, should they do so this would put them in

conflict with existing HRS514b-123. And, lawyers would advise them they cannot ignore 'state law'. Consider, the Legislature in 2005 truncated Voting Rights in HOAs, which was injurious to most members, and now Senator Baker ducks Legislative accountability by pointing a finger at HOA Boards to deal with Voting Rights. This clearly was a Gut & Replace maneuver, introducing a *non-germane* portion which Committee members were okay with. None of them objected.

2e. Senator Baker, out of public view, accepts donations from business lobby groups, and their Officers, then does their bidding by killing Bills they object to, in my opinion. She refused to schedule a Voting Rights related HOA specific Bill, *SB724* introduced by Senator Maile Shimabukuro, at my request, in *2019*, then again the Senator blocked the same issue in *2021* when it was introduced by Senator Lorraine Inouye of the the 'Big Island' (Hawaii). The 'Public Good' is not being accomplished when this happens. A useful Internet link to have a look at in this particular situation is:

 One of her donors is President of Hawaii Council of Community Organizations (HCCA), which in fact is a business lobby group. Routinely both HCCA and CAI (Community Associations Institute), another business group with a misleading name, oppose any measures relating to voting rights, like, *HB347* & *SB724* in 2019.

2f. Senator Baker in her 'report' regarding *SB2852 SD1* conjures up imaginary problems that would manifest if HOAs were required to allow members to vote, Ignoring that her decision for Boards of Directors, many of which are in fact 'puppet Boards' due to willful election maladministration by management companies, cannot approve a policy at variance with existing state condo law. Senate President Ronald Kouchi could show leadership and intervene, as a matter of decorum, but will never do so.

3a. Regarding *Representative Aaron Ling Johanson*, Chair of the Hawaii House Committee on Consumer Protection and Commerce (CPC). He convened a Hearing on Thursday February 3, 2022, for *HB1583* (which was the companion to *SB2852*), giving to HOA members who cannot attend an election meeting in person, to exercise their vote(s) via US Mail, the Internet, or other electronic means. • 3b. While reading submitted testimony is interesting, and, watching the video, it was the manner in which Representative Johanson ducked having his Committee members decide whether or not HOA owners, taxpayers, can exercise voting rights, by citing the Supreme Court decision regarding 'Gut and Replace. Watch and listen as he makes, at time mark **1:50:28** (for 1 hour, 50 minutes, and 28 seconds), a rambling excuse for deferring his Committee from voting on HOA members rights in elections, curiously, blaming the Supreme Court prohibition on 'Gut & Replace'. Odd that Johanson has now 'weaponized' that Hawaii Supreme Court decision.

4. We have an intractable corruption problem in our Legislature, as evidenced by several cases reported in news media recently. This one of predatory business practiced aimed at HOAs via manipulation of elections, which they administer, has been going on for decades. Respectfully I suggest the state Attorney General address this matter with the Governor, Legislative 'Leadership', the Legislators involved, and enforce the Supreme Court decision. A public announcement to that effect would go towards restoring some modicum of public confidence in our 'Law Makers'

IV. CONCLUSION

For the foregoing reasons, we vacate the circuit court's orders and judgment granting the State's motion for summary judgment. Because we conclude that article III, section 15 of the Hawai'i Constitution requires that a bill receive three readings after the Legislature introduces a non- germane amendment and because the hurricane shelter provisions of Act 84 violated section 15, we vacate the summary judgment granted to the State and remand this case to the circuit court with instructions to grant Plaintiffs' motion for summary judgment.

I am extremely honored and would like to express my appreciation to Governor David Ige for providing me with this opportunity to serve the State of Hawaii as the Attorney General.

As background on my education, I am a proud graduate of Hawaii's public school system – I graduated from Kaiser High School and attended the University of Hawai'i at Manoa. I earned a Bachelors Degree in Accounting and was enrolled in the Masters of Accounting program when I was accepted to the William S. Richardson School of Law.

After graduating from law school, I was fortunate enough to start my legal career at the esteemed law firm of Fujiyama, Duffy & Fujiyama. I worked at the firm for 4 years before deciding that I wanted to use my law degree for public service work. This began my 30+ year career at the Department of the Attorney General.

In 1989, I was hired as a Deputy Attorney General in the Family Law Division where I handled Child Abuse and Neglect cases. These were some of the most difficult cases, not necessarily because of their complexity, but mainly because of the difficulty in reading the reports and learning about the abuse our keiki were suffering. These cases were emotionally difficult, but I felt it was extremely important to do what I could to help these children who were being abused. I worked with some of the most dedicated public servants, the Department of Human Services social workers. It was essential that we work as a team to assist the families in creating a safe family home for these children or have the children adopted by a family who could provide them with a safe, stable, loving home. While in the Family Law Division, I also handled a variety of other types of cases within the Family Court system, including Juvenile Offender cases, Guardianship cases, and Adoption cases. I appeared in Court on a daily basis, handled over a hundred trials, and had the pleasure of handling over a hundred adoption cases. The adoption cases were the only cases where we would be able to see the children and experience the excitement and

happiness of the children and the families adopting them. For years, the adoption calendar was extremely backlogged and I had the good fortune of being able to work on a special project with then Senior Family Court Judge Michael Town to remodel the adoption system and clear the backlog. We were able to work together to develop a more streamlined approach for adoption petitions and cleared the backlog within a few years.

I worked in our Family Law Division for 10 years and in 1999, I was asked by then Attorney General Earl Anzai and First Deputy Attorney General Rick Keller to head the Felix Unit, which was created as a result of the Felix Consent Decree litigation case. The State's mission in that case was to ensure the delivery of special education and related services to special needs students in Hawaii's public schools. This resulted in my transferring from the Family Law Division to the Education Division. The deputies who worked on the Felix case before me were instrumental in working with the Department of Education and Department of Health to set up a system in which the two departments could work in concert to address the special education and mental health services for our special needs students. In 2005, as a result of the hard work of the Department of Education and the Department of Health, the State was found to be in substantial compliance with the Consent Decree and the case was dismissed. It was a team effort and I was proud to be a part of that team.

In 2003, then Attorney General Mark Bennett appointed me as the Supervisor of the Education Division. It was an extremely rewarding job and I enjoyed working closely with the Department of Education and all of our other Education Division clients, which included the Board of Education, the Public Charter School Commission, the Public Charter Schools, the Hawaii State Public Library System, the Hawaii Teacher Standards Board, the Executive Office on Early Learning, and the Early Learning Board. I served as the Education Division supervisor for a total of 18 years; it was very rewarding work as public education and providing opportunities for our keiki is extremely important to me. My 2 children went through Hawaii's public education system and are productive working members of our community. I thoroughly enjoyed working with the Education Division clients, assisting them in making a difference for our children.

In April 2021, I was asked by Attorney General Clare Connors if I would serve in the position of First Deputy Attorney General as then First Deputy Dana Viola was selected to be the Corporation Counsel for the City and County of Honolulu. While I loved my job as supervisor of the Education Division, the position of First Deputy Attorney General would give me the opportunity to serve the State in a greater capacity. It would also provide me with the opportunity to continue learning and expanding my knowledge.

While I didn't officially start in the position as First Deputy Attorney General until April 2021, I was provided the opportunity to transition for approximately 1 month; the entire month of March was used to transition from being the Education Division supervisor to the First Deputy Attorney General position. Thank you to Dana Viola for mentoring me during that month. From April until December, I had the benefit of working as the First Deputy Attorney General under Clare Connors. With the guidance and mentoring from Clare for those 9 months, along with 30+ years in the department, I am ready to take on the challenge of being the Attorney General.

While I was the Education Division supervisor, I was extremely fortunate to have worked with other division supervisors and a large number of other deputy attorneys general. Since becoming the First Deputy Attorney General and now in this interim period as the Attorney General, I am privileged to work more closely with a wider range of our supervisors and deputies. I don't think words can do justice in

describing the amazing talent and work of the department's supervisors and deputies. Their dedication to their job, their knowledge of their respective subject matter areas, and their desire to "get it right" in providing the best legal advice to our clients is most impressive.

Having the opportunity to lead these individuals would be an incredible opportunity and no doubt the highlight of my career.

If allowed to lead this department, among my priorities are to work with the experts to continue to safely navigate our State through this COVID pandemic; work on the mental health issues plaguing our houseless population and communities; be more involved in addressing fraud and environmental crimes; and continuing to develop and provide employee training and the recruitment of quality attorneys.

Our department has an excellent working relationship with the Department of Health and HIEMA and we work with them on a daily basis to address the challenges created by this pandemic. The curveballs thrown at us by this pandemic have been numerous and multifaceted. The Deputies in our Department have been able to manage the issues and litigation and have, to date, prevailed on every case relating to the pandemic and the Governor's emergency proclamations.

I also know that much has been done with respect to identifying and working on the mental health issues plaguing our houseless population and communities. Although there are no easy solutions to these issues, we have a team of deputies working with various groups attempting to assist on addressing the myriad of issues. This is an area that I would like our department to prioritize and continue working closely with the experts on.

Fraud and environmental crimes are other areas where violations seem to be on the rise. Fraud, particularly as it impacts some of our most vulnerable residents, the elderly and disadvantaged, is an area I'd like to focus on. We will continue to address and prosecute individual fraud cases; however, I would also like our department to get aggressive in going after cases where there are individuals, groups of individuals, or enterprises engaging in fraudulent schemes that are hurting our residents.

Illegal dumping, including hazardous waste materials, oil and petroleum spills, and water pollution are activities significantly impacting our environment. I would like to see our department become more active in investigating these types of violations and bringing criminal charges when appropriate.

We already have an established privacy law group that works on privacy issues, including how and when confidential information can be shared and with whom. Privacy issues are becoming more complex and cybercrimes are becoming more prevalent. This is another area I would like our department to focus on.

In order to appropriately address all of these difficult and involved issues, it is extremely important for our department to be able to continue recruiting and hiring the best and brightest attorneys. We are currently working on a recruitment plan and have started a Summer Internship Program with the goal of spurring the interest of legal interns to consider public service law as a career choice. It is my hope that the legal interns will find public service and government law as interesting and rewarding as I have, and choose to make this their career.

Re: Nomination to the Position of Attorney General

Dear Senator Rhoads:

This written statement responds to your letter dated February 9, 2022. My answers to the questions posed to me, for publication on the Legislature's website, are as follows.

1. Please briefly describe your understanding of the role and responsibilities of the Department.

I see the role and responsibility of the Department of the Attorney General as providing responsive and timely legal advice and representation to our client, the State of Hawai'i, which includes our executive, legislative, and judicial branch clients. We must be able to identify and assess legal issues honestly and comprehensively so that our clients can properly evaluate risk and make informed decisions. And, we must be true to the law; our interpretation of the law should not change based on who is asking the question. We should, however, advocate for our clients to assist them in achieving their goals and objectives within the confines of the law and the constitution.

Our Department also has the responsibility to protect the people of the State of Hawai'i. We do not represent individuals, but we represent the interest of the people as a whole. We protect our citizens through the filings of various actions, such as consumer protection actions, qui tam actions, and the filing of criminal charges against individuals who have committed crimes. Other litigation taken up on behalf of the State also include complex high-stakes issues of deep concern to the people of Hawaii, such as the appeal of the Red Hill Emergency Order, the Opioids lawsuits and bankruptcies, and the Bristol Meyers Squibb Plavix unfair and deceptive trade practice litigation.

2. Based on your experience and observations, please provide a brief assessment of the Department's strengths and weaknesses. Please include an explanation of how the Department's strengths might be more effectively utilized going forward, as well as how the Department's weaknesses might be improved. Please describe what you think the Department's top budgetary priorities should be going forward.

The Department's greatest strength, no doubt, is our employees. Our Deputy Attorneys General (Deputies) choose to be here because of their desire to work in public service; they are committed, dedicated, experienced, and intelligent and we seek out such individuals because we want attorneys who see the people of Hawai'i as their priority. We have formed a number of committees and task forces within our department to address specific issues and areas of law. These committees and task forces are staffed with Deputies from our various divisions, each with specialized knowledge and skills in the areas they work in, as well as general knowledge relating to various aspects of the law. I'd like to increase the number of committees and task forces we have and expand the membership to the newer, less experienced Deputies in order to expand their knowledge base and interactions with the senior Deputies. Our people are our greatest asset, and we need to provide them with the opportunities to learn and grow. By having more committees and task forces, newer, less experienced Deputies will have the opportunity to participate with other Deputies who can provide mentorship and the transfer of institutional knowledge about the issues our Department addresses.

The weakness I see in the Department is the number of Deputies who are eligible to retire if they so chose. Succession planning and preparing the next generation of Deputies to take on leadership roles and responsibilities is extremely important. The historical and institutional knowledge of our Deputies, many who have been practicing for decades and specifically within the Department, is nothing short of astounding. We, as a Department, need to ensure we are sharing and transferring the information and knowledge that our seasoned Deputies have to our newer, less experienced Deputies.

The Department's top budgetary priorities should be ensuring we have funding to keep our Deputies salaries competitive with other government legal entities in order to retain our seasoned Deputies and attract new ones. The reality is our employees still need to support themselves and their families, so we need to pay them a wage that will allow them to do that. We ask a lot of our Deputies, with many working in excess of the normal 40-hour workweek and on weekends, evenings and holidays with no additional compensation. With a deep sense of professional responsibility, our Deputies continue to deliver, but other government attorney positions better compensate their employees. Therefore, the overwhelming majority of our budget request is for positions that are needed to fulfill our obligations and responsibilities of providing responsive and timely legal advice to our clients, and for funds to ensure pay parity with other similar positions in Hawaii.

Second, funding for litigation cases is essential for our department to appropriately defend or file affirmative actions on behalf of the State. In most instances, litigating cases requires the hiring of experts. Experts can be quite costly, but are essential to successful case outcomes. Obtaining the necessary funding to allow the Department to vigorously represent the State is crucial. The success of certain cases is totally dependent on the credibility and expertise of the experts we are able to retain.

3. Please describe why you believe that you are qualified to serve as the Attorney General of the State. Please discuss any personal skills, expertise, knowledge, and experience that you think will aid you in the position. In particular, given that the Department is a government agency with over 700 employees and a budget of over \$100 million, please describe the management experience and skills you believe you possess that will allow you to carry out your responsibilities effectively.

Having worked in the Department for over 30 years and practicing law for over 35 years, I believe I have the legal expertise and knowledge, as well as the experience working in State government to run the Department effectively and efficiently. I started my career in private practice at the law firm of Fujiyama, Duffy & Fujiyama. Working directly under Wally Fujiyama was demanding, but a learning experience that has shaped my work ethics and my commitment to do the best job possible for my client. While at the law firm, I was given the opportunity to work on a variety of matters, including drafting contracts, drafting wills, and being a part of multiple litigation teams working on discovery, motions, and trials.

Despite the wide range of fascinating work I was involved with in private practice, after 4 years, I decided that I was really interested in public service work. I joined the Department as a young Deputy Attorney General working in the Family Law Division, appearing in court daily and handling over a hundred trials. Based on my commitment to the work and my efforts to learn as much as I could about the Family Court system, I was given the opportunity to work with the Senior Family Court Judge of the First Circuit to remodel the Family Court's adoption system. Working together with the Family Court, we were able to clear years of backlogged adoption cases and remodel the system to greatly expedite the processing of paperwork and scheduling of adoption hearings.

I had been working in the Family Law Division for 10 years when then Attorney General Earl Anzai and First Deputy Attorney General Rick Keller asked me to head their newly created Felix Unit. The purpose of forming the unit was to assign a Deputy Attorney General whose primary focus was to work with the Departments of Education (DOE) and Health, and the Federal Court in achieving substantial compliance with the consent decree. The requirement in that case was to ensure the delivery of special education and mental health services to special needs students in Hawaii's public schools. This new assignment resulted in my transfer to the Education Division in 1999. The State achieved substantial compliance in 2005 and the Felix Consent Decree and Federal Court

> jurisdiction were terminated that same year. In 2003, then Attorney General Mark Bennett asked me to be the supervisor of the Education Division. From 2003 until becoming the First Deputy Attorney General in April 2021, I supervised the Education Division, managing about 20 individuals and working with hundreds of clients. The Education Division provides legal advice and representation to the DOE and the Charter School system, including each school under both jurisdictions. The Education Division also provides legal advice and representation to the Board of Education, the Hawai'i State Public Library System, the Hawai'i Teacher Standards Board, the Executive Office on Early Learning, and the Early Learning Board.

> In April of 2021, Attorney General Clare Connors asked me to fill the position of First Deputy Attorney General as then First Deputy Attorney General Dana Viola was leaving to become Corporation Counsel for the City and County of Honolulu. I was fortunate enough to work with Dana for one month before she left, and with Clare for nine months before she moved on to become United States Attorney for the District of Hawai'i. While my time with Dana and Clare was short, the knowledge and experience I gained is invaluable. Working with Clare for those nine months provided me with the insights, knowledge, and familiarity with the role and responsibilities of the Attorney General.

> With respect to my management style, it is to work directly with Deputy Attorneys General and the client on issues of significant import. I have an open-door policy and am reachable 24/7, including those infrequent times when I am out of the office. I readily recognize that I don't have command of every area of the law and greatly rely on the talented Deputy Attorneys General who have the knowledge and expertise to assist on any given issue and do not hesitate to involve those individuals as needed. I enjoy and think it is essential to have round table discussions on complex issues to ensure the Deputy Attorneys General with such knowledge and expertise can contribute to the discussion so we can provide the best advice or employ the best strategy on any particular issue or case. Ensuring these meetings are run effectively and efficiently is extremely important so we do not unnecessarily impede on the Deputy Attorneys General time to work on other pressing cases. I allow the free flow and exchange of ideas and do not shy away from making decisions once I have the necessary information. Over the years, I have learned to hone my leadership skills such that I believe my leadership style is participative and for the newer, less experienced Deputy Attorneys General, more of a coaching style. I am a firm believer in people being responsible to do their own work and taking responsibility for the work that they do. I have no issues with sitting with a particular Deputy Attorney General to work side-by-side with them on a particular issue or project and guiding them, as well as sharing in the work and responsibility to get the job done.

> With respect to the budget, I have only begun to be more involved with budget issues since I became the First Deputy Attorney General. However, budget and accounting issues are not new to me as my undergraduate degree from the University of Hawai'i is a Bachelors Degree in Accounting. I have the ability and knowledge to understand budget

issues and have others within the Department who have specialized expertise on State budget issues that I have and will continue to rely on.

4. Are there any circumstances, events, or areas in your professional or personal past that you think might give rise to actual or perceived conflicts of interest if you were to become Attorney General? Please describe how you will review and handle situations involving possible personal conflicts of interest or involving possible conflicts of interest of the Department with respect to other state departments or agencies or as between the legislative and executive branches.

I have worked for the Department for the past 30 years and the private law firm I had previously worked for was dissolved. I cannot think of any circumstances, events, or areas in my professional or personal lives that could give rise to an actual or perceived conflict of interest if I were confirmed as the Attorney General. If something unforeseen should arise that could even be perceived as a potential conflict, I would immediately recuse myself and completely wall myself off from the matter. The Department is the State's attorney, and should potential conflicts arise between the Department and any of our clients, the Department has the ability to hire private counsel to represent a particular State entity that the Department has a conflict with. With respect to potential conflicts between State entities, including between the various branches of government, we have in the past and we will continue to do so in the future, assign different divisions to represent and advise the different State entities. Within the Office of the Attorney General, the Attorney General and the First Deputy Attorney General will ensure that a conflict wall is erected, and each will supervise one division or the other. Additionally, our Department has an Ethics and Conflicts Committee that will review any potential conflict issue or situation and make recommendations on whether separate Deputies must be assigned to represent and advise each client.

The ability to concurrently represent multiple State agencies or multiple parties that have conflicting interests is something that private attorneys are not able to do under the Hawai'i Rules of Professional Conduct (the rules governing lawyers); however, in the *Klattenhoff* case (*State v. Klattenhoff*, 71 Haw. 598 (1990)) the Hawai'i Supreme Court ruled that the Department of the Attorney General may assign deputies to represent agencies or employees that have competing interests as long as it establishes appropriate safeguards, such as firewalls between those attorneys and takes steps to ensure that no prejudice is suffered by the clients. As stated, we will continue to erect our firewalls when these conflicts occur to ensure we are able to provide vigorous and appropriate representation to all of our clients.

5. Please describe what important substantive differences you see, if any, between the United States Constitution and the Constitution of the State of Hawai'i of 1978 (in each case, as amended). Which of those differences are particularly important to you, and how do you see the role of the Department in protecting and enforcing any provisions of the State constitution that afford Hawai'i's citizens different or greater rights or freedoms?

Generally, the Constitution of the State of Hawai'i (Hawai'i Constitution) is more protective than the United States Constitution (US Constitution). Our Hawai'i Constitution must, at a minimum, afford our citizens the same rights given them in the US Constitution; however, the Hawai'i Constitution is much more detailed in describing those rights.

The most significant differences between the US Constitution and our Hawai'i Constitution relate to areas such as: the explicit right to privacy, which goes beyond the US Constitution's personal privacy; the Equal Rights Amendment, where the Hawai'i Supreme Court has shown a sensitivity to racial discrimination; the requirements for search and seizure, where our citizens have broad protections against unreasonable seizures of private property, subject to the exigent circumstances rule; the right to a healthful environment, as specified in article IX, section 8 of the Hawai'i Constitution; and the protections for people of Hawaiian ancestry, as set forth in article XII. Hawai'i is unique from every other State and each and every difference between the US Constitution and our Hawai'i Constitution is important to me as an individual and as an attorney because they identify the priorities and values of the people of Hawai'i.

The attorney general as the chief legal officer and chief law enforcement officer of the State, and the Department, are responsible for protecting and upholding the Hawai'i Constitution and the US Constitution. Whether the Hawai'i Constitution affords our citizens different or greater rights or freedoms, the people of Hawai'i have identified the priorities and values important to them through the adoption of the various constitutional provisions, and it is the duty and responsibility of the attorney general and the Department to defend and uphold the constitution on behalf of the people.

6. Is there any other information regarding your experience and background that you believe should be considered for your nomination? Is there any information regarding your experience and background that, if disclosed, you think might cause embarrassment to the Governor, the Department, or the Legislature?

I came to this Department 30 years ago and never regretted choosing public service, specifically in this Department. I am very loyal to this Department and the work we do. If given the opportunity to be the Attorney General, I will use the knowledge and experience I have gained in my 35 years of practice, particularly the knowledge and experience working in this Department for the past 30 years, to continue providing the best legal advice and representation to all of our Department's clients. The supervisors in

our Department once developed principles and a vision for our Department. Our principles are to: (1) think deeply, (2) work hard, and (3) care always. Our vision is "To be the embodiment of responsive, trustworthy government." I can say, without reservation, that I strongly believe in our principles and vision which guide me every day.

I am not aware of any experience or anything in my background that if disclosed, might cause embarrassment to the Governor, the Department, or the Legislature.
