Testimony of the Environmental Advisory Council on GM 598 and GM 599 Before the Senate Committee on Agriculture and Environment Conference Room 224 & Videoconference April 8, 2022 at 1:00 pm

Aloha Chair Gabbard, Vice Chair Nishihara, and Members of the Senate Committee on Agriculture and Environment:

The State of Hawai'i Environmental Advisory Council (EAC) is in strong **SUPPORT** OF GM 598<sup>1</sup> and GM 599 appointing Ms. Michele Lefebvre to the EAC for a term to expire on June 30, 2026.

The EAC is established by HRS § 341-5.5, which also directs membership "to ensure a broad and balanced representation of educational, business, and environmentally pertinent disciplines and professions, such as the natural and social sciences, the humanities, architecture, engineering, environmental consulting, public health, and planning; educational and research institutions with environmental competence; agriculture, real estate, visitor industry, construction, and media; and voluntary community and environmental groups."

The functions of the EAC are to serve as a liaison between the Office of Planning and Sustainable Development (OPSD) Director and the general public, to make recommendations concerning ecology and environmental quality, and to monitor the progress of the State, county, and federal agencies in achieving the State's environmental goals and policies. The EAC also worked on and promulgated the administrative rules for implementing Chapter 343, HRS and now serves an advisory capacity in that respect.

Ms. Lefebvre's experience in permitting, compliance, and preparing both HRS Chapter 343 documents as well as NEPA documents will contribute to the EAC's roles and discussion. With respect to the EAC's functions, duties, and powers, and in consideration of Ms. Lefebvre's experience as demonstrated on her resume, including her community involvement, the EAC strongly supports her nomination. The EAC respectfully requests that this Committee vote in favor of her confirmation to serve on the EAC.
