Aloha Chair Gabbard, Vice Chair Nishihara, and Members of the Senate Committee on Agriculture and Environment:

The State of Hawai'i Environmental Advisory Council (EAC) is in strong **SUPPORT** OF GM 602¹ and GM 603 appointing Ms. Rachel Sprague to the EAC for a term to expire on June 30, 2026.

The EAC is established by HRS § 341-5.5, which also directs membership "to ensure a broad and balanced representation of educational, business, and environmentally pertinent disciplines and professions, such as the natural and social sciences, the humanities, architecture, engineering, environmental consulting, public health, and planning; educational and research institutions with environmental competence; agriculture, real estate, visitor industry, construction, and media; and voluntary community and environmental groups."

The functions of the EAC are to serve as a liaison between the Office of Planning and Sustainable Development (OPSD) Director and the general public, to make recommendations concerning ecology and environmental quality, and to monitor the progress of the State, county, and federal agencies in achieving the State's environmental goals and policies. The EAC also worked on and promulgated the administrative rules for implementing Chapter 343, HRS and now serves an advisory capacity in that respect.

As a resident of Lana'i, Ms. Sprague provides important perspective from and representation for the neighbor islands on this statewide board. Ms. Sprague's extensive experience working with federal and state agencies, as well as in the private and non-profit arenas, is valuable to the EAC's work and will contribute to the EAC's discussions and roles. With respect to the EAC's functions, duties, and powers, and in consideration of Ms. Sprague's experience as demonstrated on her resume, the EAC strongly supports her nomination. The EAC respectfully requests that this Committee vote in favor of her confirmation to serve on the EAC.

On behalf of our 20,000 members and supporters, the Sierra Club of Hawai'i offers the following testimony in **STRONG SUPPORT** of the nomination of Rachel Sprague to the Environmental Advisory Council ("EAC").

The EAC plays a critical role in guiding and facilitating the meaningful implementation of our environmental laws and policies. Accordingly, it is critical that the council possesses members who understand the critical importance of our native Hawaiian species and ecosystems, which not only define our islands' ecological and cultural identity, but that also may be critical to our socioeconomic stability and environmental resiliency in the era of climate destabilization. In addition, council members should also demonstrate the community connections and insight necessary to facilitate a broader public understanding of, and engagement in, the development and implementation of our environmental laws, policies, and processes.

Dr. Sprague's lifetime of education, experience, and expertise in the protection and preservation endangered native wildlife and plants, both in Hawai'i and abroad, will greatly serve the EAC in the execution of its roles. Her clear dedication and breadth of experience will no doubt enable the EAC to make carefully considered decisions and provide nuanced advice and recommendations to government agencies and policymakers regarding the protection of our native species and their habitats. In addition, Dr. Sprague's long record of community service also demonstrates a commitment to and understanding of the need for community engagement as an integral part of environmental policy and decision making – another key function of the EAC.

Accordingly, the Sierra Club respectfully urges the Committee to recommend that the Senate **ADVISE AND CONSENT** to the nomination of Rachel Sprague to the EAC.
