Chair Rhoads and Members of the Committee:

The Attorney General supports the reappointment of Elizabeth Kent to the Commission to Promote Uniform Legislation (CPUL) of the Department of the Attorney General.

The CPUL is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of this state commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws, which is also referred to as the "Uniform Law Commission." The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Commissioner Kent is a lawyer licensed to practice law in Hawaii. She has served as the Deputy Director of Human Services in the Executive Branch and is the retired Director of the Center for Alternative Dispute Resolution in the Judiciary. Commissioner Kent is committed to promoting uniform legislation and has attended and actively participated in the meetings of the CPUL and of the National Conference since her initial appointment in 1998. Since her last appointment in 2019, Commissioner Kent has attended the annual meetings of the National Conference held in Anchorage, Alaska, from July 12-18, 2019, held online from July 10-15, 2020, via interactive Testimony of the Department of the Attorney General Thirty-First Legislature, 2022 Page 2 of 2

conference technology, and held in Madison, Wisconsin, from July 9-15, 2021, as a hybrid meeting with attendance also allowed via interactive conference technology.

In 2019-2020. Commissioner Kent served on the Enactment Committee on the Model Veterans Treatment Court Act, the Committee to Monitor Civil Litigation and Dispute Resolution, and the Family Court Emergency Procedures Study Committee. She chaired a subcommittee to Monitor Civil Litigation and Dispute Resolution that focused on online dispute resolution. She spent about forty hours in research time, telephone calls, and numerous meetings for the subcommittee. In 2020-2021, Commissioner Kent continued to serve on the Committee to Monitor Developments in Civil Litigation and Dispute Resolution and to chair a subcommittee to Monitor Civil Litigation and Dispute Resolution that focused on online dispute resolution. She also continued to spend time on research, telephone calls, and numerous meetings for the subcommittee and additional time on committee work. For 2021-2022, Commissioner Kent will continue to serve on the Committee to Monitor Civil Litigation and Dispute Resolution and chair the subcommittee. She was also appointed to the U.N. Convention on International Settlement Agreements Resulting from Mediation Committee. In addition to the time spent on the National Conference's committees, Commissioner Kent also spent approximately ten hours on work related to the Uniform Law Foundation of the National Conference and devoted time to research and work related to possible introduction of different acts for the Regular Session of 2022. Commissioner Kent currently serves as the Vice Chair of the CPUL.

In view of her demonstrated commitment to the promotion of uniform legislation and her continuing participation in the activities of the National Conference of Commissioners on Uniform State Laws and of the CPUL, Elizabeth Kent's continued service as a member of the CPUL and of the National Conference will be beneficial to the State of Hawaii and the National Conference. Consequently, the Attorney General respectfully requests that this Committee recommend the confirmation of the reappointment of Elizabeth Kent to the CPUL.

Thank you for your letter of March 4, 2022. I am honored to be nominated to serve another term as one of Hawaii's Uniform Law Commissioners. My responses to your questions follow.

 Why do you wish to serve as a member of the Committee? Please note if you initially applied to be nominated to the Committee or if you were invited to apply. Participating as a commissioner gives me an opportunity to contribute to the community. Good, well thought out laws bring clarity and stability to our statutory laws.

Initially I was invited to apply to be a commissioner. This year I applied because I knew my term was ending.

2. What are some of your accomplishments as a member of the Commission and what would you like to accomplish during an additional term?

Passage of the Uniform Revised Anatomical Gifts Act was very important to me - it may have saved lives and brought quality of life to recipients of the gifts. Passage of the Uniform Mediation Act, the Uniform Collaborative Law Act, and the Uniform Family Law Arbitration Acts were meaningful because my profession is in Alternative Dispute Resolution and each of these acts helps the field.

This session I hope the Uniform Recognition and Enforcement of Canadian Protective Orders Act, the Uniform Parentage Act, and the Public Expression Protection Act will pass both houses and be sent to the Governor for signing. I also want to continue working on diversity issues in the Uniform Law Commission.

3. What issues do you believe that the Commission has handled well in the past? What issues do you believe that the Commission should address in the future? Hawaii's commissioners work well together. We have good coverage and share the work. We have different backgrounds and strengths. We play an active role in the national commission.

I would like to see more acts outside of the commercial area and acts that reflect new trends in the law and society. It is important that the Uniform Law Commission encourage diversity of thought to stay as vibrant as possible. We also need to encourage legislators and others to forward good ideas to us for future drafting.

4. During your service on the Commission, were there possible conflicts of interests involving you that arose? How were those potential conflicts addressed? If you were to continue to serve, can you foresee any other possible conflicts involving you? I don't think there were any conflicts of interest in my past service and do not anticipate conflicts of interest with future service as a commissioner.
