<u>Agency's Position</u>: The Office of Language Access (OLA) <u>supports</u> the nomination of **BARBARA TOM** to the Language Access Advisory Council (LAAC) to fill the seat of "one representative from a covered entity," pursuant to Hawaii Revised Statutes Chapter 321C-7(a)(2) for a term to expire June 30, 2024.

<u>**Purpose and Justification**</u>: Consideration in support of confirmation of the LAAC Gubernatorial Nominee, Ms. Barbara Tom.

The purpose of OLA is to address the language access needs of limited English proficient persons (LEP) and ensure their meaningful access to services, programs, and activities offered by the executive, legislative, and judicial branches of state government, including departments, offices, commissions, boards, or other state-funded agencies. OLA provides oversight, central coordination, and technical assistance to state agencies in their implementation of language access obligations – a civil right under both state and federal law.

The LAAC assists the Executive Director of OLA by providing input on implementation and compliance with Hawaii's language access laws and on the quality of oral and written language services provided under the law. The LAAC also offers feedback on state agency or covered entity training of employees who are likely to have contact with LEP persons; policies and

procedures for language services; competency in working effectively with interpreters and translators; and understanding of the dynamics of language services between clients, providers, and interpreters.

Ms. Tom is currently holding the position of Director of Waipahu Safe Haven, a project within the Waipahu Community Association. In this position, Ms. Tom is responsible for the operation of the Immigrant/Migrant Resource Center. The Immigrant/Migrant Resource Center is located in a densely populated area of Waipahu, and addresses the social determinants of health, education, and welfare, by providing language access services to help clientele address all areas of need. The Immigrant/Migrant Resource Center also works in partnership with multiple community organizations. In addition, Ms. Tom has more than 20 years of experience working as a public health nurse at the Hawaii Department of Health.

Ms. Tom's desire to serve on the LAAC demonstrates her passion and commitment to the issue of language access. As an advocate and a public health educator, we are confident that Ms. Tom will be a valuable member of the LAAC.

Therefore, OLA respectfully requests your favorable consideration in confirming the appointment of Ms. Barbara Tom to the LAAC.

Esteemed Chair, Vice Chair and Committee Members:

I am Dina Yoshimi, a private citizen who serves as the Director of the Hawai'i Language Roadmap in the College of Arts, Languages & Letters at UH-Mānoa. I am writing in strong support of GM 673 which provides for consideration and confirmation to the Language Access Advisory Council of Barbara Tom, Gubernatorial Nominee. Barbara epitomizes the responsible citizen who sees a need in her community and acts on it vigorously, faithfully, and lovingly.

Nearly 10 years ago, as the newly appointed director of a multilingual initiative at UH-Manoa, I was a newcomer to the laws and processes of language access in the state, and was especially lacking in awareness of the severe language barriers facing the COFA migrant community in Hawai'i. To remedy this gap, I made my initial contact with a representative of the UH Richardson School of Law who had been working with this community for several years. Within the first 5 minutes of our conversation, Barbara's name was mentioned as "someone you have to meet". This was followed by accolades regarding her unfailing commitment to fighting for language access for this underserved community and her longstanding ties in and deep knowledge of the community.
