The Sierra Club appreciates the willingness of the nominated individuals to provide their time and expertise in service to the BLNR's important mission. The Sierra Club does emphasize the critical role of the BLNR in overseeing the management and protection of the lands and resources that provide the foundation of our islands' identity, social fabric, and ways of life. Accordingly, Sierra Club believes that this hearing provides a critical opportunity for the Committee, the nominees, and the general public to reflect on the nominees' knowledge, views, and commitment to make what may be difficult but necessary decisions to uphold their fiduciary and legal obligations under the constitution, statutes, and other laws of the state, with regards to our natural and cultural public trust resources and sites.

To assist in this process of reflection and assessment, the Sierra Club respectfully offers the following questions for the nominees before you today:

- 1) What expertise, knowledge, or skills do you possess that may be relevant to fulfilling the BLNR's fiduciary and legal obligations with respect to the conservation, protection, and use of our public lands and natural and cultural resources and sites?
- 2) Should stream diverters be allowed to dewater entire streams and waste millions of gallons of water per day, due to aging and leaky irrigation and reservoirinfrastructure?

- 3) Do you believe it is appropriate to issue long-term leases of ecologically or culturally significant lands and waters before DLNR staff can demonstrate sufficient expertise and capacity to provide consistent and timely oversight over lease terms and conditions?
- 4) What is your position on community-based fisheries management approaches, and should greater weight be given to the testimonies of Native Hawaiian traditional and customary practitioners and subsistence community members than outsiders who do not have a daily connection with the resources of their place?
- 5) What steps should the DLNR take to address the recommendations of the 2019 Audit of the Land Division's Special Land and Development Fund, which found a lack of an overarching plan for the Land Division's public land inventory, a lack of staff expertise and capacity to administer industrial and commercial leases, an overreliance on ground leases rather than more lucrative space leases in disposing of revenue-generating lands, and a lack of transparency and accountability, among other deficiencies, leading to significant opportunity costs to the DLNR and its mission?
- 6) Do you believe that the aquarium collection industry should be subject to stricter regulations based on evolving science regarding climate change impacts on our coral reef ecosystem, and the application of the precautionary principle?
- 7) What strategies should the BLNR employ to discourage shoreline hardening and encourage strategic retreat to mitigate the loss of our beaches and coastal areas?

The Sierra Club hopes and strongly believes that these questions will provide a much-needed understanding of the value that the nominees may bring to the BLNR, as it carries out its kuleana concerning matters of critical importance over the next several years.

Aloha, Senators,

I am writing to raise a significant concern about Governor Ige's recent choice of Riley Smith, nominee to the Board of Land and Natural Resources. Mr. Smith was a principal of a company during a period of time when the company was committing proven fraud. I am also concerned about Mr Smith's current focus as an owner of a company involved in commercial development of large land holdings. Mr Smith's representation on boards and councils is demonstrably on behalf of development interests. The responsibility for the protection of the natural resources of public trust lands must be entrusted to citizens of the highest integrity and a clear knowledge and understanding stewardship and fiduciary responsibility.

Riley Smith was Vice President of Construction of Waimana Enterprises, and Waimana Enterprises was parent company of Sandwich Isles Communications, whose President was Albert Hee. According to Federal prosecutors, Hee siphoned about \$4 million from his company Waimana Enterprises to cover "false" salaries to family members, college tuition for his children, family vacations, massages and dozens of other personal expenses. Hee directed accountants and company employees to classify many of the personal expenses as business deductions or part of a shareholder loan that was never intended to be repaid, according to prosecutors, over a 15 year period.

The U.S. Department of Agriculture holds a \$139 million court judgment against Sandwich Isles tied to delinquent loans, and a trustee appointed in U.S. Bankruptcy Court to oversee Paniolo has a \$257 million judgment against Sandwich Isles on behalf of Paniolo's creditors. In 2016, following a lengthy investigation in which the FCC concluded that Sandwich Isles improperly received millions in universal service high-cost support through repeated violations of FCC rules, the FCC sought comment on whether to terminate Sandwich Isles' status as an incumbent local exchange carrier, and thereby render Sandwich Isles ineligible to receive universal service support.

The FCC's Wireline Bureau denied Sandwich Isles' waiver request based on its ultimate conclusion that "Sandwich Isles has certain expenses that appear grossly excessive and unreasonable," and "[i]n particular, Sandwich Isles has spent millions of dollars with affiliated and related entities for services that appear unrelated to the provision of a broadband-capable network."[7] The following "unreasonable costs" were identified by the Bureau:

Corporate operations expenses that are 623 percent greater than the average for similar companies with the highest corporate operations expenses; Significant payments between 2009-2011 to Waimana Enterprises, Inc. (Waimana), Sandwich Isles' parent company, for providing services to Sandwich Isles.

Riley Smith was Vice President of Construction for Waimana Enterprises during this period supervising the undersea cable construction for five islands. Smith wrote a letter of support on behalf of Albert Hee to Judge Susan Mollway prior to the sentencing hearing, where Hee was sentenced in 2015 for tax fraud to 46 months in prison and the Waimana/Sandwich Isles company was ordered to pay a \$49.6 million fine. In his signed letter to Judge Mollway, Riley Smith stated that 99% of the employees of the company were classmates, friends and relatives of Mr Hee.

FCC Chairman Ajit Pai said in a statement that Hee engaged in a "long-running scheme" using money from a web of connected companies to pay for personal expenses for himself and family members over nearly 15 years.

Riley Smith is CEO of Lanihau Properties. Lanihau's primary strategy is to develop the lands, construct needed infrastructure, and create commercial/industrial lots to sell. Riley Smith also manages large acreages for cattle production. Lanihau Properties is a member of the Hawai'i Chapter of the National Association of Industrial and Office Properties (NAIOP) https://www.naiophawaii.org/. NAIOP "is the nation's leading trade association for developers, owners, investors, asset managers and other professionals in industrial office and mixed-use commercial real estate." Mr. Smith works with the Hawai'i Leeward Planning Conference (HLPC) which represents large landowners (including Lanihau Properties on the leeward side of the island of Hawai'i. He is associated with real estate development interests in West Hawai'i and is part of the "traditional" political power structure on this island.

Mr Smith sits on the advisory council for Na Ala Hele trails, and repeatedly represents the interests of developers, opposing the addition or protection of historic trails protected by the Highways Act of 1892. When he votes to oppose, he does not explain his opposition. In his conduct of board and commission meetings, attendees and testifiers have complained that those giving informative testimony are cut off summarily, and that the conduct of Mr Smith can be rude and disparaging. We can find no record of efforts to conserve or protect natural resources, rather Mr Smith generally represents development interests.

Riley Smith is the CEO of Lanihau Properties, which is a member of the Hawai'i Chapter of the National Association of Industrial and Office Properties

(NAIOP) https://www.naiophawaii.org/ . NAIOP "is the nation's leading trade association for developers, owners, investors, asset managers and other professionals in industrial office and mixed-use commercial real estate." Mr. Smith works with the Hawai'i Leeward Planning Conference (HLPC) which represents large landowners (including Lanihau Properties on the

leeward side of the island of Hawai'i. He is associated with real estate development interests in West Hawai'i and is part of the "traditional" political power structure on this island. Mr. Smith's most recent public action was to take a lead role in *opposition* to the Kaloko-Honokohau National Historic Park's effort to protect its water resources by having the Keauhou aquifer designated as a state water management area by the state Commission on Water Resource Management.

In summary, Riley Smith's extensive executive association with a company with a proven record of tax fraud and misrepresentation, his strong advocacy for development interests, and the absence of a land stewardship record lead me to believe that Mr Riley Smith would not represent the protection of the natural resources that could be entrusted to him.
