Aloha. I am Coleen Momohara, Interim Director of the Executive Office on Early Learning (EOEL). EOEL supports the nomination and confirmation of Mei Ou to the Early Learning Board (ELB).

EOEL is statutorily responsible for the development of the State's early childhood system that shall ensure a spectrum of high-quality development and learning opportunities for children throughout the state, from prenatal care until the time they enter kindergarten, with priority given to underserved or at-risk children.

Dear Honorable Members of the Hawai'i State Legislature,

On behalf of Family Hui Hawai`i, I would like to provide our strong support for GM689 appointing MeiQing Ou as the Parent Representative on the Early Learning Board (ELB). As a parenting support organization serving over 1000 parents, caregivers, and children, prenatal to age 5, each year, we see the struggles that families face every day and the difficulty they have in accessing supports and services. We believe that families are strong, that cultural diversity and family choice are strengths that families build on to raise their children.

As families are children's first and most enduring teachers, policymakers must consider and support the needs of children's families around health and early learning. In professional circles where we work with families every day, we may inadvertently overlook the voice of constituents whom we serve. We believe the parent representative of the Early Learning Board ensures that the voice of parents are heard in discussions and decisions that may affect them and their children. At Family Hui Hawai`i, we recognize that all families are unique and that a strong community is built when we respect our differences and learn from each other to support our children.
