In consideration of GOVERNOR'S MESSAGE 690 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE HAWAI'I HISTORIC PLACES REVIEW BOARD, GUBERNATORIAL NOMINEE, NICHOLAS BELLUZZO

The Department of Land and Natural Resources supports Governor's Message 690 nominating Nicholas Belluzzo for appointment to the Hawai'i Historic Places Review Board.

The Hawai'i Historic Places Review Board was established under Section 6E-5.5, Hawai'i Revised Statutes, to evaluate and determine if historic properties are to be entered into the Hawai'i Register of Historic Places and to recommend nominations of historic properties to the National Register of Historic Places. Nicholas R. Belluzzo, M.A., is nominated to serve as an Archaeology (Archaeology/History) subject matter expert on the Hawai'i Historic Places Review Board. If confirmed, Nicholas Belluzzo will serve until June 30, 2025.

Mr. Belluzzo has over fourteen years of archaeological field and research experience, including projects in Hawaii, Palau, Guam, the Commonwealth of the Northern Mariana Islands, Virginia, the western United States, and England. He has a master's degree from the University College London, and is a Ph.D. candidate in Anthropology at the College of William and Mary, focusing his research on landscape-scale approaches to the archaeology of Manukā, Ka'ū, Hawai'i. Mr. Belluzzo's work includes experience with state and federal historic preservation agencies and private cultural resource management firms, with specializations in Geographic Information Systems (GIS) data collection, design, maintenance, and the rectification of cultural resource GIS inventories. He also has experience in the Global Positioning System (GPS) mapping of surface architecture, photogrammetry, ground-based lidar, and drone-based data acquisition.

Mr. Belluzzo is associated with the Society for Hawaiian Archaeology and the Society for Historical Archaeology.

I serve as the chair of the Society for Hawaiian Archaeology's (SHA) Standards and Ethics Committee and Nicholas Belluzzo has served as one of my committee members for the past two years. Since the beginning of my tenure as chair, I have found Nick to be a dependable and reliable committee member. He is dedicated to improving archaeology and historic preservation in Hawai'i and is particularly concerned with the ethical obligation professionals in the field have to the public. For example, Nick recently suggested that our committee work on finding novel mitigation strategies for the protection of historic sites that we can share with others in the profession so that the preservation of historic sites and communication of associated information can be improved in Hawai'i. He is also consistently working on improving his own practice as well, finding ways to engage more community members in historic preservation so that the people most closely connected to these historic sites have their needs met.
