Chair Rhoads and Members of the Committee:

The Attorney General supports the appointment of Mr. Michael Tanoue to the Commission to Promote Uniform Legislation (CPUL) of the Department of the Attorney General.

The CPUL is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of this state commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws, which is also referred to as the "Uniform Law Commission." The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Thank you for your and the Senate Committee on Judiciary's consideration of my nomination by Governor David Y. Ige to the Commission to Promote Uniform Legislation (Commission). I would be honored to be given the opportunity to work with colleagues from Hawaii and members from across the country through the National Conference of Commissioners on Uniform State Laws (ULC).

The following are my responses to the questions posed in your March 28, 2022 letter.

1. I understand the Commission's role is to represent Hawaii in the work of the ULC and to participate in drafting, revising, evaluating, debating and enacting uniform laws in Hawaii.

2. I perceive the role and responsibilities of a Commission member are to work actively and collaboratively with Hawaii and national colleagues to approve and recommend uniform laws that are clear, understandable, and of value.

3. I was asked to consider applying to the Commission by outgoing member Kevin Sumida. I wish to serve as a member of the Commission because I firmly believe that well-crafted legislation benefits Hawaii.

4. My background that qualifies me to serve as a Commission member includes clerking at the Hawaii Supreme Court, serving on the Hawaii Supreme Court Committee on Pattern Civil Jury Instructions for over 20 years, practicing insurance law for over 30 years, and working with the Hawaii Insurers Council for over 10 years in reviewing, analyzing, drafting and revising proposed legislation. My volunteer work includes serving as a judge in high school speech and debate activities at national and state tournaments for nearly 40 years.

5. I am a first-time nominee. If confirmed, I intend to participate and contribute meaningfully to the Commission to promote uniform laws.

6. In my areas of practice, I believe the Revised Uniform Arbitration Act (HRS Chapter 658A), the Uniform Rules of Evidence Act (HRS Chapter 626), and the Uniform Mediation Act (HRS Chapter 658H) have been especially beneficial to litigants and their attorneys.

7. If confirmed, and as a new Commission member, I would listen and be open to all issues for future consideration. Recent events, however, have made me think about the possible benefits of uniform laws on the licensing and certification of providers of critical services across state lines, especially in times of emergency.

8. I do not foresee any future conflicts of interest. However, if a conflict arises, I would disclose that conflict and, if appropriate, either disqualify or recuse myself from participating in those topic areas.
