It is my pleasure to support the nomination of Stacy Haumea to the State Subarea Health Council for Hawai'i County. I have known Stacy personally and professionally for 3 years.

Stacy has a demonstrated her commitment to the community health and her leadership capacity through her service on the Big Island Nurtrition Council, Hale Ola Hawaiian Healing Institute, and volunteering to serve on many local boards. Stacy is a Registered Dietition and Certified Diabetes Educator and generously shares her 'ike of medicinal plants with community to promote awareness of native Hawaiian health and healing resources and practices.

As the Executive Director for Vibrant Hawai'i, I have worked with Stacy on several occasions, beginning in 2020 at the onset of the pandemic when Vibrant Hawai'i received a grant to provide food boxes to kupuna who were advised to stay at home. Stacy partnered with us and designed a healthy 1-week menu for kupuna using mainly shelf stable food items. We continue to utilize this resource to create and distribute healthy food boxes for keiki while they are out of school. I reached out again to Stacy in 2021 to present to our Health and Wellbeing Stream about nutrition and the health benefits of māmaki. As a result, attending community members supported an initiative to increase the community's integration of māmaki into their daily use, and Vibrant Hawai'i partnered with a local māmaki farmer to develop "Vibrant Hawai'i" labeled bags of māmaki for community distribution.

Stacy Haumea is a humble, grounded, hardworking and exemplary leader for Hawai'i County. Our community trusts her subject matter expertise and care in delivery of education and services. She is an advocate for native Hawaiians, rural communities, and equitable access to health and wellbeing resources.

I believe Stacy Haumea is an ideal candidate for the State Subarea Health Council for Hawai'i County and encourage your strong support of her nomination.

Honorable Chair Keohokalole, Vice-Chair Baker, and members of the committee, I wish to submit this testimony in strong support of the confirmation of Dr. Stacy Haumea to the Health Planning Council, Hawai'i County Subarea. In my role as Professor and Chair of Native Hawaiian Health at the John A. Burns School of Medicine, I have worked closely with Dr. Haumea for over 7 years on two National Institutes of Health (NIH) funded research projects aimed at improving the health and wellbeing of Native Hawaiians and Pacific Islanders.

Dr. Haumea is well qualified to serve on this council and represent the people of Hawai'i County. She is a very active health care provider on Hawai'i Island with a doctorate in behavioral health. She is also a certified diabetes educator and registered dietician. She is part of the medical team at Hui Mālama Ola Nā 'Ōiwi, the Native Hawaiian Health Care System on Hawai'i Island. In addition to having real-world clinical experience, she has been active as a community investigator on NIH-funded research projects aimed at developing and testing culturally-responsive community-based health promotion programs to address the disproportionately higher rates of heart disease among Native Hawaiians and Pacific Islanders.

I cannot think of anyone else more qualified and deserving to serve on this council than Dr. Haumea who gives so much of herself to her patients and community.

referred from Hilo Medical Center and from the community to improve their health. She is familiar with the political challenges that the community faces in advocating for the resources for improving the health of our community.

Preventing chronic illness is desperately needed in our state. Hawaii residents struggle with high incidence of diabetes and kidney disease and a lack of resources to tackle these issues, putting further strain on our health care system.
