I highly recommend Chad Farias be approved as the Executive Director of the School Facilities Authority.

Because of his leadership and insight, many people have CAS Chad Farias on speed dial. I do not. In 2015 Chad Farias became Complex Area Superintendent (CAS) of the Ka'u-Kea'au-Pahoa Complex Area of the Hawaii Department of Education and "my boss". I am Principal of Na'alehu Elementary School, one of the most challenged schools of HIDOE due to our demographics. CAS Chad Farias surrounds himself with intelligent individuals of high integrity. He initiates and implements systematic practices. When needed, I can reach out to his leads and personnel. I utilize documented resources created by his team. True leadership develops the skill set of many individuals. CAS Chad Farias is a leader of leaders. At the same time, when I need to, I can and do reach out to him directly. I rarely need to contact him directly, but when I do, he responds. On one such occasion I called him but he was busy at the moment. He doesn't know but he accidentally answered the phone and I could hear him speak with whomever he was with. I heard, "Oh, sXXt. It's Darlene. She rarely calls me. I gotta call her back." Within a short time he returned my call and provided guidance in addressing my issue.

CAS Chad Farias has a unique experience base for the position of Executive Director of the School Facilities authority. Besides the "normal" operations of a HIDOE complex area, CAS Chad Farias has had to manage the safety of facilities, staff, students and community in multiple short term and long term emergencies. This includes lava flows, hurricanes, wind storms, SO2, earthquakes, and most recently, COVID. In these tasks he has had to account for a range of facilities in age and condition as the KKP complex has both newer and older facilities, up to 100+ years old. The range of conditions of the communities he services includes geographically isolated schools and communities. CAS Chad Farias has the skill set, knowledge, integrity, flexibility, and decisiveness to guide his team of leaders and administrators to do what is needed on the day to day basis and in emergency situations. CAS Chad Farias also knows how to manage day to day operations (regardless of conditions) to be effective in the short term future and long term future.

As the proud parent of an engineer myself, I am also aware of Chad Farias knowledge and experience in engineering and construction. We've had private conversations in this area and his

passion and understanding of this work is evident. (Note- my son graduated from Ka'u High and Pahala Elementary School, one of KKP's nine schools.)

Most importantly, CAS Farias is balanced with both experience/intelligence and a strong love for community and culture. "Keone" puts his heart and hours into the work of taking care of the extended ohana of KKP and Hawaii. Aloha:

I write this testimony in STRONG SUPPORT of Chad Keone Farias to be the Executive Director of the School Facilities Board.

I have known Mr. Farias for nearly twenty years. When we met, we were both principals of elementary schools who were at the forefront of providing our students with a 21st century education. Mr. Farias and I had long conversations about how we could leverage resources to provide our students with the tools they would need to be successful.

Few people know that Mr. Farias studied engineering in college. However, he realized that he wanted to work with young people so he changed his major, returned to Hawai`i island where he grew up and started as a teacher, earning his teaching credential and a Master's degree in Educational Administration. Mr. Farias has worked in the Hawai`i Department of Education for over thirty years, serving in many capacities including as a teacher, counselor, athletics coach, Student Activities Coordinator, Vice Principal, Principal, and Complex Area Superintendent.

Mr. Farias gets things done efficiently. He is the Complex Area Superintendent of an area of Hawai`i island which includes just nine schools but includes some of the most remote areas of

our state. When lava flow threatened Keonepoko Elementary School in 2015, CAS Farias worked with the Department to build a temporary facility in a portion of the parking lot at Ke`eau High School so students would not lose learning opportunities. When volcanic ash affected the air quality of the schools in his complex area, CAS Farias worked with businesses and the Health Department to find solutions to minimize the negative impact on student learning and attendance. More recently, the pandemic posed many challenges for schools, and CAS Farias was there to support the school communities in his area. This included helping schools to create outdoor learning spaces, ensuring that schools were able to physically distance indoors, and distributing food for the community.

As a military-impacted school principal, I was fortunate that the federal government realized the need to upgrade school facilities on military bases in our country. Daniel K. Inouye Elementary School (aka Hale Kula Elementary) received \$26.6 million from the federal government and \$6.6 from the state of Hawai`i to upgrade our school facilities, a project that took three years (2013-2016) to complete. At the time, I shared that all schools should be upgraded, not just schools on military bases. The main challenge continues to be funding.

I believe that Mr. Farias is the right person to be appointed as the Executive Director of the School Facilities Board. He has served as a member of the SFB for one year, and he is an out-of-the-box educator/thinker with a can-do attitude. He is a risk-taker who recognizes the strengths of people around him and gives them opportunities to grow. He is a collaborator and a good listener who reaches out to the community to partner with the schools. A great example is Ka`u Dream, a partnership between the school, the community, businesses, and non-profit organizations and can be a model for other rural communities. More importantly, Mr. Farias understands the urgency to upgrade our school facilities. His focus will be on creating 21st century facilities, reimagining under-utilized assets, and creating facilities that can be used for multiple purposes including making schools the center of their communities. His background and his 30-year career with the Hawai`i Department of Education have given him the experience as well as the mindset to get things done.
