Thank you for the opportunity to respond to your letter of April 7, 2021. Please note the following:

- 1. Why do you wish to serve as a member of the Defender Council? I joined the Office of the Public Defender right out of law school in 1988 and stayed for 12.5 years. I truly believe and live by the phrase: #PDs4Life. I have a responsibility to support the Office and the DPDs and serving on the Council is the most direct means of doing so. Last year I was informed that there was a vacancy and immediately made it clear that I was very interested in serving. Now that I have served a year, I have applied to continue to serve for a full-term.
- 2. What are some of the accomplishments as a member of the Defender Council and what would you like to accomplish an additional term? During my one year on the Council my focus was on clarifying what the actual duties and authority of the Council are and reaching a consensus with my fellow members on the best method to carry out those duties. This process involved a review of the nature of the historical relationships between the Public Defender and the Council. The Council has increased the frequency that we meet and we recently developed a process to obtain detailed feedback from the rank and file of the office. If re-appointed, my goal is to follow through with the detailed feedback, including addressing the always contentious issue of the evaluation of the Office supervisors.

- **3.** What issues do you believe that the Council has handled well in the past? I believe the most significant past impact that the Council has implemented was the agreement with the present Public Defender that the Council would evaluate the Office supervisors every two years. I also believe that the Council has rightfully taken a more active role in the management of the Office, including obtaining input about personnel decisions from DPDs and others in the criminal justice system. I believe the Council should continue to build trust with the rank and file of the Office that their concerns will be listened to and addressed.
- 4. What issues do you believe that the Council should address in the future? The focus in the coming year will be on evaluating the performance of supervisors and providing input to the Office leadership about the role and performance of supervisors and best practices they can utilize to best serve those that they supervise. As mentioned above, continuing to build trust with the rank and file of the Office that the Council is actively taking a role in the operation of the Office is critical.
- **5.** During your service on the Council, were there possible conflicts of interest? I am unaware of any potential conflicts of interest outside of my relationships with members of the Office given that I have worked with all of the Office administration and know most of the DPDs, including my efforts to meet many of the newest DPDs. In dealing with numerous issues related to the Office I have always focused on the question of what is in the best interest of the overall Office as opposed to my relationship with any particular individuals. I believe that both the leadership and rank and file of the Office have confidence that I will always act in the best interest of the Office.

In closing, during my career I have actively supported the Office, with a special interest in the trial advocacy training and performance of DPDs. I still regularly advise DPDs about trial strategy. I presently serve as the Dean of the HSBA Trial Academy and have received the HSBA Ikena Award for outstanding achievement in legal education and I have always had strong opinions on the role of supervisors and their need to emphasize the development of the trial advocacy skills of the DPDs they supervise, while at the same time I am very aware that said supervisors are responsible for managing the massive number of cases and paperwork that flows through the Office.
