Thank you very much for your letter dated March 28, 2022. I am humbled by Governor Ige's nomination to serve another term on the Defender Council. I sincerely look forward to my continued service on the Council and the broader impacts this has for the Office of the Public Defender, our State and our community.

The past two years have certainly gone by quickly. The entirety of my time on the Council has been during COVID, and that has occupied much of our attention as Council members. We have supported the office through its COVID measures, made the switch to distance meetings, and did our best to navigate the changing times alongside the office. Most of what was needed from us was support during this time. Public Defender James Tabe did an excellent job of leading the office through these unprecedented times. Now that things appear to be transitioning back to normal, we have set our sights on helping as much as possible to improve the office and support its attorneys as needed in the exercise of their duties.

I wish to continue my service as a Council member because I believe there is a lot of good, non-COVID related work left to be done. I occupy a unique role on the Council, being the member who most recently served as a Deputy Public Defender in the Honolulu office. Because of this, I maintain strong relationships with the administration, deputies and staff, and have a finger on the pulse of what's going on in the office. I am often someone that is approached when deputies have concerns, and this connection allows me to raise issues directly to the Council that may not have otherwise been reported. I welcome and value this role as a Council member who people feel comfortable approaching with concerns.

We are now in the process of picking up where the first survey left off to finish the good work that was started by previous members. Our goal is to give everyone an opportunity for input and to address their concerns directly. I would very much like to remain a Council Member to see this through. My utmost goal is to do what I can with the time I have to improve the office, and I look forward to the survey responses to direct what the Council should address in the future.

During my service on the Council, I do not believe any conflicts of interest arose. Again, I believe that my recent service as a Deputy Public Defender is an asset because it makes me approachable and accessible to anyone at the office who wishes for an issue to be raised with the Council. To that end, I strive to be fair and available to all who approach me and to always keep in mind that the best interest of the Office of the Public Defender is my kuleana as a Council Member.

Thank you for your questions about my continued interest in serving on the Defender Council. I will always have the best interest of the Office of the Public Defender at heart. I have appreciated the opportunity these past two years to contribute my voice in a meaningful way to support the office.
