Mahalo and I appreciate the great honor of being nominated by Governor David Y. Ige to the State Rehabilitation Council (SRC) and I am responding to assist you in the consideration process as you have requested, as follows.

- (1) Why do you wish to be a member of the SRC? It is required under the Federal Rehabilitation Act that the SRC include in its composition at least one member of the Client Assistance Program (CAP) and I serve as the CAP representative on the SRC.
- (2) How do you perceive the role and responsibilities of a member of the State Rehabilitation Council?

As the CAP representative, my role is to provide input on the State Plan, advocating for policies, programs and services for individuals seeking competitive employment, including legislative and systemic advocacy. My role includes working in a proactive and collaborative manner with the DVR Administrator and the SRC.

(3) Given your understanding of the role and responsibilities of a member of the State Rehabilitation Council, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision making ability as a member of the State Rehabilitation Council.

I believe that my long years of experience in the fielf of working with people with disabilities and employment, including the first6 supported employment program for persons with disabilities, serving as a program specialist with the State Council on Developmental Disabilities, Director of Rehabilitation at Goodwill of Honolulu, Deputy Director of Hawaii Centers

for Independent Living and, now, as Senior Advocate for the Hawaii Disability Rights Center. My experience in direct service, administrative skills, program planning, fiscal management, writing annual program performance reports, knowledge of local and national resources qualifies me for this position.

- (4) What do you hope to accomplish during your term of service? I hope to help to accomplish results that will increase employment training and opportunities for eligible persons with disabilities and advocate that their rights are fully protected under Federal, State and City and County laws.
- (5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Rehabilitation Council? Three qualities that best describe me would include being assertive, focused and having a capacity for continuing without weakening. I believe these qualities help me work with the SRC in accomplishing its many goals and objectives.
- (6) Name one previous experience that would make you stand out. How would this benefit the State Rehabilitation Council? One previous experience would have to be my upbringing in a loving family whose parents immigrated to the United States from Europe and who valued hard work to become successful. My7 wife, who is from the Philippines, us still working as a housekeeper at the Royal Hawaiian Hotel – for 48 years! My experience guides me to the SRC with this in mind and has laid out my personal road map.
- (7) Can you foresee any possible conflicts of interests that could arise during your service on the State Rehabilitation Council? How would you overcome any possible conflicts of interest?
