Responses: Deja Ostrowski

1. Why do you wish to serve as a member of the Commission on the Status of Women (Commission)? Please note if you initially applied to be nominated to the Commission or if you were invited to apply.

As a current Commissioner who was appointed only six months before the pandemic, I applied again to continue my service. I would like to see how we can follow up the work of the commission as we transition out of pandemic related work.

2. What are some of your accomplishments as a member of the Commission and what would you like to accomplish during an additional term?

The Bridges not Backs Feminist Economic Recovery plan has garnered worldwide recognition including by the UN. We were successful in getting a bill for source of income discrimination in the Governors package in the 2020 legislative session and I hope to build on that advocacy in the future.

3. What issues do you believe that the Commission has handled well in the past?

The Commission took a thought leadership role in supporting the Bridges Not Backs economic recovery plan, in a way that was proactive and community centric and garnered recognition for Hawai'i as a feminist policy leader.

4. What issues do you believe that the Commission should address in the future?

I believe we should continue to address housing discrimination for women and families.

5. During your service on the Commission, were there possible conflicts of interests involving you that arose? How were those potential conflicts addressed? If you were to continue to serve, can you foresee any other possible conflicts involving you?

During my service there were no conflicts of interest. I could foresee that a former colleague could request funding from the Commission. We adopted new procedures and criteria for funding approvals. A Commissioner would be able to recuse themselves from the voting should a conflict arise.
