She would take the most valuable of commodities- time- to start and hold a conversation with them. Us little Peters weren't quite so bold. We clumped together and tried to stay out of sight. In hindsight, this was amazing act on her part and it demonstrated her understanding that we need to talk to the elders for they hold knowledge and history. It also showed great respect. This is who Lauren is.I learned much from her modeling that behavior.

After that, Lauren would then make her rounds to check in on us, The Little Peters' the cousins'. Even if we had a friend over, they got the treatment too. She would go one on one and ask a few questions- and it was always about school! She would ask about our grades or what project we were working on. And she always seemed to have some knowledge of the topic.

There was no escaping it! No one really likes to face that moment of self assessing our progress and taking that hard look at our own actions and progress. Its hard, uncomfortable. So we often don't do it. In a way, I wish my parents did more of this- but they were piloting the ship- both working, mom was actually a teacher in the DOE, 5 kids. And so it goes, sometimes the ship's captain and the crew keep sailing without checking progress or the course. But this cousin, our

elder cousinLauren was like the Harbor Master- whenever we came to port e.g. the family gathering, she would check if this ship was seaworthy, followed regulations, did we do the paperwork? Today, of course, I realize how those small check ups were her way of keeping us accountable to ourselves, and to our families. She was helping us to build our integrity.

The DOE is of course, a very big ship. And big ships cannot course correct or change sail plans on a dime, or on their own. There needs to be all hands on deck approach. But still, this ship needs guidance- they need officers on duty at the harbor to check the sea worthiness of the vessel.

This is why I think Ambassador Moriarty is the appointee we need right now for the BOE. Just as she kept us as her cousins accountable and helped us to bolster our own integrity, so too will she strive to keep the Department accountable to its mission to the students, teachers, and its employees, and yes, to taxpayers. School boards are going through challenging times. It was always hard and the pandemic has amplified the need for solid leadership- not just education is at stake, but lives and livelihoods are too! The pandemic has shown us just how critical public education is to an entire community. It always was, and always will be but now we see it in real time.

I humbly ask the Senate Education Committee to support Governor Ige's appointment and confirm Ambassador Moriarty to the Hawai'i State Board of Education.
