I have known Dr. Tochiki for almost thirty-five years. I first met her when visiting a law school classmate, whom Dr. Tochiki had graciously provided space to begin her law practice. It was the first of many acts of grace I have seen from Dr. Tochiki over the years.

When Dr. Tochiki was our Associate Dean for Student Services, I heard students refer to her as "Auntie Laurie" or "Mom." It wasn't just her warmth and emotional intelligence, which Dr. Tochiki has in spades. As we know, Moms are the world's best advocates and doers when it comes to protecting, nurturing, and advancing those entrusted in their care. Dr. Tochiki undertook her deanship, knowing that her office would fill with students in need, some in long-term crisis. She moved quietly, humbly, and smartly to figure how to address the student's needs. With Dr. Tochiki as our associate dean, the law students knew that they had someone who would take care of them. She effectively did this for twelve years. Her students always perched at the top of her priorities.

Dr. Tochiki's concern for her students' welfare was part of her larger understanding of their education as developing lawyers and human beings. Because she is wise, smart, and balanced, she was able to envision the "long game" for her students. Of course, she had to put out fires in short order, but her problem-solving approach anticipated steps down the line that not only got a student past a crisis, but put them in a far better place, where a student could not only survive but flourish.

I recruited Dr. Tochiki to be my partner in a variety of projects. We launched our award-winning Client Counseling Team twenty-five years ago, and she remains the team's senior coach. We also started the law school's annual Stew Day, where faculty members in thrift store aprons and paper hats pay for and serve stew lunches to students. It is a small way for professors to show appreciation for our students and demonstrate the service ethic of the faculty. Dr. Tochiki and I also began collecting "Hero Stories," where students described in writing how classmates engaged in quiet, sacrificial acts to benefit others. We have hundreds of those little stories now. And for years, we just sat together, trying to figure out how to approach distressed students in my classes. It was there that I saw her mind, spirit, and heart whir together to chalk out her sensible, workable plans.

What do I know about Laurie Tochiki? She is smart, strategic, visionary, and heartful. She is gutsy but knows how to keep her distance from the foolhardy. She listens and reads non-verbal language like no one else can. And boy, can she work, even when she's tired. When something or someone's important to her, there is always time. It's not a trouble for her.

To Dr. Tochiki, the University of Hawai'i is important. She has been a stakeholder in a number of ways and remains so today. Her voice comes from a humble, grounded, strong, and Hawai'i-centric place. She would bring to the Board of Trustees the same commitment, intelligence, skill, and compassion that she has brought to everything and everyone who has mattered to her.
