Chapter 286-5, Hawaii Revised Statutes, establishes the SHSC which advises the Governor on matters relating to the programs and activities of the state in the field of highway safety. The state has adjusted the makeup of the committee from a group that was primarily government officials and safety advocates, to one that includes cross sections of all users of the highway system in our community.
