We believe the Gubernatorial Nominees will bring knowledge, experience and passion that will add tremendously to a council that will advise the department on eliminating roadway fatalities while modernizing the system to meet the current and future needs of our state.

Mr. Gaug currently serves as the senior vice president of investments and analytics at Ulupono Initiative. His areas of oversight include their investment strategy within the ground transportation sector. The Ulupono team is committed to a more sustainable, resilient Hawaii - investing and partnering to increase local food production, renewable energy, clean transportation, and better management of freshwater and waste. Dear Senate President Kouchi and Members of the Senate:

I wish to submit my wholehearted and strong support for the confirmation of [Greg] Kevin Gaug as a State Governor's representative to the Hawaii State Highway Safety Council.

I have worked with Greg for almost four years in his multiple roles affecting sustainable green transportation in Hawaii through his volunteer work on the boards of Bikeshare Hawaii and STCH (Sustainable Transportation Coalition of Hawaii) and his work at the Ulupono Initiative.

He will bring an important viewpoint and skills set relating to the programs and activities of the State in the area of 'highway' safety especially as it supports Vision Zero goals and participation in community conversations about safer active transportation. His long and deep work with Bikeshare Hawaii has allowed this mobility service to make the greatest impact on cycling in Hawaii, especially Honolulu since the first introduction of bicycles during the 1890s Monarchy. The Biki system has made cycling safer overall by introducing many well maintained, accessible, and affordable city bikes in urban Honolulu: thus, reinforcing the "safety in numbers" research findings of transportation planners/ engineers: i.e. the more cyclists that drivers frequently experience and share the roadway with lowers the crash and injury rates of cyclists involved with motor vehicle operators.

Thus far, the Biki system has served over 300,000 users who rode over 5 million trips which is equivalent to:

- Over 11 million miles travelled (half of which would have been car trips);
- Over 13 million pounds of CO2 avoided (vs mitigated); and
- Over 444 million calories burned (important for type 2 diabetes avoidance).
