## Senate Committee on Transportation

The Department of Transportation (DOT) **supports** the nomination of Michael Packard, to the State Highway Safety Council (SHSC).

Chapter 286-5, Hawaii Revised Statutes, establishes the SHSC which advises the Governor on matters relating to the programs and activities of the state in the field of highway safety. The state has adjusted the makeup of the committee from a group that was primarily government officials and safety advocates, to one that includes cross sections of all users of the highway system in our community. We believe the Gubernatorial Nominees will bring knowledge, experience and passion that will add tremendously to a council that will advise the department on eliminating roadway fatalities while modernizing the system to meet the current and future needs of our state.

Mr. Packard is a professional traffic engineer who has spent much of his career addressing solutions to improve transportation safety. He has worked with all county and state transportation agencies on policy, planning, design, and construction oversight of our roads and paths.

Much of this work has concentrated on improving safety and accessibility for the most vulnerable users, including those traveling on foot and on bicycle. Mr. Packard served as the first Complete Streets Administrator for the City and County of Honolulu. As administrator, he advanced efforts to implement complete street oversight on all city roadway projects through the coordination of a team comprised of multiple city agencies.

Additionally, he worked with the DOT on multiple roadway safety projects, including pedestrian studies and implementation along Kalanianaole Highway, the roundabout

study and design at intersections along Keaau-Pahoa Road, and the study and design of improvements for all users along Queen Kaahumanu Highway.

The DOT respectfully requests that this Committee confirm Michael Packard to the SHSC whose members serve without compensation.

Dear Senate President Kouchi and Members of the Senate:

I wish to submit my wholehearted and strong support for the confirmation of **Michael Packard** as a State Governor's representative to the Hawaii State Highway Safety Council.

I have worked with Michael for almost four years in his multiple roles affecting transportation in Hawaii through his work with SSFM and the City. [Plus, I bike commute on many of his project bikeways and complete streets.]

He will bring an important viewpoint and skills set relating to the programs and activities of the State in the area of 'highway' safety especially as it supports Vision Zero goals and implementing best practices roadway design for safer active transportation on state highways (complete streets). His many years of professional engineering work in Honolulu in the design and operation of the bikeway network has built the physical foundation that has allowed Biki to be the success that it has become, as the 6<sup>th</sup> most ridden docked bikeshare system in the US.

The Biki system, which makes up a super majority of the daily bike traffic in Honolulu, has a very low reported injury rate, as compared to shared micro-mobility overall (i.e.  $1/60^{\text{th}}$  to  $1/100^{\text{th}}$  that of e-scooters nationally).

Thus far, the Biki system has served over 300,000 users who rode over 5 million trips which is equivalent to:

- Over 11 million miles travelled (half of which would have been car trips);
- Over 13 million pounds of CO2 avoided (vs mitigated);
- Over 444 million calories burned (important for type 2 diabetes avoidance).

HIPHI strives to be a bridge between community and partners from government and healthcare so that all relevant stakeholders throughout the Hawai'i are involved in decisions related to public health policy, programs, and investments. We believe we can play a significant role in the shift of public health from being primarily about treating disease to the promotion of preventing it. Our work includes food and agriculture, transportation and public safety, oral health, healthy eating + active living (HEAL), drug and alcohol prevention, tobacco prevention and control, COVID-19 response efforts and workforce development.

Mr. Packard is a senior engineer in SSFM's Strategic Services, with over 20 years of progressive traffic engineering and transportation planning experience. Mr. Packard has worked on several projects with HIPHI, with the most recent being a quick build demonstration project at the intersection of Papa Avenue and Mā'alo Street on Maui in March 2021. About 200 residents and Lihikai School staff, teachers and families participated in a survey last fall, sharing their experiences using the Papa Avenue – Mā'alo Street intersection. Public input was instrumental in the project design and street beautification. Aligned with Complete Streets principles and Vision Zero Maui initiatives, this quick build project included enhanced bike and pedestrian crossings, improved sight lines, back-in angled parking, and traffic calming features. The project also featured designs Maui artist Matthew Agcolicol to help beautify the intersection,
