Pūlama Lāna'i is in **support of GM 854**, a consideration and confirmation request for the Gubernatorial Nominee, MICHAEL YAMANE, for a term to expire 06-30-2026 to the Land Use Commission (Commission).

To administer land use law, the Legislature established the Commission, which is responsible for preserving and protecting Hawai'i's lands and encouraging those uses to which lands are best suited. The Commission's primary role is to ensure that areas of state concern are addressed and considered in the land use decision-making process. The Commission establishes the district boundaries for the entire State, acts on petitions for boundary changes and requests for special use permits within the Agricultural and Rural Districts, and designates important agricultural lands.

Hawai'i has limited land and there are competing uses for these lands, which include energy, housing, and agriculture-- to name a few. Mike's background and skills will be beneficial to the collective group of commissioners as decision makers in future land use applications. As a retired utility executive that was instrumental in Kaua'i's transition to a renewable utility he has years of experience in strategic planning, technical insight, and regulatory processes. Aloha mai kākou,

I submit my opposition to appointing Michael Yamane onto the Land Use Commission for reasons of fear of private interest influencing decision-making. I am cautious when it comes to former public servants creating their own firms prior to being appointed to a higher position where such can be a conflict of interest.

The next few years of the direction the State goes are crucial to creating the future for my generation. I am a firm advocate for the protection of our agricultural lands, with decisions on the future designation of my island of O'ahu's Important Agricultural Lands as well as surmounting pressure to turn such lands along with other lesser ag land designations into solar and wind farms, I am deeply concerned with the future of Hawai'i's food security and if we are seeking solutions or simple profit-based decisions.

It is my understanding that Mr. Yamane formerly worked under the Kaua'i Island Utility Cooperative, who I although I do applaud for demonstrating an alternative business model outside of HECO, I do question decisions that swept the community under a rug with streams diverted for hydroelectric facilities. These facilities massacred huge amounts of subsistence by killing 'o'opu and so much more stream wildlife vital to our ecosystem. For me I look for action, and what I seen from my friends on Kaua'i is this idea of "taking" from these different sources, to "take us into the future" with little regard to what we "takeaway" from future generations. Such models and metrics for me are unacceptable.

As an 'ōpio, I do support having diverse technical backgrounds, but there are people with such backgrounds that can still find solutions that are far less detrimental and do keep in mind the need to improve and not undermine our island's ecosystems which also undermine our ability to grow food our live subsistence lifestyles on the land.

With the recent reprimand of Representative Ty Cullen and Senator Kalani English, I would hate to speculate on whether or not poker chips are being moved to support individuals like Mr. Yamane to step in at such a time when the so-called "green" energy sector is pressuring many of our public officials to take action without consideration to what is lost for future generations.

We do not need more individuals that are self-serving in their private interests to be making decisions that must consider the overall public.

Again I ask you to oppose this nominee.
