## H.B. 1290 RELATING TO TRANSPORTATION

House Committee on Transportation

The Department of Transportation (DOT) **supports** H.B. 1290, which appropriates general funds to the DOT for bicycle paths in Lower Puna.

The DOT supports providing more multimodal transportation connections on both the State and county systems. If general funds are appropriated for the effort, the DOT will work with the County of Hawaii on the routes identified in this bill: Kahakai Boulevard and Pahoa Village Road. The DOT will defer to the County on requests to plan, design, and construct improvements on the County roadway network.

On State Route 130, there is an existing shoulder bikeway from State Route 11 to Paradise Drive that was implemented over twenty years ago. The remainder of State Route 130 is a proposed shoulder bikeway that will cost an estimated \$1.8 million for project planning and design and an estimated \$12 million to construct due to the need to widen the existing paved shoulder outside of the existing paved roadway.

The DOT recently completed the Bike Plan Hawaii Refresh in 2022, which reevaluated data, priorities, costs, and feasibility of proposed projects from the 2003 Bike Plan Hawaii. This reevaluation included input from the public and bicycling stakeholder organizations, including People's Advocacy for Trails Hawaii. Adding bicycle improvements to State Route 130 from Paradise Drive through Pahoa Village Road is currently a mid to longer term priority for implementation due to the cost. However, if general funds are appropriated for the improvements, the implementation priority will be reevaluated.

Bicycle and pedestrian specific needs and improvements are identified through the DOT's bicycle and pedestrian programs. Both programs use a technical process coupled with community and public input to assess the bicycle and pedestrian network. Projects are then implemented as standalone projects or as part of larger transportation projects. Last year, as reported in the DOT Act 100 legislative report, more than \$45

million was expended for bicycle and pedestrian improvements, which include expenditures on raised crosswalks and shared use paths.
