This bill will serve to hold accountable those who repeatedly abandon vehicles. In our experience, there does appear to be a certain demographic of people who chronically dump vehicles. One fairly common type of perpetrator includes amateur or independent mechanics who acquire vehicles for parts and then abandon them after they have removed the parts that are useful to them, littering the streets with hazardous, stripped shells of cars. We hope that taking a stronger stance and holding them more financially accountable will deter them from this activity, decreasing the number of vehicles that require response.

For reference, I serve as the County of Maui Division Manager for Environmental Protection & Sustainability, where the Abandoned Vehicles Program is housed. I also served as the administrator for the AV program for five years, so I have a great deal of familiarity with the program and associated challenges.

Therefore, we urge this committee to pass this bill in order to deter chronic perpetrators from further escalating the problem of abandoned vehicles and hold them more accountable for their wrongful actions.
