Chair Quinlan and Members of the Committee:

The Department of the Attorney General (the Department) opposes this bill.

This bill creates a new section within chapter 706, Hawaii Revised Statutes (HRS), and authorizes the court to sentence a misdemeanor defendant to a geographic restriction as a term of probation if the defendant's instant conviction as well as the defendant's four prior misdemeanor convictions occurred within a single "business district" or "resort zoned area". This bill also creates an additional misdemeanor offense for violation of the geographic restriction, with a mandatory sentence of imprisonment of thirty days.

Existing law, section 706-624(2)(m), HRS, already authorizes the court to impose a geographical restriction as a special condition of probation, regardless of whether a defendant has any prior convictions, and regardless of where the offenses were committed. Section 706-624(2)(k), HRS, also allows the court to prohibit a defendant from residing in a specified place or area.

Additionally, if there is a willful and deliberate violation of the geographical restriction, and therefore a violation of a defendant's probation, that defendant would be subject to a probation revocation and resentencing for the offense. In other words, a defendant would be facing imprisonment for a full year, not just thirty days as proposed in this bill (page 1, line 15).

Finally, the Department notes that a definition was provided for "business district" (page 2, lines 5-11), but not for "resort zoned area" as referenced on page 1, line 8.

In conclusion, this bill is duplicative because existing law already provides the ability to achieve the bill's purpose and to impose a stronger penalty than what is proposed. It also potentially undercuts the penalties already provided in current law, by creating an inconsistency between the proposed new section and the existing law. We respectfully request this committee hold this bill.
