H.B. 1515 RELATING TO TRANSPORTATION

House Committee on Transportation

The Department of Transportation (DOT) offers **comments** on this bill which requires the Director of Transportation to adopt rules that require tour aircraft operators to have aircraft liability insurance coverage of not less than \$1,000,000 per person per incident.

The Federal Aviation Administration (FAA) requires air carriers under Part 121 and 135 to have Aircraft Accident Liability Insurance per Title 14 CFR Part 205.5. The FAA Standards Office monitors the requirements.

The bill only requires tour aircraft operators to have aircraft liability insurance coverage of not less than \$1,000,000 per person per incident, not all air carriers under Part 121 and 135. FAA Grant Assurance No. 22, obligates DOT to make its airports available for public use on reasonable terms and without discrimination to all aeronautical activities.

TESTIMONY IN SUPPORT OF HB1515 RELATING TO AIRCRAFT

Good morning Chair Aquino and members of the Transportation Committee.

My name is Claudine Tomasa (Kailua Resident and Member of the Kailua Neighborhood Board) and I am testifying in support of HB1515 that requires the Director of Transportation to adopt rules that require tour aircraft operators to have aircraft liability insurance coverage of not less than \$1,000,000 per person per incident.

The same industry standards as commercial airlines should be enforced upon Air Tour helicopters & small aircraft, which are often more susceptible to crashes.

Kailua experienced a fatal helicopter crash on Oneawa Street - April 29, 2019 - the third helicopter crash within a six month period in Windward Oahu.

With the increased and widespread operation of sight seeing helicopters and plane tours in Hawaii, local citizens living in densely populated communities are concerned about their safety as well as the safety of passengers.

HB1515 may address the costs of medical expenses and property damage stemming from an aviation crash.

Please support and pass this Bill to the next Committee.
