RELATING TO COMPOSTING

The Department of Budget and Finance (B&F) offers comments on this bill. House Bill No. 1528 requires the Department of Agriculture to establish a compost reimbursement pilot program to provide reimbursements to farmers and ranchers for up to 50% on purchases of compost from certified vendors, provided that no single farmer or rancher can receive more than \$50,000 per year. This bill also appropriates an unspecified amount of general funds in FY 23 for 1.00 permanent Program Manager position, program administrative costs, and reimbursements.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

Chairperson Lowen and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1528. The bill establishes and appropriates funds for a compost reimbursement program within the department of agriculture and one full-time permanent compost reimbursement program manager position to oversee the program and requires an annual progress report of the program to the legislature prior to each regular session. Aloha Chair Lowen, Vice-Chair Marten, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports HB 1528, which establishes and appropriates funds for a compost reimbursement program within the department of agriculture and one full-time permanent compost reimbursement program manager position to oversee the program.

HFB strongly supports the concept of building soil structure and nutrient capacity. Caring for the soil is a cornerstone to having multigenerational farms that continue to provide for the people of Hawaii. Many of our farms add compost made off-site as well as utilize short-term fallow between crop cycles to increase organic content in their soils. HFB recognizes and supports the diversion of discarded food and other useful wastes away from landfills. The benefits of this and of composting are well-known.

Farming is a tough business. High production costs are a major driver of narrow profit margins for Hawaii's farmers. Land, water, labor, taxes, transportation, utilities, inputs, invasive species, and food safety regulations are all costs of doing business that often results in our farmers just being able to break even. HFB supports this initiative that could reduce the cost of production for local farmers by incentivizing, with a 50% match, the use of compost material. This is another mechanism that can help locally produced goods compete with imported products, strengthening our local economy.

I, Kahealani Acosta, testify IN SUPPORT of HB1528, relating to composting.

According to UHERO study conducted in 2015 [1], approximately 26% of food is wasted along Hawai'i's available food supply, which estimates a total loss of \$1 billion dollars of fresh consumable food annually. Food is lost all along the food chain, with greatest losses occuring at the consumer level. In 2020, Honolulu alone accounted for 400 million pounds of food waste. Consequently, Hawai'i residents lose an average of \$700 on food that goes straight to the garbage. On O'ahu, 15

percent of residential garbage is food, equating to about 435 pounds of food waste per household per year (<u>opala.org</u>). This waste has the potential to become an agricultural commodity, if suited for outcomes that regenerate this waste into a valuable, nutrient-rich source material for agricultural and soil remediation strategies.

Moreover, in alignment with other agricultural bills moving through the 2022 legislative session, HB1528 would serve as a companion to SB2989, relating to a healthy soils program in Hawai'i. Soils are composed of 45% parent material, 25% air, 25% water, and 5% organic matter, in which organic matter is the sole source of energy for biological matter within the soil and is required for a healthy and well-functioning soil [2, 3].

According to the US EPA [4], compost possess the following benefits:

The Food+ Policy internship develops student advocates who learn work skills while increasing civic engagement to become emerging leaders. We focus on good food systems policy because we see the importance and potential of the food system in combating climate change and increasing the health, equity, and resiliency of Hawai'i communities.

In 2022, the cohort of interns are undergrads and graduate students from throughout the UH System. They are a mix of traditional and nontraditional students, including parents and veterans, who have backgrounds in education, farming, public health, nutrition, and Hawaiian culture.

- Organic waste in landfills generates methane, a potent greenhouse gas. By composting wasted food and other organics, methane emissions are significantly reduced.
- Compost reduces and in some cases eliminates the need for chemical fertilizers.
- Compost promotes higher yields of agricultural crops.
- Compost can help aid reforestation, wetlands restoration, and habitat revitalization efforts by improving contaminated, compacted, and marginal soils.
- Compost can be used to remediate soils contaminated by hazardous waste in a cost effective manner.
- Compost can provide cost savings over conventional soil, water and air pollution remediation technologies, where applicable.
- Compost enhances water retention in soils.
- Compost provides carbon sequestration.

In alignment with the aloha+ challenge goal of solid waste diversion to 70% by 2030, as well as other supportive measures in the 2022 legislative session, **HB1528** is primed as an opportunity of converting food and other green waste into food for Hawai'i's soils, and ultimately a healthier and more resilient food system.

As a graduate student of indigenous cropping systems, a budding farmer, and advocate for sustainable and resilient food systems, I urge the committee to pass HB1528. On behalf of the Hawai'i Food+ Policy Internship, I would like to thank Chair Lowen, Vice Chair Marten, and members of the House Committee on Energy and Environmental Protection, for considering the comments made herein.
