#### Testimony of the Hawaii Board of Veterinary Medicine

#### On the following measure: H.B. 1598, RELATING TO VETERINARY MEDICINE

Chair Johanson and Members of the Committee:

My name is Kerrie Shahan, and I am the Executive Officer of the Hawaii Board of Veterinary Medicine (Board).

The purposes of this bill are to: (1) authorize the Board to grant temporary courtesy and relief permits for out-of-state veterinarians; (2) permit licensed veterinarians to practice veterinarian telemedicine; and (3) to allow for international veterinary school graduates to qualify for licensure examination.

The Board will review this bill at its next publicly noticed meeting on February 11, 2022. While the Board has not had the opportunity to review the bill, it is in support of the intent of the measure. Specifically, the Board appointed two permitted interaction groups to research and review telemedicine and best practices for out-of-state visiting veterinarians, which this bill proposes. Also, the Board has had discussions about how new permits would impact the Professional and Vocational Licensing Division in terms of IT upgrades and additional operational and personnel costs.

In addition, the Board has previously expressed support of the acceptance of the PAVE certification for foreign graduates at several of its meetings.

On behalf of the Hawaii Veterinary Medical Association (HVMA), I would like to express our strong support of HB 1598 and its strengthening of Hawaii's veterinary practice law.

HB 1598 amends Hawaii Revised Statutes Chapter 471 on Veterinary Medicine to better define the practice and parameters of veterinary medicine and veterinary telemedicine to protect consumers and their pets from inadequate, improper, or unlicensed veterinary care. In addition, it addresses the current shortage of veterinary specialists and practitioners in Hawaii by allowing the Board of Veterinary Medicine to grant temporary permits to out-of-state veterinarians and provides for international veterinary school graduates to qualify for licensure examination in Hawaii.

The COVID-19 pandemic has increased consumer demand for telehealth in the field of veterinary medicine. Telemedicine has allowed consumers more access to veterinary services for their pets, particularly in areas where access to veterinary care is limited. However, HVMA is aware that the use of telemedicine may also be abused without an established veterinary-client-patient relationship. Without actual physical examination of a pet, veterinary services rendered through telemedicine alone can be inadequate and below the standard of veterinary care. The addition of telemedicine definitions and parameters will help to clarify the practice of veterinary telemedicine and assist the Hawaii Board of Veterinary Medicine in ensuring consumers in Hawaii receive proper and licensed veterinary telemedicine services.

Additionally, the pandemic highlighted the shortage of veterinarians available to provide specialty and routine veterinary care for Hawaii's people and their pets. At times, veterinary emergency hospitals were unable to operate 24/7 and surgeon schedules were completely booked for months due to the inability to fill these staffing shortages by temporary permit. In one specific case, there was a veterinary surgeon within the state that could have assisted during this period, but due to her international veterinary school degree, was unable to sit for Hawaii's state licensing exam due to a technicality in the administrative rules. These amendments are critically important to prevent such veterinary care shortages in the future, and to ensure that all qualified veterinarians are allowed to sit for the Hawaii state licensing exam.

The HVMA requests that HB 1598 be amended to include the following four changes:

1. To ensure consistency with federal (FDA) VCPR definition, the following telemedicine language definitions should be stated as:

Aloha Chair Johanson, Vice Chair Kitagawa and Committee Members,

On behalf of the Hawaiian Humane Society, thank you for considering our enthusiastic support for House Bill 1598, which authorizes the board to grant temporary courtesy and relief permits for out-of-state veterinarians, permits licensed veterinarians to practice veterinarian telemedicine, and allows for international veterinary school graduates to qualify for the licensure examination.

This bill seeks to restore a pathway for out-of-state veterinarians, licensed in good standing, to assist our local veterinary community, and the pet owners and animals of Hawai'i. In late 2020, the Hawaii Board of Veterinary Medicine closed the existing pathway that allowed visiting veterinarians to practice in the state. It agreed to work with stakeholders to create a new system, one that meets the needs of our community while giving the board greater control over visiting veterinarians and clarrifying that professionals who wish to work in the state regularly must apply for a Hawai'i license. This bill is the result of that collaborative effort.

HB 1598 will allow animals to get immediate care in the case of natural disasters or rescues, it will allow out-of-state veterinarians, licensed in good standing, to assist Hawai'i-licensed professionals and it will allow our local veterinarians some much needed respite. Its provisions protect animals, serve the interests of consumers and support access to high-quality veterinary care.

We urge the committee to pass HB 1598. Mahalo for your consideration. I would be happy to answer any questions.

Dear Committee on Consumer Protection and Commerce,

On behalf of Veterinary Emergency + Referral Center, I am writing to express our strong support of HB 1598. The overarching intent of HB 1598 is to ensure continuous access to qualified veterinary care, with appropriate oversight from the Board of Veterinary Medicine, for all animals in Hawaii and is consistent with the mission of our organization.

Veterinary Emergency + Referral Center (VERC) is one of Hawaii's few 24-hour emergency and specialty referral veterinary facilities, offering an array of advanced diagnostic and treatment services to provide the current standard of care for small domestic animals. As a medical director at VERC, one of my responsibilities is to ensure uninterrupted availability of experienced emergency veterinarians in our hospital 24 hours a day, 365 days a year, as well as consistent coverage of our specialist services during business hours. There are a limited number of Hawaii-licensed veterinarians with the appropriate training, certification and experience to practice in facilities like ours, so we rely on out-of-state veterinarians to maintain coverage and provide a consistent level of expertise and care.

On the island of Oahu we have just 2 practicing veterinary critical care specialists, 4 small animal internists, 1 cardiologist, 1 radiologist, 1 dentist, 1 neurologist, 3 ophthalmologists and 3 surgeons. We are still lacking specialists in many disciplines, and highly trained and experienced emergency veterinarians are in short supply. This leaves Hawaii consumers and their pets constantly at risk of experiencing lapses in available emergency and specialty veterinary care if even one of these individuals needs to be away from work for any reason, whether it is for vacation, continuing education, illness, injury, maternity or personal leave. It also places an enormous burden on our veterinarians who often find it impossible to take the time they need away from work, leading to career dissatisfaction, burnout, attrition, and even greater risk of lapses in available care within our community. I have experienced this first-hand as one of the small animal internists and the wife of Hawaii's only radiologist. We have to plan vacations or other time off 6 months to a year in advance and sometimes still are unable to go. My husband read x-rays from the delivery room when our first child was born, and he wasn't able to take even a single day off following the birth of our second because there was no one to cover his workload.

In the 10 years I have served in the role of medical director at VERC, it has often been difficult to recruit veterinarians for our vacant positions. It has been even more challenging during the COVID-19 pandemic and, unfortunately, we have experienced some lapses in ability to provide care over the past year that negatively impacted the community when we lost our surgeon, were unable to license another highly qualified, board-certified surgeon due to current licensing law, and were unable to obtain temporary permits for emergency doctors in time to keep our emergency service staffed. This year Hawaii also lost our only board-certified oncologist and there were times when owners of pets with a cancer diagnosis could not get an appointment with an oncologist due to difficulty obtaining temporary permits for out-of-state oncologists. We need to be able to more readily bring in board-certified specialists and experienced emergency veterinarians from outside the state to ensure Hawaii's pets have access to current standards of care on a consistent basis when we cannot fill a vacant position or one of our team members needs to be away from work.

Currently the process of obtaining a temporary permit or Hawaii license for veterinarians is cumbersome and not worthwhile to complete for veterinarians who intend to work here only for a couple of weeks to provide relief, and the in-person examination requirement is an additional deterrent. HB 1598 will allow us to more easily hire experienced veterinarians licensed in other states on a temporary basis, with appropriate oversight from the Board of Veterinary Medicine, to ensure Hawaii consumers have access to emergency and specialty veterinary care and avoid the critical lapses in care that occurred in 2021. It will also ensure general practice veterinarians can hire relief veterinarians to help keep their practices open and clients served during any necessary absences, allow our shelters to bring in veterinarians to support their efforts where necessary, and out-of-state veterinarians to come to our aid in the event of an emergency.

The VERC organization also supports acceptance of PAVE for foreign veterinary graduates seeking licensure in Hawaii. The Program for the Assessment of Veterinary Education Equivalence (PAVE) is a pathway for veterinarians who are graduates of international, non-accredited veterinary programs to practice in the United States and Canada. PAVE is a rigorous program that evaluates and certifies the education equivalence of these graduates. PAVE is currently recognized by 45 states and territories in the Unites States, all provinces and territories in Canada, as well as the counties of Australia and New Zealand. Many foreign veterinary graduates are attracted to Hawaii's diversity and culture. Allowing those who have completed PAVE certification to become licensed veterinarians in Hawaii will ensure we are able to consider all qualified veterinarians wanting to offer their talents and expertise to our community.

Finally, VERC supports the portions of HB1598 referring to telemedicine and its regulation. We encourage amending the language of the bill as suggested by the HVMA to include the requirement of a physical examination in establishing a veterinarian-client-patient relationship as this is a crucial element to providing appropriate veterinary care and will protect Hawaii consumers.

Dear Members of the House in the State Of Hawaii,

I am writing to express my fervent, and quite honestly, desperate support of House Bill 1598. A portion of this bill creates provisions for qualified out-of-state veterinarians to perform permitted relief work. The purpose of this personal testimony is to explain the great need for additional support for our patients, our professional community, and our state.

Veterinary care in Hawaii has a long and illustrious history, with many skilled veterinarians paving the way for what it is today. However, today's veterinary graduates whom are the future of our work-force, rely heavily on specialists for advanced treatments that are now the standard of care. In the last 10 years, the number of specialists in our state has slowly increased, but not nearly enough to meet the demand. In our state, there are only a small handful of overworked Hawaii licensed board certified internal medicine doctors, surgeons, criticalists, ophthalmologists, cardiologists, oncologists, radiologists, and zoo veterinarians. Some of these are non-resident veterinarians who were only licensed in the last year to help with relief. We have one neurologist. There are no resident nutritionists, dermatologists, or radiation oncologists. We have one full-time equine/large animal veterinarians. We are in a crisis!

For the past 9 years I have served as the sole board certified small animal surgeon at VCA Oahu Veterinary Specialty Center, and currently one of three full-time board certified surgeons in the state of Hawaii. At many times of the year, one of us is the ONLY board certified surgeon in the state. I have been responsible for elective and emergency surgical care of dogs, cats, small mammals, and exotics that require the skill of a specialist surgeon. This includes everything from orthopedic, spinal, cardiothoracic, gastrointestinal, hepatobiliary, urogenital, reconstructive, and cancer surgery, to interventional radiology.

At our practice I average 50 appointments per week, and 15-20 surgeries per week, with a direct nursing staff that fluctuates between two and four people per shift. We work an average of 14 hours per day, 4 days a week, and are on call 24-7, 7 days a week. During the last year alone, we performed nearly 250 emergency surgeries per year, in addition to our regularly scheduled caseload. My first available consultation appointment is nearly in June, 2022. The purpose of this testimony is not toot my horn, it is a wake up call that while we have risen as a team to the needs of our community and hospital - we are sacrificing our own needs and health and we know this is not sustainable.

In the past 2 years, the need for essential veterinary health care services has grown exponentially. Our service alone, which was running at nearly maximum daily capacity in 2018, has grown by nearly 30% in the last 2 years. During this time, staffing remained the same, or worse due to COVID-19. Veterinarian and veterinary technician burn-out is at an all-time high. Our profession has a 3x higher suicide rate than average, with one of the highest, if not highest suicide rates in the United States and United Kingdom. However, if we do not work to the point of burn-out on a regular basis, patients are unable to receive timely care leading to poor outcomes, and greater emotional fatigue all around. None of us is trying to be a martyr, we are simply needed even when we are exhausted, and the alternative in many cases is the morbidity or mortality of a patient.

In addition to the daily needs of patients, our state currently does not have provision for emergency licensing of out-of-state veterinarians in the event of a natural or man-made disaster requiring a rapid response. As a state that is at high risk for inclement weather events, with limited human and material resources - this is of utmost importance.

Prior to 2018, the Board of Veterinary Medicine allowed interpretation of HRS-471 to include the legal sponsorship of qualified out-of-state veterinarians to practice on an emergency or relief basis. This allowed veterinarians, especially highly-qualified specialists of which there are few in our state, to work in place of a Hawaii-licensed veterinarian. We were able to take much needed time away from work without leaving a gap in coverage for our state. However, since November 2018, the statue was reinterpreted by the Board of Veterinary Medicine and the sponsorship program was terminated.

A permitted interaction group was formed and the bill you have before you was created with the wisdom, desperation, and support of Hawaii's own veterinarians. The visiting veterinarian and telemedicine portions of the bill will specifically improve our ability to provide timely quality care to so many animals who need us. It will also enable us to help ourselves, as we are struggling too. I myself, joined the Board of Veterinary Medicine specifically to help be a part of a solution to provide continuous comprehensive care to the animals of Hawaii and their human companions. I am fully supportive of the Bill's intent to provide regulated and accountable help for the veterinarians in the state of Hawaii, and I hope that this personal testimony serves as an eye opener.
