### Testimony COMMENTING on H.B. 1623 RELATING TO CONTROLLED SUBSTANCES

#### 1 Fiscal Implications: Undetermined

2 Department Testimony: The Department defers to the Department of Public Safety on the

3 implementation of this measure but offers the following comments and offers amendments.

4 First, the term "substance use disorder (SUD) services clinic" is not defined, so the bill is unclear

5 on what other controlled substances are at issue besides methadone. SUD clinics cannot

6 prescribe nor dispense methadone (a Schedule II drug). Only Opioid Treatment Programs (OTP)

7 do, since they have a physician. Outpatient SUD clinics typically include suboxone (a Schedule

8 III drug because it contains buprenorphine and the life-saving drug naloxone) in an SUD client's

9 treatment plan, then refers them to their physician. The physician prescribes, and the client gets it

10 from the pharmacy.

11 Second, the Alcohol and Drug Abuse Division is working with the Med-QUEST Division to

12 expand Medication Assisted Treatment options for those with opioid use disorders, which

includes the use of buprenorphine and suboxone. According to the National Survey on Drug Use

and Health, over 23,000 Hawaii adults statewide need but are not receiving treatment for illicit

drug use disorders that includes use of marijuana, cocaine and heroin. There are over 150 Hawaii

16 practitioners with an approved federal waiver to provide buprenorphine to treat opioid use

17 disorders. The federal Substance Abuse and Mental Health Services Administration or <u>SAMHSA</u>

18 <u>encourages practitioners to apply for a buprenorphine waiver</u>.

Offered Amendments: First, please strike "substance use disorder services 1 clinic" throughout the bill because the term is not defined, unless clarification is given on 2 what other controlled substances besides methadone are at issue. 3 Second, if this measure becomes law, and if SUD clinics are included, we request an amendment 4 to grandfather existing methadone clinics and SUD services clinics in the following Sections: 5 6 Section 1, page 3, paragraph (6): 7 (6) The clinic will be located at least seven hundred fifty feet away from any real property comprising a 8 protected area, provided that this section shall not 9 10 apply to any methadone clinic or substance use disorder clinic that maintains centralized ordering, 11 storage, and record keeping of controlled substances 12 and that is registered with the department as of one 13 14 year from the effective date of this Act. Section 2, page 7, paragraph (i): 15 16 (i) No registration shall be issued or renewed under this 17 section to any person, applicant, or registrant, and no 18 registration shall be waived under subsection (d) for any person or applicant, for a methadone clinic or substance use disorder 19 services clinic if the clinic is within seven hundred fifty feet 20 21 of a protected area, as defined in section 712-1249.6, provided 22 that this section shall not apply to any methadone clinic or 23 substance use disorder clinic that is registered with the 24 department as of one year from the effective date of this Act." Section 4, page 11, paragraph (5): 25 Is a registrant for a methadone clinic or substance (5) 26 use disorder services clinic that has located or 27 relocated within seven hundred fifty feet of a 28

## TESTIMONY ON HOUSE BILL 1623 RELATING TO CONTROLLED SUBSTANCES. By Max N. Otani, Director

House Committee on Health, Human Services and Homelessness Representative Ryan I. Yamane, Chair Representative Adrian K. Tam, Vice Chair

Chair Yamane, Vice Chair Tam, and Members of the Committee:

The Department of Public Safety (PSD) strongly opposes House Bill (HB) 1623, which: 1) expands the prohibition on promoting a controlled substance in, on, or near schools, school vehicles, public parks, and public housing projects or complexes to include group child care centers, group child care homes, public recreation centers, and youth services centers, collectively as protected areas, 2) requires the registration and registration renewal of methadone clinics and substance use disorder services clinics as clinics and for handling controlled substances to be contingent upon location at least 750 feet away from protected areas, and 3) gives methadone clinics and substance use disorder services clinics one year from the effective date of this Act to comply with this Act. PSD strongly opposes this measure for several important reasons and respectfully requests that the committee hold this measure.

First, under HB 1623, the Bill as proposed seems to prohibit under Section 1 (a) any and all clinics from being less than 750 feet from a protected area. This would mean that other clinics such as dental clinics, veterinary clinics, and other healthcare "clinics" would be affected by this measure.

Second, under HB 1623, PSD would be prohibited from both issuing a new controlled substance registration and renewing a current controlled substances registration if a "protected area" were to either currently exist, or suddenly develop within 750 feet from a methadone clinic or a substance use disorder treatment clinic.

On Oahu, there are only two currently operating opioid treatment programs (i.e., "methadone clinics") and a third program is about to open. One of those programs would be immediately affected by HB 1623 if it were to pass into law. None of those businesses can operate if they cannot obtain a Hawaii controlled substances registration from PSD. Consequently, If this bill were to pass into law, that would mean that within one year, a currently existing clinic in Downtown Honolulu would have to relocate or close. Moreover, if that clinic were not able to relocate because of finances or other business conditions, it would mean that the hundreds of vulnerable patients served by that treatment program would be displaced.

Third, HB 1623 places every opioid treatment program and possibly, all substances use disorder services clinics at risk of disruption, either upon passage of this bill, or in the future, if a business were to develop within 750 feet of them, thereby creating a "protected area." The current Oahu opioid treatment programs have been in business at their current locations for decades. Their business futures and those programs on the neighbor islands, would become entirely vulnerable to any development of businesses, such as child care, and child related businesses that may develop within 750 feet of them in the future. PSD also notes that there is a third opioid treatment program that is about to open in Downtown Honolulu at a time where there are currently no restrictions, as proposed under HB 1623. The owner of that business has invested money, time, and efforts to build her business and comply with the many state and federal laws involved in opening an opioid treatment program. That business has also taken more than a year to develop. Consequently, if any opioid treatment program were forced to relocate because of the impacts of HB 1623, they cannot simply move somewhere else and quickly open shop again. Again, that would mean that the hundreds of patients served by those programs would be displaced.

Finally, PSD also notes that HB 1623 would also restrict the issuance and renewals of controlled substances registrations for "substance use disorder services clinics". The term, "substance use disorder services clinics" is not defined in HB 1623. In Hawaii, there are many practitioners who are authorized and specially certified by the federal government to treat substance use disorders. The treatment of substance use disorders does not only involve methadone, and may involve other medications such as buprenorphine, naloxone, and others. Moreover, substance use disorder services is a broad term that also applies to mental health treatment and even treatment in an emergency department. If HB 1623 was meant to also apply to these types of healthcare practices, then PSD respectfully submits that the vulnerability and impacts to these types of healthcare practices would dramatically increase the impacts to patients in need of substance use treatment. Often, these types of substance use disorder services clinics are located in dense commercial office buildings and business areas. If a new child related business were to sprout up next to them and create a "protected area", they would become immediately unstable and vulnerable to HB 1623.

HB 1623 places the very small number of opioid treatment programs under a great deal of vulnerability. Moreover, HB 1623 could broadly apply to an even greater number of substance use services clinics. If a business, especially one of the two current programs was to close, hundreds of patients undergoing closely supervised treatment would be displaced and at risk for overdose and return to addiction. The Department believes that would a catastrophe for Hawaii.

For these reasons, PSD respectfully urges the committee to hold HB 1623. Thank you for the opportunity to provide testimony.

### Hawaii Substance Abuse Coalition Opposes HB1623 as is but offers Amendments:

ALOHA CHAIR, VICE CHAIR AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies.

#### **Recommendation:**

- 1. Remove Substance Use Disorder (SUD) clinics because they don't store or dispense controlled substances:
  - a. SUD clinics cannot prescribe nor dispense Methadone, a Schedule II drug.
  - b. Only Opioid Treatment Program (OTP) can prescribe and distribute methadone.
  - c. SUD do not store, handle, or dispense controlled substances. Clients in residential settings (not outpatient) have some patients who have their own prescription drugs that they self-administer.
  - d. SUD clinics can not prescribe, nor dispense Suboxone, a Schedule III drug, that is a medication treatment for opioids misuse that is prescribed by physicians under a special medication licensure. Suboxone is needed to help people with opioid misuse and has low to moderate physical dependence because it includes both naloxone as well as buprenorphine. Other Schedule III drugs are codeine, hydrocodone with aspirin or hydrocodone with Tylenol and certain barbiturates.
  - e. While very few SUD outpatient clinics have a doctor to prescribe suboxone, none store it because pharmacists dispense suboxone directly to the patient based on a prescription.
  - f. The Federal government, in tangent with the Department of Health, goals are to have every physician office in the state prescribing suboxone or any other new medications that come along. A physician may prescribe, but a pharmacist fills the order from there stores.
  - g. Since community health clinics, mental health clinics, all physician offices can prescribe, there is no need to single out substance use disorder clinics because they have no licensure to store nor provide methadone nor do they do so for suboxone.

### 2. Recommend grandfathering in the two existing Opioid Treatment Programs (OTP) in the state and if problems arise, work with the clinic to resolve problems.

- a. OTP needs a special license from the state and they are the only ones who can prescribe, store and dispense methadone, a Schedule II drug.
- b. There are only two agencies in the state that are OTP: Champ Clinic and Ku Aloha Ola Mau.
- c. The main distribution clinics for the two OTP agencies have been in their location for at least 30 years.
- d. People who come for methadone doses are people who are in recovery or in the pursuit of recovery. Remember that ADA has determined that people in recovery are included in disability definitions.
- e. Keep in mind that people with addiction not in recovery have no restrictions and can go near protected areas. Opioid medication is legal while heroin and most forms of fentanyl are illegal.
- f. OTPs are essential to the community to help mitigate the opioid epidemic. Let's work with them to resolve problems that keep our children safe and still provide recovery opportunities to people with opioid problems.

Dear Chair Yamane, Vice Chair Tam and members of the committee

The Hawaii Health & Harm Reduction Center (HHHRC) respectfully opposes HB 1623 as currently drafted. HHHRC appreciates the intent of the measure and understands the community concerns that accompany treating substance use disorders in certain geographical areas. HHHRC would appreciate the opportunity to be involved in discussion of potential strategies to accomplish the intent of this measure without impacting behavioral health providers ability to deliver services. For example, HHHRC employs a "peer security greeter" that develops relationships with people accessing services to mitigate impact on surrounding offices and services. HHHRC also conducts regular outreach in around the adjacent areas to ensure our participants have not wandered onto others' property and to help reinforce boundaries with visitors to our clinic.

The US Surgeon General has identified stigma as one of the biggest barriers to assessment and treatment of substance use disorder (SUD). Measures such as HB 1623 would not only perpetuate the stigma for those ready, willing and able to access SUD treatment, but will make access more difficult, especially in congested areas that may have no options more than 750 feet away from protected areas.

HHHRC's mission is to reduce harm, promote health, create wellness and fight stigma in Hawaii and the Pacific. We focus our efforts on those disproportionately affected by social determinants of health, including but not limited to: people living with and/or affected by HIV, hepatitis, substance use, and the transgender, LGBQ and the Native Hawaiian communities.

Aloha,

My name is Milton Miyasato, and I work at AOAO Capitol Place. That is a luxury condominium located at 1200 Queen Emma Street. I have been employed here since December of 2019. Throughout my time here I have received numerous anecdotal accounts of incidents and behaviors by clients of the Champ (Methadone) Clinic located in the building next to ours which negatively impacted our residents' lives. Episodes of violent behavior between clients, loitering, trespassing, and even defecating on our grounds were frequent. We also have discovered used syringes in our landscaping and one time in particular, our landscaper had his glove pierced by a needle when he was picking up trash and did not see the syringe until it stabbed his finger. While we do not have conclusive evidence that this needle was left by clients of the clinic, one can surmise that it is a client or at least it is highly probable that it was. At any rate, the location of the clinic does not appear to be the most conducive to providing this, admittedly needed service to these individuals. One of the issues is that it is located right across the street from the Central Middle School and Saint Andrews Priory. Pre-teen students should not have to be exposed to this type of environment where drug addicts receiving maintenance treatment for serious drug addictions are lingering on the sidewalks waiting for their daily dose. It is important to note that this is a maintenance program which means that they are given methadone as an alternative to other opioids. So ultimately, the clients are being administered psychoactive drugs, albeit milder versions but still potentially mind altering.

Ideally a treatment program such as this should be administered in a health care facility like a hospital, but the fiscal realities and controversial treatment modality makes this nearly impossible, so a community-based location is necessary. However, there are still more viable alternative sites to this than the one currently being utilized. A location where there are related programs and services such as shelters, and meal programs that would provide a more comprehensive approach to helping these individuals. A lot of the clients are also homeless or jobless and places such as the Institute for Human Services is in a more industrial location that can support these types of service providers. I understand the current real estate and housing markets are experiencing a robust return for their investments and obtaining a new and reasonable lease rate may be difficult for the clinic, but it is just the reality of our times for all categories of business. I support HB1623 prohibiting the promoting of a controlled substance within 750 feet of a school.

I am writing to express my strongest opposition to HB1623, a bill that casts an incredibly wide net across existing services that do not fall into the proposed categories but will nonetheless impact them, i.e., treatment centers that do not control, administer or dispense controlled substances, proven services that have existed for many decades that have served the community and demonstrated strong success; and, erases the long-standing efforts of non-profits, communities and individuals who have been dedicated to rehabilitation and community reintegration. In short, this bill contradicts many of our more successful legislation that works to decrease—not increase—barriers to treatment, rehabilitation and community reentry.

In 2008, I received a PhD after completing my dissertation about incarceration politics in Hawaii. My work has been recognized locally, nationally and internationally. Prior, I spent 25 years in community and direct services. I continue to engage in various efforts that promote alternatives to incarceration, including rehabilitation and reentry, simply because of the decades of evidence-based data and my own observations that demonstrate much higher success rates than incarceration.

This letter is in reference to Bill 1623. We are in opposition to Bill 1623 for the following reasons. We are a substance abuse clinic, licensed by the state of Hawaii: and we have successfully been in business for the past 28 years and at our current location for the past 24 years. During this time, we have helped over three thousand people with opioid addiction and plan to help many more.

As many of you are aware the opioid epidemic has hit the islands like a tsunami and shows no signs of slowing unless something is done to address the needs of the people afflicted with the disease. Our main goal in providing state approved pharmaceuticals is to help ease individuals out of withdrawal and the cycle of addition and back into society as functioning productive citizens. We have many success stories to corroborate our main purpose which we would be happy to share to those that are interested.

The main reason for our opposition to Bill 1623 is that one of our locations happens to be within a certain distance from a school. We are in open communication with the schools in the vicinity and have abided by their requests. We have a security guard outside the building and monitored security cameras around the building which have been in place for many years. We are in communication with the schools and are in good standing with them.

As stated earlier we are licensed by the state of Hawaii to dispense pharmaceuticals for reduction of harm in relation to opioid addiction. It is our understanding that we are in good standing with the state and licensing bodies to conduct business at our current location. We own and operate this facility successfully and safely and have done so for the past 28 years.

We have invested financially by purchasing the building, so that we can maintain easy and stable access to those in need. Our location is of particular importance because we are within several bus routes which is of significant to people without transportation as well as the handicapped. Our location allows for bus access for the entire island. We are also surrounded by metered parking which allows people easy access to the building.

Whether this law passes or not, it is our belief that we should be grandfathered in and should not be moved due to any changes that may occur due to Bill 1623.

We would like to humbly submit this testimony to the legislative body in light of the current opioid epidemic and our clinics tireless efforts to help ease the pain and suffering caused by opioid addiction.
