Dear Honorable Chair Representative Johanson, Honorable Vice Chair Representative Kitagawa, and Honorable Members of Committee on Consumer Protection & Commerce,

We, the Board of Directors of the Hawaii Acupuncture Association, represent our members and colleagues, as well as our patients and citizens of Hawaii, in testifying today in support of measure HD 1679, HD1.

Regulated medical professions require safety of the public and access to care to be of primary importance. Acupuncture has been one of the fastest growing segments in American healthcare due to increased access for the public via medical insurance and Medicare inclusion, as well as its demand as the primary alternative to opioid prescriptions and other medical conditions. On the following measure: H.B. 1679, H.D. 1, RELATING TO ACUPUNCTURE

Chair Johanson and Members of the Committee:

My name is Risé Doi, and I am the Executive Officer of the Board of Acupuncture (Board). The Board supports this bill.

The purpose of this bill is to make comprehensive updates to Hawaii Revised Statutes chapter 436E, regarding acupuncture practitioners, to reflect modernized scopes of practice, titles, and licensing and renewal requirements, including thirty hours of continuing education per licensing biennium.

The Board supports this measure because it modernizes the statutes to align with the current professional standards and activities provided by licensed acupuncturists.

In consultation with the Department of Commerce and Consumer Affairs' Professional and Vocational Licensing Division (Division), the Board requests the following amendments to section 10 of the bill:

(b) Beginning with the renewal for the licensing biennium commencing July 1, 2025, and every biennial renewal thereafter, all licensees shall be in compliance with continuing education requirements, as approved by the board, by obtaining at least thirty credit hours, which shall include at least two credit hours of ethics and at least two credit hours of safety. The board shall adopt rules relating to the requirements and standards that continuing education programs shall meet to obtain recognition and approval from the board.

(c) To determine compliance with the continuing education requirement under subsection (b), the board may conduct a random audit of licensees continuing education documentation. A licensee selected for audit shall be notified by the board. Within sixty Testimony of the Board of Acupuncture H.B. 1679, H.D. 1 Page 2 of 3

days of notification, the licensee shall provide the board documentation to verify compliance with the continuing education requirements.

(d) Licensees shall hold a current and valid cardiopulmonary resuscitation certification."

The requested amendments will allow the Board to: (1) provide ample notice to affected licensees of the CE requirement and time for licensees to meet the CE requirement prior to license renewal; (2) promulgate rules to define the parameters of the CE courses; and (3) conduct a random audit for compliance of the CE requirement.

Lastly, the Board seeks clarification regarding the amendments in section 9, powers and duties of the board. The Board notes that the additional enumerated language included in numbers (9) and (10) go beyond the typical language associated with this section. The Board believes that numbers (9) and (10) should be addressed in either a new section of the statutory chapter and/or the Board's administrative rules.

If it is the Committee's intent to create a provision to address licensure by reciprocity, then the Board requests that the following amendments be made to the bill:

<u>"§436E-</u> Reciprocity. (a) The board may issue a license by reciprocity to an <u>acupuncturist if:</u>

(1) The applicant:

- (A) Files an application and pays fees as prescribed by the board;
- (B) Holds a current, unencumbered, active license in a U.S. state or territory that requires qualifications equivalent to or greater than the qualifications for licensure in this State as specified in section 436E-A; and
- (C) Hold a current certification with the National Certification Commission for Acupuncture and Oriental Medicine, or its successor entity.

(b) For applicants who graduated prior to September 1, 2000, the board may issue a license by reciprocity to an acupuncturist if:

- (1) The applicant:
 - (A) Files an application and pays fees as prescribed by the board;

Dear Senator Johanson and Senator Kitagawa,

We are members of the American Academy of Medical Acupuncture (AAMA) and representatives of the organization's Legislative Committee. The AAMA opposes HB1679 for the following reasons.

- 1. In Section 4, subsection 1, the definitions of "acupuncture medicine" and "practice of acupuncture medicine" are extremely broad and could encompass any number of medical modalities.
- 2. In Section 4 the definition of "practice of advanced acupuncture medicine" includes "biomedical internal medicine training." To suggest that the time and experience required for the professional practice of internal medicine is commensurate with that required for "acupuncture medicine" is not based in fact.

An internal medicine physician, or internist, must complete 11 years of postsecondary education to become board eligible. The second biennium of medical school alone encompasses 4000 hours of clinical work. This is followed by a minimum of three years of training in an internal medicine residency program. A review of the doctoral program at the Institute of Clinical Acupuncture and Oriental Medicine shows a total of 3450 hours, a fraction of which pertains to the study of internal medicine subjects.

The proposal by the Hawaii Acupuncture Association that a health care provider with an advanced degree in "acupuncture medicine" is equipped to assume the role of an internist is clearly out of sync with the fundamental facts regarding the education, training, and experience of these practitioners. Section 436E-3 is worded such that only licensed acupuncturists or licensed doctors of acupuncture may practice "acupuncture medicine." This usurpation of practice areas to the exclusion of other health care professionals lacks any rational basis and runs contrary to public policy which favors maximal accessibility of health care services for the public.

The AAMA supports the HHH committee's change in Section 4 to the title "doctor" for acupuncture practitioners in place of "physician" in the original bill.

While changes are being made to Hawaii's acupuncture statutes, we request that you repeal Section 436E-3.5 which prohibits physicians and osteopaths from practicing acupuncture unless licensed as LAcs. The majority of US medical boards accept acupuncture within the physician's scope of practice or with the qualification of completion of a 200- or 300-hour program in medical acupuncture. The time has come for Hawaii's unnecessary restriction on physicians to end.

We also recommend the formation of an exploratory committee of members from the Hawaii Acupuncture Association and the Hawaii Medical Association be convened to promote mutual understanding and cooperation between the organizations.

What an inspiring moment in acupuncture's history over thousands of years to be recognized at a legislative level in the US and particularly in Hawaii, with the highest acupuncturists density in the nation. It is both an honor and a challenge. My position on HB 1679 regarding the future status of acupuncturists in Hawaii comes from a deeply dedicated medical experience. Having been born in Taiwan and achieving a medical degree in Italy and licensing in allopathic medicine and acupuncture in the US, I have over 45+ years of cross cultural medical education and clinical and private practice experience in both allopathic medicine and TCM (Traditional Chinese Medicine). I am a physician member of:

- > AMA (American Medical Association)
- > HMA (Hawaii Medical Association)
- > AAMA (American Academy of Medical Acupuncture)
- > HAA (Hawaii Acupuncture Association)
- AcuPlan Hawaii
- > ICAOM Graduate (Institute of Clinical Acupuncture and Oriental Medicine) in Hawaii
- > Associate Clinical Professor, John A Burns School of Medicine, Univ. of HI

I hold great respect for all of these organizations and understand the valid concerns on both sides of the aisle. While there is clear merit in advancing the status of acupuncturists in Hawaii, I chose to offer a neutral commentary based on my observations of the bill's major requests. I reserve a final opinion as I have several concerns regarding the clarity of the semantics of the bill's narrative, that I believe need to be revisited and amended, including, but not limited to:

- Broad-based use of terminology related directly to allopathic medicine, yet, loosely translated to acupuncture without clarification
- Omission of liability requirements mandated to practicing physicians/doctors, such as medical malpractice insurance
- Non-delineation of specific diagnostics, biomedical internal medicine training, advanced acupuncture techniques, etc...
- Lack of designating DAc graduate requirements for establishing title of "acupuncture medicine doctor"

Acupuncture is a major branch of TCM, whose efficacy and safety has an impressive body of evidencebased clinical studies. TCM was endorsed in 2019 by the WHO (World Health Organization) to its 129 member nations as an acknowledged and credible healthcare system. The key point, however, is acupuncture is a branch of TCM, not the entire system. To be recognized as an official doctor of TCM requires extensive training in a multi-faceted educational program. Training in allopathic medicine is equally an intense educational investment of many years with variegated advanced curricula. To compare the training of these two doctoral programs with a certification or master's degree program in acupuncture is inequitable. Assuming the title of a physician or a medical doctor is not a qualification of entitlement. In the history of China, where TCM originated, the rank of officials and professionals was designated by their hat designs for scholars, sages, judges, doctors, etc... In the western countries, an old saying is, "that person wears many hats." Some aspects of this bill appear to be an attempt to assume an elaborate allopathic status hat that may blind the vision of what is truly actual and factual. The question is why is it necessary to redefine an already esteemed healing system such as TCM in allopathic terms? Perhaps, it would be wiser to maintain the traditional identity of TCM, including acupuncture, raise the quality of education and credentialing and increase remuneration of insurance coverage to reflect the adjudicated increased status. It is important to integrate TCM's energetic principles and practices into the allopathic educational system. This way, both retain their individuality and integrity, while learning and progressing from the shared diversity of knowledge.

The legendary symbol in TCM of the Yin/Yang represents the sun and the moon within the same sky; the night and the day, a balanced duality in nature. They remain infinitely connected but unique unto themselves. The systems of TCM and allopathy remain distinctly different in their ideologies and technologies, including the more personalized approach to the individual in TCM as compared to the disease/treatment approach favored in allopathy. They are connected in a common quest for ultimate health and healing, yet, as different as night and day. They have much to learn from each other.

A quote from the Yellow Emperor's Inner Classic from 2500 years ago states: "The law of Yin and Yang is the natural order of the universe, the foundation of all

things, the mother of all changes, the root of life and death." Let us join forces and see better how to blend the law of the universe and the legislature of Hawaii in redefining an effective acupuncture legislation, rather than redefining acupuncture. Time to put the care back into healthcare.

To the Honorable Chair Johanson, Vice Chair Kitagawa, and Committee Members,

My name is Jeffrey Tice, and am a Doctor of Acupuncture in the state of Hawaii (#732). My practice is in Wailuku, Maui where I co-own Longevity Health Center with my wife, Joyce Tamori. I am also vice president of Hawaii Acupuncture Association.

I fully support HB1679 HD 1 to improve the language in the scope of practice for acupuncture medicine in the State of Hawaii and to elevate the licensure requirements for future generations of Licensed Acupuncturists to serve the people safely and effectively.

Acupuncture and associated modalities historically termed Traditional Chinese Medicine or Oriental medicine, is the oldest continuous, documented medicine on the planet, yet also one of the fastest growing today. It has a long history in Asia (4000+ years) yet is relatively new to the rest of the world (100 years). Hawaii was an early adopter of licensing acupuncture in the United States, predating formal accredited schools and national board certifications. Much has changed in the profession over the last four decades and especially in the last twenty plus years since the current statute, 436E was updated.

Acupuncturists licensed to practice in Hawaii practice under two titles, Licensed Acupuncturist (LAc) and Doctor of Acupuncture (DAc). HMA has reviewed the HHH committee report and appreciates the amendment "Changing references from "acupuncture medicine physician" to "acupuncture medicine doctor". However, HMA has continued concerns regarding internal medicine training that is still included in the "Practice of advance acupuncture medicine" definition in Section 4

"Practice of advanced acupuncture medicine" means the practice of acupuncture medicine and the use of advanced diagnostics, specialties, and therapeutics, based on additional traditional and biomedical internal medicine training, as further determined by rules adopted by the board."

An Internal Medicine residency program requires a minimum of three years of intensive training, easily involving 8,000 hours of training, to qualify for the certification examination as an Internal Medicine physician. It is unlikely that training and licensure requirements for acupuncturists, as specified in the proposed amendments, will be satisfactory as equivalent training. The inclusion of the language regarding the use of internal medicine training may have the unintended consequences of exposing the consumer/public to harm and the certified acupuncturist to legal exposure. The ultimate consequence of the proposed comprehensive update may be a decrease access to acupuncture services for consumers.

RECOMMENDATIONS

1. HMA recommends removal of the language in HRS436 E-1, Section 4 regarding internal medicine training.

"...and the use of advanced diagnostics, specialties, and therapeutics, based on additional traditional and biomedical internal medicine training..." so that the proposed language reads:

"Practice of advanced acupuncture medicine" means the practice of acupuncture medicine and the use of advanced diagnostics, specialties, and therapeutics, based on additional traditional and biomedical internal medicine training, as

I am the sole member of Acupuncture and Herbs from China LLC and have been licensed to practice acupuncture in the State of Hawaii since 1993. Prior to 1993, I practiced acupuncture in the People's Republic of China for 7 years. In total, I have been practicing acupuncture for over 36 years. I oppose the changes to Chapter 436E of the Hawaii Revise Statutes, as amended, embodied in HB1679 on the grounds that (1) the proposed changes are draconian and severely excessive and will interfere with the practice of acupuncture and (2) no informed survey and impact study has been conducted to assess the many effects of all such embodied changes to practitioners (like me), patients and administrators of acupuncture. The proposers of HB1679 and the companion Senate bill did not contact me or any the many colleagues whom I have spoken to about this proposal before proceeding to attempt to imposed these problems on acupuncture practitioners, patients and administrations. My colleagues were completely surprised when I told them about this problem, as they had no notice of such proposal. I strongly object to both bills.
