Testimony in <u>OPPOSITION</u> to HB 1682 HD1: RELATING TO THE ISSUANCE OF' SPECIAL PURPOSE REVENUE BONDS TO ASSIST NEXT LEVEL SOLUTIONS GROUP INC.

Aloha Chairs and Committee Members,

As the Executive Director of Zero Waste O'ahu, a local non-profit working to rebuild an equitable and waste-free Hawai'i, I am testifying in **opposition to HB 2399 HD1**, which would approve special purpose revenue bonds to support Next Level Solutions Group, Inc. in pursuing a private industrial enterprise, which is a "waste-to-energy facility" that is purported to to be in the public benefit.

We offer the following comments and basis for opposition:

- 1. The City and County of Honolulu recently completed a 10 year waste management strategy, called the <u>Integrated Solid Waste Management Plan</u>. This strategy prioritizes waste reduction. This measure does not further that priority and is out of step with the priorities of the county and of residents living here. These priorities include:
 - a. *"Reduce per-capita waste generation 25 percent by 2030, from 6.5 pounds per day to 4.9 pounds per day, and*
 - b. Reduce carbon emissions from the waste stream by substantially reducing or eliminating carbon-based single-use plastics and polystyrene from the waste stream going to H-POWER and landfill by 2030." (see Chapter 3: Source Reduction and Reuse for full details).



- 2. As a private endeavor asking for investments via special purpose revenue bonds, the proposed Next Level facility would need to prioritize profit. The profit model for private WTE facilities hinges on receiving waste to process (via burning or other means) and then sell in the form of energy or other outputs. As such, it enables and requires the further production of waste, which is directly at odds with the City and County's stated priorities and not in the interest of the public.
- 3. Waste generation, and industries that encourage or rely on waste generation, are not in the best interest to of the public because:
 - a. <u>42 percent of U.S. greenhouse gas emissions stem from the energy used to produce, process, transport, and dispose of goods and food.</u> This is a big issue as we think about climate change. We need to focus on producing less waste in order to offer public benefit, not producing more of it to turn into fuel (especially considering there are other, better suited, renewable energy technologies).
 - b. Processing waste cannot be done without negative impact to the climate and it poses risks to our water, air, and ecosystems. There is currently no waste management technology that avoids these risks. Therefore, it is critical we focus our resources on creating less waste to manage in order to offer public benefit.
- 4. While the state is not directly funding this project, approval of special purpose revenue bonds indicates the state condones such a project. Approving a project like this for state bonds oversteps the autonomy of the county to create and design their own waste management infrastructure while ignoring the county's stated goals around waste reduction. Creating more waste-to-energy infrastructure will not help us reduce the amount of waste we have to manage, it will likely encourage and exacerbate waste production.
- The preamble to the bill sets a false premise from which to evaluate the merits of the project, in particular the claim in SECTION 1 that "Next Level Solutions Group Inc.'s development of waste-to-energy technology benefits Hawaii by.... (2) Protecting the environment, including by not releasing toxins and other harmful emissions into the

air..." While air emissions are regulated (and if the system was set up well, emissions could be less than H-POWER), it is false to state that no emissions will occur and therefore inaccurate to position it as a potential benefit to the public.

6. Lastly, Next Level indicates that they intend to pursue gasification specifically in their testimony. Meanwhile, the bill refers broadly to "waste-to-energy". At the very least, the bill should explicitly state that bonds will be issued for gasification research and not provide leeway for other waste-to-energy methodologies to be explored.

We would support the issuance of special purpose revenue bonds that would benefit the public by reducing the amount of waste generated *prior* to disposal at waste-to-energy facilities, landfills, or in recycling systems.

For example, if Next Level were to propose building out reuse and refilling infrastructure for local packaging reuse, that would be a tremendous benefit to our community, create clean green jobs, and get us closer to resolving a problem instead of exacerbating it. That is the direction we need to go in and the direction that our County Integrated Solid Waste Management Plan prioritizes as well.

Mahalo the opportunity to weigh in on this measure and for your time and consideration of our comments.

The Climate Protectors Hawai'i is a group focused on reversing the climate crisis and encouraging Hawai'i to lead the world towards a safe and sustainable climate and future. The Climate Protectors Hawai'i **COMMENTS** that this proposal has received almost no scrutiny in hearings and almost no testimony except from representatives of Next Level. **It is not clear whether the project would be in the public interest.**

The project proponents claim that it "will reduce pollutants in the air and land and reduce the amount of waste going into the the landfill in comparison to H-Power, the older incinerator technology currently being used" Reducing the waste entering the landfills is generally good for the environment, especially reducing organic waste that can produce methane, a potent greenhouse gas.

Being better than H-Power doesn't necessarily mean a project is in the public interest.

Gasification of "recycled waste, medical waste and other waste," can put carbon and other greenhouse gases and other pollutants into the atmosphere, which generally can harm the climate, the environment, and even human health. Whether this project will benefit or harm the climate should be determined by a careful lifecycle greenhouse gas analysis.

The Climate Protectors Hawai'i appreciate the Committee's consideration of these concerns.

RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST NEXT LEVEL SOLUTIONS GROUP INC.

The Department of Budget and Finance (the "Department") offers the following comments on House Bill No. 1682, H.D. 1, which authorizes the issuance of Special Purpose Revenue Bonds (SPRB) to assist Next Level Solutions Group Inc., a Hawaii corporation, in the development of a waste-to-energy facility pursuant to Part V, Chapter 39A, Hawaii Revised Statues. The amount of the authorization is unspecified.

The Department would like to inform the Legislature and prospective SPRB

parties that should the legislation be approved, approval of the SPRB issuance and conduit loan will require further review of the financing proposal to ensure compliance with all federal, state and credit underwriting requirements. Additionally, the Department would like to note that House Bill No. 1829, H.D. 2, specifies that the entire allocation of the state bond ceiling cap shall be used for housing related projects for the next six years provided that the allocations authorized, but not issued before July 1, 2022 shall not be affected. An authorization to issue a SPRB does not allocate the state bond ceiling. The allocation of the state bond ceiling is made at the closing of

the bonds. Since the bill specifies that the entire state bond ceiling shall be used for housing related projects, all authorized and not issued SPRBs subject to the bond ceiling cap will be prohibited from issuance by the Department for the next six years regardless of the authorization received prior to July 1, 2022.
