Department's Position:

The Hawaii State Department of Education (Department) supports HB 1699 and offers comments on this measure.

The Department's Community Engagement Branch is responsible for the administration, compliance, and monitoring of quality after-school programs funded through state and federal programs, including the Nita M. Lowey 21st Century Community Learning Centers, After-school Plus, UPLINK, R.E.A.C.H, and Out-of-School Time American Rescue Plan Elementary and Secondary School Emergency Relief programs. The Department agrees the demand for quality after-school programs far exceeds the current supply and the impact of the COVID-19 pandemic has added to the need. Furthermore, quality programs accessible to middle and intermediate students are critical to their development. The additional appropriated funds could be used to expand the existing partnerships, collaboration, and efforts to support Hawaii's youth in the out-of-school time hours to increase access and positive outcomes for Hawaii youth.

The Department is concerned about its capacity to implement such a large-scale increase in the size of the R.E.A.C.H. program given its current staffing and commitments to its other federal and state-funded after-school programs. For example, existing federal funds (i.e. UPLINK) are accessible and prioritized for Title I-designated

middle and intermediate schools. UPLINK currently funds 34 schools across the state and through the Memorandum of Understanding for UPLINK with the Department of Human Services, teh Department has continued to expand the number of schools in the program.

The Department appreciates the appropriation to expand its after-school programs. The Department asks that costs for program administration, implementation, monitoring and compliance, technical assistance, and evaluation also be considered and that any new initiatives do not displace the Department's priority to stabilize and restore funding for positions and basic services that were reduced for Fiscal Year 2023 due to the impact of COVID-19.

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill No. 1699 appropriates \$6,123,398 in general funds for FY 23 for the

Department of Education's Resources for Enrichment, Athletics, Culture, and Health

program to match federal dollars that the State receives for the 21st Century

Community Learning Center.

B&F notes that, with respect to the general fund appropriation in this bill, the

federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

The Hawai'i Afterschool Alliance supports HB1699 to appropriate funds for the Department of Education's Resources for Enrichment, Athletics, Culture, and Health (REACH) program to match federal dollars that the State receives for the 21st Century Community Learning Centers.

Afterschool is an essential part of our communities' response to the coronavirus pandemic, and programs will continue to play a critical role throughout recovery.

For years, afterschool programs have kept kids safe, inspired them to learn, and offered parents peace of mind that their children are constructively engaged in the hours between the end of the school day and when parents return from work.

Yet, in Hawai'i, the America After 3PM 2020 report found that for every child in an afterschool program, 2 are waiting to get in, with 35,067 children alone and unsupervised after school.

Afterschool is Evidence-Based and Proven Effective

Working together, schools, afterschool programs, and community partners are better positioned to accelerate students' academic, social, and emotional learning, especially students who have been historically underserved and those with special needs.

Comprehensive afterschool programs apply evidence based practices to support the needs of youth, families, and communities. Decades of data show these programs:

- Accelerate students' learning gains and improve their reading and math skills
- Engage youth in learning and boost school attendance
- Support social and emotional development
- Prevent youth violence
- Boost on-time graduation

More funding for the REACH program will help to expand comprehensive, high quality afterschool offerings and meet the growing needs of our students and families.

In 2016, the State of Hawai'i requested the Hawai'i Department of Education (HIDOE) to convene a working group to review afterschool programs in Hawai'i's public middle and intermediate schools and make recommendations to the Legislature. The group came to the conclusion that there is an immediate need to increase the funding for out-of-school programs to provide services to all the children and youth that need and/or would like to participate in a program. Out-of-school programs work as a safety net to support students' success by creating a safe environment where they can thrive. The <u>document</u> produced by the group highlighted the importance of focusing on transportation, athletics, and accommodation for students with special needs.

The Hawai'i Afterschool Alliance respectfully urges the passage of this bill so that students have the support they need during the out-of-school time hours. Thank you for the opportunity to testify.

After-School All-Stars Hawaii supports House Bill 1699 which seeks to appropriate funds for the resources for enrichment, athletics, culture, and health program of the department of education.

The weekday, after-school hours of 3 pm to 6 pm are considered the danger hours for youth, where they are three times more likely to engage in violent crime, drug-taking, alcohol consumption and sexual activity. Middle and intermediate-aged youth are especially at risk, as afterschool program opportunities for this age group are not as widely available as elementary and high school-aged youth.

In addition, COVID learning loss needs to be addressed by providing strong support to our charter and public school students, especially the most vulnerable and those who are socio-economically disadvantaged.
