Chair McKelvey and Committee Members:

The League of Women Voters of Hawaii does not support HB 1871 as currently drafted. If it's not appropriate for public employees who administer permits to routinely accept "gifts of aloha" or free meals from permit applicants, then it's not appropriate for legislators to routinely accept "gifts of aloha" or free meals from people who want to influence legislation. State legislators should NOT be exempted from either gift limitations on gift reporting requirements that apply to all other public employees.

### in consideration of HB 1871 **RELATING TO GIFTS.**

Chair McKELVEY, Vice Chair WILDBERGER, and Members of the House Government Reform Committee

Common Cause Hawaii submits testimony in opposition to HB 1871, which excludes from the State Code of Ethics' prohibition against acceptance of gifts by legislators and employees, foreign protocol gifts, gifts of aloha, invitations to certain events, and meals, under certain conditions.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization focused on upholding the core values of our representative democracy through advocating for a government that is ethical, transparent, and accountable to the people of Hawaii and not special interests.

Strong, uncompromising ethics laws should not be watered down with exceptions during these times of corruption in our government. Legislators and government employees – public servants – should not be legally allowed to accept gifts, meals, and invitations to attend events while mingling with special interests to do the people's work. This is not how The People's business should be conducted.

HB 1871 will further undermine The People's faith and trust, the little that is left, in our government and our democracy and, instead, create more opportunity for dishonesty, corruption, and special interests to flourish.

Further, Common Cause Hawaii calls attention to Hawaii Revised Statutes (HRS) § 84-11.5(a)(1) which provides in relevant part that every legislator and employee shall annually file a disclosure with the State Ethics Commission disclosing the legislator or employee, or spouse or dependent child of a legislator or employee's receipt "directly or indirectly from one source any gift or gifts valued singly or in the aggregate in excess of \$200, whether the gift is in the form of money, service, goods, or in any other form". This provision will still be in effect even if HB 1871 is adopted.
