In support of House Bill 1893 RELATING TO CESSPOOL CONVERSIONS

House Bill 1893 amends Act 153, Session Laws of Hawai'i 2022, to increase the cesspool compliance pilot grant project grant amount and update a reference. This bill also appropriates funds for fiscal year 2024-2025 and to establish positions to implement the pilot grant project. The Hawai'i Climate Change Mitigation and Adaptation Commission (Commission) supports this measure.

The Commission consists of a multi-jurisdictional effort between 20 different departments, committees, and counties. Removal of cesspools for all properties within the Sea Level Rise Exposure Area (SLR-XA), is imperative to the health of nearshore waters and for members of the public accessing coastal resources. Removal may not be achievable by 2050 as directed by state law without viable alternatives for replacement. Cesspools on the shoreline and in the coastal zone will be an increasing source of nonpoint source pollution as groundwater rises and coastal erosion accelerates. The Commission's 2022 update to the *Sea Level Rise Vulnerability and Adaptation Report* Recommended Action 6.4 counsels that the State should expand policy directives beyond the existing income tax credits and requirement for removal by 2050. Accelerating the conversion of cesspools of any kind would ensure a more resilient future and safer reefs and waters for kama'āina and visitors alike.

HB 1893 - RELATING TO CESSPOOL CONVERSIONS

Chairs Lowen and Ichiyama, Vice Chairs Cochran and Poepoe, and Members of the Committees:

The University of Hawai'i Sea Grant College Program and UH Water Resources Research Center **support HB 1893**.

The Cesspool Conversion Working Group reported that the vast majority of cesspool owners cannot afford the upgrade of their cesspool to an advanced form of wastewater treatment. Because it is critical to both human and environmental health that the state's cesspools be eliminated as soon as possible, it is important that a multitude of mechanisms for financial assistance be created for homeowners. This bill would increase the grant funding amount for cesspool conversions by \$10,000 and would provide salary support for two positions that would support cesspool conversion work in the state. Both of these measures will improve the efficiency and effectiveness of the current cesspool conversion program.

We recommend that the reference to the year on Page 2, Line 17 be updated to instead say "in the University of Hawai'i's most up to date cesspool hazard assessment and prioritization tool".

Aloha Chairs Lowen and Ichiyama, Vice Chairs Cochran and Poepoe, and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) supports this bill which 1) amends Act 153, Session Laws of Hawaii 2022, to increase the cesspool compliance pilot grant project grant amount and update a reference; and 2) appropriates funds for fiscal year 2024-2025 to establish positions to implement the pilot grant project.

Approximately 2,500 cesspools exist on Hawaiian Home Lands. The proposed increase for the cesspool compliance grant amount, from \$20,000 to \$30,000, and the proposed update to a reference to the University of Hawaii's Hawaii cesspool hazard assessment and prioritization tool, will allow for fully comprehensive data and new technology demonstrations that may include the islands of Moloka'i, Lana'i, and Ni'ihau.

DHHL understands that there are approximately 88,000 cesspools statewide that will require cesspool conversion approvals. DHHL supports the appropriation of funds for FTE positions within the Department of Health's Wastewater Branch to support the approval of individual wastewater systems applications, due to the administrative demand that this legislative requirement places on DOH for the 88,000 cesspools statewide. DHHL is also aware that the State currently has a shortage of licensed engineers to execute the design plans and final construction inspections required by Act 125 (SLH 2017).

Aloha Chair, Vice Chair, and members of the committee,

Hulu Mamo Hawaiian Civic Club stands in support of HB1893.

Hulu Mamo Hawaiian Civic Club appreciates this grant program and the fact that this allows DHHL lessees, especially those with a household income of less than 140% AMI, helping those that really need the funds to have be able to convert their cesspools into something more environmentally friendly.

We do also want to note that while this grant program does help those in need, it still misses one critical component, those who can't afford to cover the initial costs of the cesspool conversion and wait to be reimbursed. Many in Hawaii are living paycheck-to-paycheck and are not able to cover an extra \$20,000-\$30,000 in expenses and still have money to put food on the table, especially a family below 140% of AMI.

Hulu Mamo HCC suggests an amendment to allow the program to provide a qualifying note that can be provided to the contractor to show that the applicant qualifies for the grant, and that note can be used by the engineer and contractors to execute on the work and receive payment via the grant when the work is completed. This would allow someone without the means to pay for the cost of the work upfront to get the conversion work done.

This idea is supported by the Association of Hawaiian Civic Clubs and would help many families convert their cesspool, even though they don't have the means to do so by utilizing the grant funds.

Attached is the resolution supporting this idea, passed by the Association of Hawaiian Civic Clubs on October 21, 2023 at their annual convention in Kālia, Waikīkī, Oʻahu.

URGING THE STATE OF HAWAI'I TO CREATE A GRANT PROGRAM THAT WORKS DIRECTLY WITH CESSPOOL CONVERSION CONTRACTORS TO HELP COVER THE COST OF THE REQUIRED CESSPOOL CONVERSIONS UPFRONT FOR THOSE IN POVERTY IN RURAL COMMUNITIES

WHEREAS, the health of Hawai'i's people and quality of Hawai'i's waters are being harmed by pollution from cesspools, in which Hawai'i has more than 80,000 that discharge approximately 50 million gallons of wastewater every day; and

WHEREAS, cesspools are antiquated substandard systems that damage public health pollute drinking water and lower quality water quality in streams, groundwater, nearshore marine areas, and the ocean, where cesspool pollution also harms public recreation and the precious coral reefs on Hawai'i's shoreline, fisheries, and native species; and

WHEREAS, an article from The Maui News from July 2023 stated that 20% of Hawaii's cesspools are less than 0.6 miles from the shoreline, which is threatened by increasing sea level rise and could cause bacteria from cesspools to enter into the ocean; and

WHEREAS, in 2017, the Hawai'i State Legislature required that all cesspools be upgraded to a septic system or aerobic treatment unit are connected to a sewage system by 2050 and directed the State of Hawai'i Department of Health to develop a system to prioritize the upgrade conversion or connection of cesspools based on their impact on public health; and

WHEREAS, there are approximately 83,000 cesspools across the state, many located in rural areas where county sewage lines do not reach properties; and

WHEREAS, according to the Economic Research Service data in 2020, poverty in rural areas of Hawaii where cesspools are more prevalent are much higher than in urban areas of the state where access to county sewage lines are more available (11.6% vs. 8.2%); and

WHEREAS, according to an Anthology Research survey conducted between July and Sept 2022, there was a sharp increase in the number of households pushed below the poverty line (15% in 2022 vs. 9% in 2018); and

WHEREAS, in 2019, the U.S. Census Bureau reported that 14.8% of Native Hawaiians/Pacific Islanders were living at the poverty level; and

WHEREAS, cesspool conversions can cost \$20,000 to \$50,000 per property, depending on the property and other factors; and

WHEREAS, the high cost of living in Hawai'i has already driven many Native Hawaiians to leave Hawai'i, and the cost of a required cesspool conversion could force a family to move from Hawai'i to the continent due to the high costs; and

WHEREAS, in March 2023, the State offered \$5 million in grants of up to \$20,000 in reimbursements to help property owners convert their cesspools, which ran out in two weeks; and

WHEREAS, reimbursements and tax refund programs are beneficial to those who can afford to pay for the cesspool remediation work upfront and be reimbursed after the work is completed; and

WHEREAS, the creation of a grant program that works directly between the state and cesspool conversion contractors, to help cover the costs of the work to convert a cesspool before the work is done, for those in poverty that need it most, would be beneficial to many Native Hawaiian families in rural communities.

NOW, THEREFORE, BE IT RESOLVED, by the Association of Hawaiian Civic Clubs at its 64th Annual Convention in Kālia, Waikīkī, O'ahu, in the malama of 'Ikuā and the rising of 'Olekūkolu, this 21st day of October 2023, urging the State of Hawai'i to create a grant program that works directly with cesspool conversion contractors to help cover the cost of the required cesspool conversions upfront for those in poverty in rural communities; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be transmitted to the Governor of the State of Hawai'i, President of the State Senate, Speaker of the State House of Representatives, Chair of the State Senate subject matter committee on Hawaiian Affairs, Chair of the State House subject matter committee on Hawaiian Affairs, Chair of the Board of Trustees of the Office of Hawaiian Affairs, and all County Mayors.

Aloha Chairs Lowen and Ichiyama, Vice Chairs Cochran and Poepoe, and Members of the Committees on Energy and Environmental Protection and Water and Land:

The Hawai'i Reef and Ocean Coalition (HIROC) is a group of scientists, educators, filmmakers and environmental advocates who have been working since 2017 to protect Hawaii's coral reefs and ocean. Hawai'i has over 80,000 cesspools that discharge about 50 million gallons of raw sewage into our groundwater every day! HIROC is deeply concerned about the impact the state's cesspools have on Hawaii's marine life, especially coral reefs.

The Hawai'i Reef and Ocean Coalition STRONGLY SUPPORTS HB1893!

This bill is needed now because pollution from cesspools is harming the public health, the quality of Hawaii's waters and marine life, including especially coral reefs, and the State's reputation for pristine waters. Financial assistance is needed to assist homeowners in upgrading their cesspools.

Under Act 153, Session Laws of Hawaii 2022, there has been a pilot cesspool compliance project to assist property owners, including lessees on Hawaiian Homelands, with upgrading, converting, or connecting a cesspool. Grants have been up to \$20,000, available on a first-come, first-served basis to assist low-moderate income homeowners with the costs of converting a cesspool in a Priority 1 or 2 area.

This bill would increase the grant maximum amount to \$30,000, appropriate funds for fiscal year 2024-2025, and establish positions to implement the project.

This bill's changes are needed given that 1) average costs of cesspool conversions are around \$30,000, 2) funding for grants is needed in the coming fiscal year, and 3) the Department of Health needs staffing to implement the project. This bill's funding for DOH staffing appears to overlap somewhat with HB1898. Part III of HB1892 also appropriates funds for grants, but not the two DOH staff positions.

This bill provides some badly needed assistance in grants for low and moderate income owners to upgrade their cesspools.

The <u>Public Access to SunScreens</u> (PASS) Coalition is a multi-stakeholder coalition composed of public health groups, dermatologists, sunscreen manufacturers, and leading advocates for skin cancer patients. We also support efforts that protect our coral reefs.

We support this measure.

Cesspools are a pressing issue in Hawaii that impacts our health, water quality, and coral reefs. With over 83,000 cesspools in the state, discharging about 50 million gallons of raw sewage every day, immediate action is needed to mitigate their negative impact. Untreated wastewater leaking from cesspools into nearshore waters can cause high levels of nitrogen in the water, which leads to algae blooms that suffocate and cover our coral reefs.

HB 1893 will increase the cesspool compliance grant amount, establishes two full-time staff positions at the Department of Health, and appropriates funds necessary to implement the Cesspool Compliance Pilot Grant Program. All these things are necessary steps to make cesspool conversions more feasible for local families.

Aloha Chair Lowen, Chair Ichiyama, and Members of the Joint Committees:

My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS[®] ("HAR"), the voice of real estate in Hawai'i and its over 11,000 members. HAR **supports** House Bill 1893, which amends Act 153, Session Laws of Hawaii 2022, to increase the cesspool compliance pilot grant project grant amount and update a reference. Appropriates funds for fiscal year 2024-2025 and to establish positions to implement the pilot grant project.

Hawai'i Association of REALTORS[®] supports the goal of protecting our drinking water, streams, ground water, and ocean resources. We recognize that cesspool conversion is important to preserve our environment. There are approximately 83,000 cesspools divided into three priorities¹ across the State and to convert 83,000 cesspools by 2050, at least 3,192 cesspools would need to be converted per year. It is crucial that we properly plan and find ways to assist communities and homeowners as resources and manpower are limited, especially on the neighbor islands. Costs will vary greatly depending on resources, labor, permitting delays, property terrain, and other variables.

In 2022, the Legislature passed Act 153 to offer rebates of up to \$20,000 to help homeowners with the costs of conversion. Demand was so great that that \$5 million in grants ran out in just two weeks.² With the high demand of Act 153, HAR supports reestablishing the pilot grant project to help homeowners who are unable to afford to convert without assistance.

In Strong Support of **HB1893** Relating to Cesspool Conversion House Committees on Energy & Environmental Protection (EEP) and Water & Land (WAL) Hearing on Feb. 13, 9:05am, Rm. 325

Aloha, Chairs Lowen & Ichiyama, Vice-Chairs Cochran & Poepoe, and Committee Members:

On behalf of the non-profit WAI: Wastewater Alternatives & Innovations and the Cesspool Legislative Task Force, I am writing in **strong support of HB1893.** This bill would extend the successful pilot program under Act 153 and increase the grant amount from \$20,000 to \$30,000 to help cover the costs of cesspool conversions for low-moderate income households in Priority Areas 1 & 2 across the state that are polluting nearshore waters and killing coral reefs. The bill would also provide funding to DOH to hire 2 FTE positions to help manage the pilot program.

Under Act 125 (2017), all cesspools are mandated to be converted by 2050. To facilitate these cesspool conversions, this bill would provide needed funding for homeowners who couldn't otherwise afford to do so. The pilot grant program created under Act 153 (2022) was so successful that the \$5 million in funding was exhausted in three days! As an amendment, I would suggest the amount of funding be expanded to at least \$10-\$20 million to help more homeowners convert their cesspools. We need to increase the rate of conversions by 10x in order to achieve the mandate under Act 153, and this kind of proven grant program is the best way to do that.

Hawaii has more than 83,000 cesspools across the state, discharging 52 million gallons of raw sewage each day into Hawaii's waters. That's similar to a massive sewage spill every day! Along with threats to public health and drinking water resources, new research in *Nature* shows that this polluted wastewater poses significant harm to coral reefs and the near-shore environment (see also <u>my article in Hawaii Business Magazine</u>). The people of Hawaii need this law to make sure their wastewater systems aren't polluting the groundwater or nearby surface waters.

WAI is an environmental non-profit dedicated to protecting our drinking water, groundwater and near-shore ecosystems by reducing sewage pollution from cesspools and failing septic systems. Our goal is to help find more innovative, affordable, and eco-friendly solutions to wastewater management and help homeowners with the conversion process. Better sanitation systems reduce sewage and nutrient pollution and make properties more valuable, while also protecting public health and valuable natural resources like groundwater, streams, coral reefs and coastal areas.

Hawaii is struggling with serious sewage pollution problems, and the state has a mandate to make sure all cesspools are converted in the next three decades. This bill will provide the necessary funding and staffing at DOH that is needed to convert cesspools across the state. Mahalo for your leadership on this issue and support of this bill.
