1 **Fiscal Implications:** Funding estimated at \$100,000 would be needed for the Department of

2 Health to implement this measure including, medical records system changes, training and data

3 analysis and reporting. The Department requests that passage of any appropriations in this

4 measure does not replace or adversely impact priorities indicated in the Department's

5 supplemental budget request.

6 **Department Testimony:** The Department of Health supports the intent of H.B. 1903 H.D. 1

7 that requires first responders to record in the incident report for each water rescue event the type

8 of snorkel and mask, if any, worn by the person who was rescued or recovered. The Department

9 is providing comments in regard to emergency medical services only.

10 Every year an average of 66 Hawaii residents and visitors experience snorkel related drowning

11 events. Approximately twenty are fatal. Understanding snorkel use can lead to better public

12 health messaging and improvements in snorkel design.

13 For data to be collected, analyzed, and reported, changes need to be made to our existing pre-

14 hospital emergency medical services (EMS) record system to collect the additional data.

15 Providing EMS personnel a convenient way to document in the pre-hospital medical record is

16 preferred.

Aloha Senator Nishihara and Senator DeCoite,

My name is Julie Urbon. I'm reaching out to strongly urge you to pass HB1903.

HB1903 would require first responders to document what snorkel equipment is used during snorkeling rescue and recovery incidents. This information is not currently collected in a consistent or standardized manner which prohibits the Dept. of Health from understanding the true risks of full-face snorkel masks.

This bill was introduced in honor of David Loasby, who died while using a full-face snorkel mask in December 2021. I was there with his family just before the incident occurred. I see daily the pain this has caused his family. Not just that he lost his life, but the anger knowing it very well could have been prevented. Since the tragedy, we have found that it is known through studies on these masks that carbon dioxide can build up inside the mask and can render the user unconscious. But apparently no one is willing to definitively say that there is a direct link to increased drowning because sometimes the information collected is not complete. <u>This seems like such a basic request...</u> when a snorkeler dies, document what type of equipment the victim was using. Collecting this data will more clearly bring into focus the risk to both visitors and locals. A study can only go so far. The study show that there are concerns. The most critical data unfortunately is collected after the fact. So, it's essential that this information be thoroughly documented.

I strongly support HB1903 because it would allow the Dept. of Health to collect reliable data, determine whether or not full-face snorkel masks contribute to the number of snorkeling drownings in Hawaii, and take action on their findings. If there is a link, we should be informing the locals as well as tourists of the hazards of those masks. Many tourists who come to the islands only snorkel a few times a year and don't know a great deal about the differences in the masks that are sold. There are snorkel tours on Maui that ban those masks on their boats. Why would they do that if they didn't see the connection? They are the ones most familiar with the equipment. And yet the masks are sold widely. A beautiful vacation turned into a horrific nightmare because "not enough information is there to conclude those masks are dangerous"? Then we need to collect the information! It's simply one more question for first responders to ask to be more thorough. I think it sends a horrible message if the state is unwilling to take a simple step to protect locals and the tourism industry.

Please consider voting in favor of this bill as it is the critical next step in reducing the rates of drownings and aquatic injuries.
