Aloha from Lana'i,

Our organization serves a small community directly affected by the fires in Lahaina.

After the fires, many on Lana'i lost friends and family, with several families returning to Lana'i as they had lost everything in the fire. With family and friends concerned about the missing, and some family members still in burn units, not just here in Hawaii, but a few were also sent to the mainland as their burns were also complicated by other health issues which arose from their injuries, emotions still run high as their concerns increased.

The Lana'i Arts & Culture Center (LAC) has been an entity for over 30 years, and our instructors are well versed in their skills. LAC has programs which are of value to our community as we strive to promote the visual arts, and address some of the trauma our community is experiencing.

Art plays a significant role in supporting individuals recovering from trauma. Trauma can leave individuals with emotional wounds, and art provides a way to communicate experiences when they are unable to verbally express them. By becoming active creators, people regain the freedom and joy of creative self-expression, bringing them into the now as they pour their emotions into art. (Kaimal, 2020)

While we are an Art Center, we are here to address whatever needs our community requires. Whether it be supplies, space or instruction, we are here to ensure that the needs of our community are met. We have a variety of art forms which include ceramics, textiles, glass, painting, and woodworking with knowledgeable instructors.

Aloha Chair Tam, Vice Chair Martinez, and members of the House Committee on Culture, Arts, & International Affairs.

We write in strong support of HB1939 which appropriates funds to the State Foundation on Culture and the Arts to provide greater access to the arts for children and communities in need. Mental Health America of Hawai`i (MHAH), an affiliate of the renowned national organization, is a highly regarded 501(c)(3) non-profit organization serving the State of Hawai`i. For nearly 80 years, MHAH has been fulfilling its mission "to promote mental health & wellness through education, advocacy, service, and access to care" through its vision of 'mental wellness for all.' We endeavor to reduce the shame and stigma of mental illness and improve the overall care, treatment, and empowerment of those with or at risk for mental health challenges across all stages of life in Hawai`i.

Research has proven the significant impact on improving mental health, wellness, and resilience, and is often used as a type of therapy in clinical mental health interventions. Increasing access to the arts can play a critical role in the ongoing healing of youth in Hawaii. This is particularly critical considering the youth mental health crisis and the ongoing trauma resulting from the Maui fires. Youth are especially impacted by disasters of this scale with the most manifested conditions being trauma, depression, anxiety, and substance use, with further impact trickling down from those who take care of them. In addition to the impacts of the fire, youth were already, and continue to be, severely impacted by the pandemic, with the CDC noting that COVID-19 created traumatic stressors for youth mental wellbeing. Evidence has demonstrated that there is a critical need for mental health and resilience education and suicide prevention programs for all youth, including artbased interventions. Late last year, the SAMHSA released its National Guidelines for Child and Youth Behavioral Health Crisis Care to express the need to improve prevention efforts and crisis response for children and youth. Earlier that same year, the US Surgeon General declared a youth mental health crisis in the U.S. According to the Hawaii Department of Health's Injury Prevention and Control Sections EMS & Injury Prevention System Branch, death by suicide was the second leading cause of fatal injuries in Hawai'i between 2016 and 2020. During the same period, suicide was the 4th leading cause of fatal injury for those 0 – 15 years of age, and the 1st leading cause for those between the ages of 16 and 29.

I am Beth-Ann Kozlovich, Executive Director of the Hawaii Arts Alliance. We are grateful for the opportunity to submit testimony in great **SUPPORT** of this bill.

The important link between self-expression through the arts and mental health has been well-documented. In September 2023, the World Health Organization announced it would build on its 2019 report with a new research series to further show the healing power of the arts.

The 2019 report presented evidence of the function of the arts in promoting improved health and well-being. For all Hawaii's people, especially children and those who continue to feel the impact of the Maui wildfires and other traumas, mental health healing through the arts is vital.

The Hawaii Arts Alliance has had its own stories of the healing power of the arts. For example, last week, one of our dance teaching artists on Maui shared that on the first day of her residency at a Kihei Elementary School, a little girl was sobbing uncontrollably. A little boy came up to the dance teacher and whispered "She's a Lahaina girl." The dance teacher sprung into action and applied the techniques she knew to work with trauma, dimming the lights, and having all students slowly stretch and move to peaceful music. We hear from the dance teacher that the little Lahaina fire survivor is thriving in the school and is one of the teacher's best dancers.

Community health is based on the duality of good physical and mental health. Mental health healing through the arts can provide a much-needed bridge to a healthier future for those suffering from trauma, and by extension, to a healthier community for all when grounded in well-being through the arts.

I strongly support HB 1939 that would add funding for SFCA's Arts programs particularly for Healing. In 2022, nonprofit arts and culture organizations and their audiences generated \$151.7 billion in economic activity—\$73.3 billion in spending by the organizations, which leveraged an additional \$78.4 billion in event-related spending by their audiences. The impact of this economic activity is far reaching, supporting 2.6 million jobs, generating \$29.1 billion in tax revenue, and providing \$101 billion in personal income to residents. AEP6 (the authoritative Arts and Economic Prosperity Study - https://www.americansforthearts.org/by-program/reports-and-data/research-studies-publications/arts-economic and community well-being.

However the Arts are essential in more profound ways than the material, economic, and bureaucratic. Imagination and creativity are uniquely human traits. Through our senses we experience colors, forms, sounds, and motion. We transform these objects of the senses into powerful, emotional, intellectual and healthily creative works. Such activity humanizes us and distinguishes us from the rest of the animal world. Such artistic activity enlivens our spirits and nourishes our soul with its beauty and freedom.

Art has always needed outside support: state, church, aristocratic, foundation, corporate, philanthropic, etc. If a market economy could alone sustain Art, then famous artists such as Dutch painter Vincent Van Gogh, German composer Franz Schubert and American author Herman Melville would have been rich men. But they made little money from their art during their lifetimes.

Art is a survival tool. There are countless stories of survivors from the Holocaust and other disasters who attended concerts or viewed exhibits, or heard a poetry reading that allowed them to enter the realm of Spirit and transcend the horrors of their subjugation. They survived because of Art. We must place the enlivenment of our spirits and nourishment of our souls as high a priority as the necessary sustenance of our bodies. Body is a function of Spirit. For those that are supporters of bill — and believe we have enough art I ask for you to please reconsider this very drastic cut of funds. After all the funding of the SFCA is what:

1. Kept alive the downtown triangle of Downtown Art Center, Mark's garage and Hawaii State Art Museum/Capitol Modern during the two years that CoVid shuttered many of our local businesses. This funding brought people to this area and kept this business district going. It is because of the arts and the art exhibitions which the SFCA supports that restaurants like Fete and Rangoon saw customers fill their 6' separated tables and outdoor spaces. In addition, why Murphy's and others opened a take out window and continued to keep their restaurants open and sustained. People came to their offices in a limited fashion downtown because these places were open and this triangle was a relatively safe place to walk, dine and take in a bit of creativity to maintain their mental health.

Our downtown Honolulu would not look the way it does with new businesses and established ones now being sustained. The monetary return dollar for dollar of funding from the SFCA far exceeded what is typically achieved. Our city is now thriving with residents who discovered what art can do during CoVid and tourists who now seek out these art places when they come to Hawai'i.

2. Gave students at Hawai'i's public schools a spark of creativity so they could see a new and different way of doing or being. As a two-time commissioned Art-in Public Places/Doe Artist, I has the privilege of working with students who were not achieving their best at an elementary school on Oahu. Many of these students spent time in detention and one even told me at the beginning of our project that they were not allowed to be in the same class with another student. At the end of our project, these students were working diligently together to meet our deadline when their artwork would be honored at the dedication for their artwork and mine. A couple of the students also had failing grades or were outcasts. Because of the opportunity to participate in the project to make a permanent sculpture outside the library, these students became empowered as all the other students wanted to be doing what they were doing. As a result of this empowerment, several of the students achieved A's, while others created bonds with their so-called enemies, other students and even their parents when they came to

help. Another who could barely be heard when answering a question, spoke commandingly into the microphone at the dedication. These students became creatives and this experience led them into future success in life. Their artwork became permanently installed near the one I completed for the SFCA and both serve as a reminder of what is possible when creativity and the arts are supported. They are now grown and contributing to our community. A few even continue to bring their friends back to show them what they accomplished in elementary school. Hope and better way of being is what they are now sharing.

3. Creates a circular economy. The SFCA funding does purchase artworks directly from artists showing at arts centers and galleries. This is a double circular economy as the money circulates through these two economic drivers. An artist's 50+ percent of the purchase will go to buy food, gas, rent and art supplies at art, craft and hardware stores. The 50% or less the art center/organization gets goes to support employees, insurance, rent, web/social media folks and many more. The arts are the one economy that keeps the money flowing and flowing again, just as I wrote about in my children's book, "I Had A Dollar In Hawai'i. It's easy math that continues to benefit each island and our state.

4. Rather than taking away how about creating a pause bill for a 5-year period that will prevent our arts industry funding from being under attack so we can find creative solutions to our state's issues. Use the funds to pay artists for their creative solutions to collaborate with other groups. Don't like homeless people on our streets? Team up artists with social workers and police to get these trauma-ridden people to make art. Imagine what their sketchbooks would look like. How filling that I interrupted my letter writing to you to take a houseless student to school as his mother and he are living in my home. On my way home, I saw 5 police men standing 8 feet away from a houseless woman who had her shorts around her knees and had defecated all over her buttocks. Why did I see this? It was the most pathetic scene I have ever witnessed. The group had their backs turned away to give her whatever dignity they could though no one was helping her on with her pants. Perhaps this happened so I can write to you about it now and offer a suggestion such as the police need to be fitted with a sheet to give such traumatized people some dignity first. Then housing and all the other services it takes to unwind such traumatic situations. Fortunately the EMS arrived a short time later and then all were trying to help her. I drove by on may way back to offer a sheet I carry in my car to move and protect my art. I was going to park and shield her from people and children who were also driving by. Yes, art can help heal. It softens the edges and reminds us how to c are. And it is even good for people who are not on the street. It is good for business. It is good for new ways of thinking, innovation and finding new ways of doing.

I found the courage to become an artist after visiting our museum. I quit my job and went back to study art and received my Masters in Sculpture from UH. I paid tuition, won awards and commissions and then created public art that brings people together. That is what this SFCA

funding that everyone wants to cut is good for. There is so much more we have to share. Let's work together and find ways to pair up SFCA funded creatives to solve our social problems. Imagine if we could lessen homelessness as Finland has done, slowed water rising and prevent the impact of climate change. I invite you and whoever else wants tour our city with me and city and SFCA folks to see and experience the art around the capitol and our arts district to learn why we have what we have and what it does for us. And what we could achieve if we used our imagination. We could make Hawaii a leader again. Just as we did when the 1% was passed and the nation followed. Please oppose HB 1807 as I do.
