## In consideration of HOUSE BILL 1955 RELATING TO THE SPECIAL LAND AND DEVELOPMENT FUND

House Bill 1955 proposes to authorize the use of special land and development fund moneys to eradicate or mitigate invasive species and install and maintain safety improvements on improved lands that provide lease revenue to the Department of Land and Natural Resources (Department) and that have significant cultural or historic value. The measure also proposes to appropriate moneys out of the special land and development fund (SLDF). **The Department opposes this measure.** 

This measure effectively provides for the use of public funds for the benefit of private entities, specifically lessees of State land. Pursuant to the standard terms and conditions of the State's standard form lease, the lessee is required to maintain the leased premises and improvements. Using SLDF moneys to mitigate invasive species and install and maintain safety improvements inappropriately alleviates an obligation that should be placed on the private lessee. Currently, the lease form does not explicitly require invasive species removal or mitigation. Therefore, as an alternative to legislation, the Department proposes to work with the Land Board on adding a provision on invasive species removal or mitigation in leases and revocable permits going forward.

Additionally, the Department supports greater recurring funding for the Hawai'i Invasive Species Council (HISC) and other related programs under the Division of Forestry and Wildlife, who can work with partner stakeholders in supporting projects for invasive species management on non-
