The Department of the Attorney General provides the following technical comment on this bill.

The purpose of this bill is to establish and appropriate moneys for temporary positions to support the Office of Planning and Sustainable Development's activities as the designated Hawaii Economic Development District Planning Organization.

In section 1 of this bill on page 3, lines 11-12, there is a reference to "title 13, section 304," of the Code of Federal Regulations. The correct term, however, is "part," not "section." We recommend making the following correction: "pursuant to title 13, [section] part 304, Code of Federal Regulations."

### in consideration of HB 1960 RELATING TO AN ECONOMIC DEVELOPMENT DISTRICT PLANNING ORGANIZATION

Chair Holt, Vice Chair Lamosao, and Members of the House Committee on Economic Development:

The Office of Planning and Sustainable Development (OPSD) **strongly supports** HB 1960, which establishes four full-time equivalent (4.0 FTE) positions and appropriates funds for OPSD's role as planning organization for a statewide Economic Development District (EDD), subject to designation by the U.S. Economic Development Administration (EDA). Designation of a statewide EDD for Hawai'i is currently under EDA review.

The establishment of a statewide EDD is a key objective identified in the 2023 Hawai'i State Comprehensive Economic Development Strategy (CEDS), a critical document to unlock access to federal funding under the EDA's Public Works and Economic Adjustment Assistance programs. Importantly, an EDD designation will further increase project eligibility and access to EDA funds, which is especially important for supporting long-term economic recovery from recent disasters—such as the devastating wildfires and COVID-19 pandemic.

The positions and funding proposed in this measure are essential to secure EDA designation as an EDD, which requires adequate professional staffing to carry out the duties of an EDD planning organization under 13 CFR §304. Such a designation will maximize Hawai'i's access to federal resources for economic development.

The Office of Economic Revitalization (OER) **strongly supports** HB1960, which establishes positions and appropriates funds for DBEDT's Office of Planning & Sustainable Development (OPSD) to become the planning organization for a statewide Economic Development District (EDD).

OER eagerly anticipates the establishment of a statewide Economic Development District to increase the eligibility of the City and County of Honolulu's grant applications to the U.S. Economic Development Administration (EDA). A statewide EDD designation will also provide the capacity for continuous engagement and coordination between the State and counties to individually and collectively advance projects toward Hawai'i's shared economic future.

OER has reviewed the EDD application and expressed support to the U.S. EDA for the expeditious consideration of OPSD's request submitted last year. In its review, the U.S. EDA will consider whether OPSD has the necessary staff capacity to carry out the planning duties for an effective EDD. Your support is needed to ensure a favorable decision, thus enhancing economic development cooperation capabilities and more funding opportunities from the federal government.

#### RE: HB1960 Relating to an Economic Development District Planning Organization

Chair Holt, Vice Chair Lamosao, and Members of the Committee:

The Chamber of Commerce Hawaii ("The Chamber") **supports HB1960**, which establishes 4 full-time equivalent (4.0 FTE) positions, appropriates moneys, and declares that the appropriation exceeds the state general fund expenditure ceiling for 2024-2025.

This measure will help to significantly increase the chances of our state receiving the Economic Development District (EDD) Designation from the U.S. Economic Development Administration, a designation which would provide support in areas our state sorely needs. There is much value to having an EDD Designation, critically because 80% of EDA's grant funding goes to areas with an EDD. EDA funding can be applied to expedite Maui's economic recovery.

Moreover, EDD receive annual funding from EDA to support the development and implementation of the updated Comprehensive Economic Development Strategy (CEDS), which was recently updated to include the pillars of Equity; Climate Resilience; Workforce Development; and Broadband, with the goal of achieving more economic development implementation projects focused on bolstering these key areas. The Designation helps to establish a long-term partnership with EDA, preventing "one-and-done" funding. To further emphasize the importance of the designation, areas with the designation were reported to recover more quickly from COVID-19 than areas that did not have this designation (Argonne National Laboratory, initial Effective Framework Analysis, 2022).

Furthermore, there are higher levels of EDA investment inside of EDD areas per capita than areas outside of EDDs. Between 2010 and 2019, more than 78 percent of EDA grants and 73 percent of total project investment went to areas covered by an EDD, while only 52 percent of the population live in areas with an EDD. Per capita, the number of EDA grants and amount of total project cost invested in EDD areas is more than three times the number of grants and investments outside of EDD areas. (Urban Institute, upcoming EDA Geography Brief, 2023).

As it stands, missing the opportunity for this designation would exacerbate Hawaii's underrepresentation on the federal stage and inhibit the state from being eligible to receive available federal funds. The Chamber encourages the committee to consider examples of how other regions have leveraged EDDs to their advantage to benefit their communities and recommends <u>NADO's</u> website, where a collection of EDD case studies are held, as a place to start.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 2,000+ businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members



and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.
