SUBJECT: HB2003 RELATING TO MENSTRUAL PRODUCTS

The Hawaii State Council on Developmental Disabilities **STRONGLY SUPPORTS HB2003**, which requires the Department of Accounting and General Services to provide menstrual products at no cost in specified restrooms in public buildings maintained by the department. Appropriates moneys. Declares that the appropriation exceeds the state general fund expenditure ceiling for 2024-2025.

Currently, individuals with I/DD residing in licensed or certified homes receive a fixed \$50 monthly personal allowance for incidental expenditures. This allowance, established in 2007, is intended to cover various needs such as telephone expenses, hobbies, prescription drugs, haircuts, clothing, and other incidental items. However, it has become increasingly apparent that essential items like menstrual products, shampoo, and deodorant are often competing for these limited funds.

Females living in these circumstances should not be compelled to allocate their sparse allowance to meet their basic menstrual product needs. House Bill 2003 represents a positive step forward in addressing this issue, ensuring that individuals with I/DD have access to necessary menstrual products without compromising their personal allowance for other essential items. We firmly believe that this bill aligns with our commitment to advocating for the well-being and dignity of individuals with developmental disabilities. By removing financial barriers to menstrual products, HB2003 supports the daily lives of those who require these essential items.

The Hawaii Health & Harm Reduction Center (HHHRC) **supports HB 2003** which would require the Department of Accounting and General Services to provide menstrual products at no cost in each covered restroom of each covered public building. Furthermore, the bill requires access for all menstruating people by providing products in gender-neutral restrooms and in absence of that, in at least one men's restroom with signage in the remaining men's restrooms. This is especially important for people who may identify as transgender or non-gender conforming and may fight discrmination.

HHHRC finds great need for products in our outreach on the streets of Honolulu and this bill will go a long way at not only fighting the stigma but increasing access.

# <u>RE: Support for HB 2003 - Relating to Menstrual Products in Public Buildings Maintained by the</u> <u>Department of Accounting and General Services</u>

Dear Chair Belatti, Vice Chair Takenouchi, and members of the Committee,

Ma'i Movement Hawai'i **strongly supports HB 2003**, which requires the Department of Accounting and General Services to provide menstrual products at no cost in each covered restroom of public buildings maintained by that department and appropriates funds. We **offer an amendmen**t to the bill to place signage in all restrooms of those covered public buildings to indicate the location of free menstrual products.

Ma'i Movement Hawai'i is a locally grown organization committed to addressing menstrual inequity and ending period poverty, or the inability to buy and access menstrual products, due to factors including but not limited to financial constraints, lack of menstrual health education, feelings of societal shame or stigma surrounding menstruation, and inadequate access to clean facilities to maintain proper hygiene. We recognize the all-encompassing societal challenges inherent in tackling the broader issue of period poverty and menstrual inequity that disproportionately affects students, low-income and houseless girls and women, trans and gender non-conforming individuals, and those who are incarcerated. Access to period products is a fundamental human right.

Menstruation is a natural monthly occurrence experienced by nearly half the population and an estimated <u>302,000</u> menstruators (aged 10-44 years) in the State of Hawai'i, for much of their lives. Yet, negative sociocultural stigmas associated with menstruation have left many people who experience menstruation feeling shame and without access to resources. Menstruation should not be treated differently from any other basic bodily function, and menstrual products are instrumental to the general health and welfare of those who menstruate. In fact, the <u>American Medical Association (AMA)</u> adopted new policies in 2021 that recognize the adverse physical and mental health consequences of limited access to menstrual products and seek to increase their availability in the workplace and schools.

Free menstrual products are necessary in our state public buildings because such facilities serve the people of Hawai'i and have long provided a safety net for some of our most vulnerable populations. While we were advocating for free menstrual products in all Hawai'i public and charter schools in 2022,

we started to work with the Senate to install dispensers that provide them for free in the Hawai'i State Capitol bathrooms. Since then, we have worked with the State libraries, courthouses on O'ahu, Maui, Hawai'i island, and Kaua'i, the House of Representatives, and Kaua'i county on several pilots to expand access to free period products in public-serving facilities. We have anecdotal evidence that access to free period products helped menstruators who were caught off guard or unprepared at the start of their period and are welcomed by many in these spaces.

Further research shows that <u>86%</u> of people who menstruate have started their periods unexpectedly in public, and 34% have needed to leave what they were doing to retrieve menstrual products at home. Such disruptions cost considerable time and resources. Moreover, 46% of adult menstruators reported in a national study, <u>State of the Period</u>, that they are afraid their career growth could be negatively affected if they ask for accommodations. Oftentimes, menstruators suffer through humiliating menstrual moments in public, like bleeding through their clothes or on chairs, which adversely affect their productivity, attention, and social-emotional well-being. Establishing wider access to free menstrual products ensures more inclusive and equitable access to public facilities and reduces barriers faced by visitors to state buildings. Just as the Women's Legislative Caucus led the change to provide diaper changing stations to make it easier for families visiting the Capitol in both men's and women's bathrooms, we want to meet the needs and protect the dignity of all menstruating people.

Since menstruators do not have the option to cease their period or flow, menstrual products should be deemed essential. We regulate and ensure toilet paper and paper towels are available in restrooms to meet basic needs for health and sanitation, and menstrual products are no different. It is well-established in research and our own statewide data that when menstruators have limited access to resources during menstruation, they seek other coping methods. This includes but is not limited to the practice of using unsafe and potentially harmful alternatives, like leaves, paper towels, and socks, using menstrual products beyond the recommended time, or going with none at all. As a result, menstruators face potential medical issues, including preventable infections that make them susceptible to cervical cancer, infertility, and toxic shock syndrome, which are serious and can result in death. It's a public health concern and unhygienic not to have access to menstrual products, no less so than lack of access to toilet paper.

Lastly, the free provision of menstrual products in public buildings alleviates the burden of period poverty. Menstrual products are becoming economically out of reach for a growing number of menstruating girls, women, trans, and gender non-conforming individuals in our State. We know from the <u>Alice in Hawai'i: 2022 Fact and Figures report</u> that the number of Hawai'i households struggling to make ends meet reached a new high in 2022, at 44% of households. Equally concerning, 15% of households have income below the federal poverty level, representing a sharp increase from 9% in 2018. According to recent data from the <u>Household Pulse Survey</u> at the end of 2023, 63% of local households report difficulties paying for usual household expenses; of those, 52% are biologically female.

We also know from our work that those struggling to meet basic needs are likely to be the same individuals impacted by period poverty. The <u>2021 report conducted by Hawai'i State Commission on the</u> <u>Status of Women and Ma'i Movement Hawai'i</u> revealed the extent of the issue in the state. The exceptionally high cost of living and wage gap for women specifically exacerbate period poverty in Hawai'i. 90% of respondents believe menstrual products are expensive, and nearly 30% of respondents reported that they or someone in their household experienced difficulty obtaining them, of which cost was

the most cited reason. Menstruation also impacts participation in daily activities, with half of respondents reporting missing school or work because of it. Menstrual products are vital for the physical and mental health, well-being, and full participation of menstruators. Failure to consider period needs is a form of sex-based discrimination that disproportionately affects menstruators.

There is growing support nationally and globally for expanded access to free menstrual products. Scotland became the first country in the world to pass legislation in 2020 that offers menstrual products free of charge to anyone who needs them. Congresswoman Grace Meng (D-NY) introduced sweeping legislation to address menstrual needs in the federal bill <u>H.R. 3646 - Menstrual Equity For All Act of 2023</u>. In the past few years, <u>Ann Arbor</u>, <u>Austin</u>, <u>Utah</u>, and <u>Washington DC</u> have passed legislation to make menstrual products free and available in state facilities.

Aloha Chair Belatti, Vice Chair Takenouchi, and committee members,

The Hawai'i Women's Coalition is a catalyst for progressive, social, economic and political change through action on critical issues facing Hawaii's women and girls. Members currently include 29 organizations and agencies (private, public, membership), as well as individuals. The coalition encourages the inclusion of interested parties and in achieving equitable representation.

The Hawai'i Women's Coalition respectfully submits testimony <u>in strong support of HB2003</u>. The free provision of menstrual products is vital for ensuring the health, dignity, and full participation of menstruators. A <u>national study</u> commissioned by Free the Tampon found that 86% of people who menstruate have started their periods unexpectedly in public, and 79% have had to improvise a tampon or pad out of toilet paper or something else. Women, māhū, trans men, gender non-conforming, and non-binary people who menstruate deserve to have their basic needs met.

Local data from the <u>2021 survey conducted by Hawai'i State Commission on the Status of</u> <u>Women and Ma'i Movement Hawai'i</u> explored the extent of period poverty and menstrual inequity in the state. Nearly 30% of respondents reporting that they or someone in their household experienced difficulty obtaining period products, **of which high cost was the most cited reason**. 84.7% believe menstrual equity is a real problem, like food and housing insecurity.

By providing menstrual products in state buildings, Hawai'i helps ensure those who menstruate have equal access to public facilities, irrespective of their gender or economic status.

**HB2003** is an initiative that takes steps to address menstrual inequity in Hawai'i and promotes common goals of public health, basic equity, and gender equality for girls, and transgender and



non-binary people. For all of these reasons, the Hawai'i Women's Coalition is pleased to support **HB2003**. Thank you for the opportunity to submit testimony on this important matter.

My name is Krystine, and thank you for allowing me to speak today. I am here to support Bill HB2003, which will require the Department of Accounting and General Services to provide menstrual products at no cost in each covered public building. As a graduate student, I have personally struggled with affording and obtaining the necessary menstrual products during my cycle where I have used toilet paper as an alternative. This struggle has led me to actively advocate for menstrual equity and fight period poverty. In August 2022, I won a \$500 grant from the Pad Project, which provided me with 2,376 menstrual pads to distribute in the East-West Center Residence Halls. While this was helpful, I believe we can do more to address the issue of period poverty. That's why I'm in full support of Bill HB2003. The availability of menstrual products in public buildings would help those who cannot afford to purchase them regularly and provide options for those who need different products for their body and flow. During the Fall of 2022, I hosted two film nights focused on period poverty and had discussions with students who shared their struggles with affording menstrual products. Many students reported that they often put menstrual products last on their priority list, so they can afford food, and pay their rent, which has been difficult with the recent inflation. They even skip class when they have their menstrual period, which is unacceptable. Access to menstrual products is a basic need for all menstruating people and should not impact essential activities of our daily lives. Furthermore, homeless individuals cannot afford these products and have to resort to unsanitary options, such as toilet paper, or no options. The lack of access to menstrual products can lead to health risks, so having these products accessible would protect menstruating people in Hawai'i.

The bill would allow products to be accessible in a sustainable way. In February 2023, I won a \$5,000 grant, which allowed me to purchase various menstrual products to be placed in each female and gender-neutral restroom of our residence halls. Although helpful and well utilized, this is not sustainable because I cannot apply for grants every year to cover these expenses for menstruating individuals. After all, my time as a student there will eventually end. Therefore, having these products readily available would make a difference because it would give access. In conclusion, I believe that Bill HB2003 can make a difference in the lives of menstruating individuals who do not have access to menstrual products.

My name is Bevin Parker-Evans and I am a resident of Omao, Kaua'i from district 17. I am testifying in support of House bill number #2003. As a resident of Kaua'i, I was able to witness first hand the important impact of introducing menstrual products to our local Kaua'i Middle and High School restrooms in the past few years. Suddenly the 40-50% of homes and families struggling to make ends meet were able to get some relief for their female children when they were attending school during their menstrual cycles. Thank goodness for this type of support when it comes to gender, socioeconomic, and racial injustice of "Period Poverty" in Hawai'i.

Immediately, I thought to myself about this wonderful benefit given to Kaua'i female youth, and how it might be an additional bonus if the state of Hawaii could provide something similar for female adults who are also in need of economic support when it comes to the increased high cost of imported menstrual products. Not only would state buildings benefit from this bill and their employees and visitors, but it would also be a very good thing for all public buildings, including public covered restrooms inside our county buildings, for obvious reasons. Our people are served by the State of Hawai'i and the County governments for business and everyday needs. Many women go to the buildings at least twice per month. Recently, I was at a public restroom where there was a plumber conducting a repair to the toliets. Unfortunately, the entire bathroom was flooded and the two toliets were both inoperable due to the fact that inapporpriate cloth rags had been substituted for menstrual pads by a woman during her period and the result was a significant clog and plumbing issue in this bathroom. According to the plumber, he said that it was now a common occurence with women substituting notebook paper, leaves, socks and other cloth items or diapers for the period products they no longer can afford for their menstural cycles. Not only was this woman's dignity taken away from her when this accident occurred, but now she felt responsible for the significant costs of repairs and the non-access to the bathroom by others. Providing free menstrual products to women in need may prevent further plumbing issues in our public restrooms and the cost to the state may actually be greatly reduced by eliminating unusual items of a non-flushable type.

Women who work for the government and women who do business inside of government offices deserve to be protected from "Period Poverty" by strengthening our support for women living here in Hawai'i without any penalty, especially due to the high cost of living and the high cost of imported expensive menstrual products.

Obviously, Hawaiian households, particularly on the neighbor islands, have struggled since before Covid lockdown to keep their families safe, keep food on the table and protect themselves from having to move out of state due to the high cost of living in Hawai'i. Purchasing everyday needed items for personal hygiene has become very difficult. "Period poverty" and menstrual inequity are serious threats to menstrual health, and it can affect mental health as well as our overall general health. The serious impact on public health, gender equality, access to education, workplace equity, and the ability to lead a normal life is a serious detriment to our population of women struggling everyday to live and work in the State of Hawai'i.

Please, I urge you to support this bill HR 2300 to give funding for the support of the women of Hawai'i and their heath and well-being.

In 2021, Ma'i Movement Hawaii and the Hawaii State Commission on the Status of Women published a study to better understand the ways that period poverty affects the menstruators of our state. The study found that 50% of respondents had missed school or work due to their periods and that nearly 30% of respondents had difficulty obtaining period products due to various barriers including cost, knowledge, accessibility, and stigma. Establishing wider access to free menstrual products would help to ensure more inclusive and equitable access to public facilities and reduce barriers faced by visitors to state buildings meeting basic needs. This bill also protects the dignity of all menstruating people and promotes greater menstrual equity in the State.

Menstruation is a bodily function that is just as important as any other bodily function. It is a biological process, and people who menstruate cannot simply "opt out" of having their periods. Thus, menstrual products are a basic necessity like toilet paper, hand soap, and other personal hygiene products, but are economically out of reach for a growing number of menstruating girls, women, and gender-diverse people. The state currently provides soap, toilet paper, and paper towels in its bathrooms (and continues to stock them when vandalism or theft occurs) because those are basic necessities that people need to address their bodily functions. The state doesn't expect non-menstruators to provide their own rolls of toilet paper in each of its buildings, yet it currently does expect menstruators to provide their own menstrual products. Aloha Chair Della Au Bellati, Vice Chair Jenna Takenouchi, and Committee Members,

My name is Jane Kwan, and I was born and raised in Honolulu. I am currently a senior attending the University of Hawai'i at Manoā. I am testifying in support of HB2003 to require the Department of Accounting and General Services to provide menstrual products at no cost in each covered restroom of each covered public building.

I strongly support this because I believe the lack of access to period products is a fundamental equity concern that can have a significant impact on an individual's physical and mental health. Given that about half of the population experiences menstruation, which can last for several decades, the financial challenges that many individuals face when acquiring these products is greatly concerning. It can also be a risk to their health if they substitute with unsafe materials (rags, leaves, etc). Thus, period products should be considered a basic need akin to toilet paper and provided in all covered restrooms of public buildings.

For students, experiencing period poverty can also be detrimental to their education. In a recent survey of University of Hawai'i students conducted by Ma'i Movement Hawai'i and George Mason University, about 43% of menstruating students have experienced period poverty in the past year. About one in five of those students have experienced it monthly. Several student participants have also reported academic disruptions as a result of it. Having free menstrual products in the restrooms would undoubtedly greatly alleviate these problems.

I work at the University of Hawai'i at Manoa Women's Center, where a stock of period products (supplied by donations) is available for students in need of it. Since the start of the Spring 2024 semester (about one month), already 60 products have been distributed. This highlights the need for more accessible period products for students on campus. In my personal experience, I unexpectedly got my period right before a final exam (which was worth a significant portion of my overall grade), and I did not have any pads with me. I questioned the front desk of the university library, a very public place, and learned that they did not stock supplies in any of their bathrooms. Thankfully, I knew my workplace had pads available so I was able to get what I needed and make it to my final exam on time. If not for the Women's Center, taking that exam would have been a very uncomfortable experience and would likely have impacted my performance. However, my experience is nothing in comparison to those who struggle with access to period products regularly and face greater financial and mental burdens because of it, which is why this bill is so important.

Aloha House Health & Homeless Committeemembers -

I strongly support HB2003. As staff co-located in the UHMānoa Women's Center, I see the need every day. There are people who cannot afford the basic necessity of period products. The Women's Center offers free period products and has voluntarily spearheaded programs to provide both INFO re: WHERE students can find period products on campus (at least since 2015) and FREE period products since 2022 (including donated period products from a variety of folks, including Ma'i Movement).

The national and state conversations re: period poverty and period products initiated by groups like Ma'i Movement have brought attention to a long-standing need. As research specific to UH Campuses shared by Ma'i Movement shows, at least 20% of UH students report "period poverty" on a monthly basis. And that study was conducted prior to current inflation.

Period Products should be considered the same as other hygiene items like toilet paper and hand soap – available to the public for free.

HB 2003 brings attention to the need and UH campuses are engaged in conversations, but **students can not** shoulder the cost.

As a woman, I am pleased to see this conversation (which impacts at least 50% of our community) gaining ground -- period products are as fundamental as toilet paper. Support HB2003.
