# TESTIMONY OF

### TO THE COMMITTEE ON TRANSPORTATION

### IN STRONG SUPPORT OF HB2015

### RELATED TO DEPARTMENT OF TRANSPORTATION

### February 6, 2024

Aloha, Chair Todd, Vice Chair Kila and Committee members. I am Larry Veray, Chairman for the Pearl City Neighborhood Board No. 21. I am submitting this testimony representing our board as a whole and the over 6,000 residents and families that live in Pacific Palisades in Pearl City. Thank you for allowing me the opportunity to provide testimony in strong support of HB2015, that would require the Department of Transportation to build an emergency egress road that could potentially save thousands of lives if a disaster occurred in Pacific Palisades allowing for evacuation of residents and access for emergency response vehicles.

Pacific Palisades is extremely vulnerable to a natural disaster such as hurricane high winds and flash flooding. With lessons learned from the Lahaina fires, a fast-moving wild fire could destroy the entire Palisades community. The community is built on a plateau above the main portion of Pearl City and the only access road to the area is Komo Mai Drive is a one lane, winding steep road, with a hairpin turn at the base of Palisades. There are two major vulnerabilities for the residents of Palisades: (1) a stream that runs under Komo Mai Rd at the lower elevation of the road subject to possibly a flash flooding taking out the road and (2) many of the homes are built on the peripheral are unable to build fire breaks because their property is right to the edge of those peripheral residential properties.

As my Vice Chair Charmaine Doran stated in her testimony, over the past two decades, the residents of Palisades have been held captive to water main breaks, tree fallings, two actual hostage crises events, road flooding, traffic accidents, police shootings/investigations and much more requiring closing Komo Mai Drive the only access road to Palisades. These events have impacted thousands of residents who were unable to return home or even leave their neighborhood, waiting for hours to receive the all clear for the road to open to residents.

I most strongly urge you to pass HB2015. The residents in Pacific Palisades desperately require this emergency egress route to be built and thank you for the language in this bill. Mahalo!

Thank you for considering this measure. A big mahalo to our Pearl City state representatives and senators for advocating on behalf of the Pacific Palisades community.

Over the last two decades, the residents of Pacific Palisades have been held captive to water main breaks, tree fallings, two actual hostage crises, road flooding, traffic accidents, police shootings/investigations and much more. When these types of events happen, 6,000+ residents are unable to return home or even leave the neighborhood. In the past, when residents inquired about an alternate route or emergency access point, we have been told that it would be on us to pay for the road ourselves. While money is a surefire way for the government to put the brakes on almost any requests, with this - it is wrong, and it is irresponsible.

Palisades is a resilient and undemanding community. We have a vibrant elementary school located across our only emergency siren. A siren that has been broken for years. We border the state Ewa Forest reserve - which lacks adequate firebreaks. Despite having no parking, security, or even waste removal services, in the forest, we regularly host residents, tourists, tours, the military, hunters, and campers. Palisades residents routinely clean up after many of these visitors. There are also numerous emergency rescues each year due to those lost or injured in the forest. Yet, the requests from the Palisades community are far and few.

The Lahaina fires have sparked a new and heightened awareness about emergency procedures. Today, we better understand the role of government in protecting citizens during an emergency and how that starts **before** a disaster. It starts with adequate emergency planning and funding. On behalf of my neighbors and the many people that visit Pacific Palisades daily – we ask for your attention to this matter and the adoption of this bill.
