Chair Perruso and Members of the Committee:

The Department of the Attorney General provides the following comments.

This bill: (1) requires the University of Hawai'i to establish a three-year pilot program to enrich diversity across all University of Hawai'l campuses; and (2) makes an appropriation for the program.

Article X, section 6, of the Hawai'i Constitution gives the Board of Regents of the University of Hawai'i "exclusive jurisdiction over the internal structure, management, and operation of the university." Section 6 further provides: "This section shall not limit the power of the legislature to enact laws of statewide concern. The legislature shall have the exclusive jurisdiction to identify laws of statewide concern." If the Committee decides to pass this bill, we recommend an amendment that adds a statement identifying this bill as a law of statewide concern.

HB 2063 – RELATING TO THE ENRICHMENT OF DIVERSITY IN THE UNIVERSITY OF HAWAII SYSTEM

Chair Perruso, Vice Chair Kapela, and Members of the Committee:

The University of Hawai'i (UH) expresses our support for HB 2063 and the proposed appropriation which aims to fund a three-year pilot program to enrich diversity across all University of Hawai'i campuses. The proposed pilot program and accompanying appropriation align with our strategic plan's foundational principle on equity.

UH is proud to serve a diverse student and community population. Currently, 75% of students across the system are classified as residents of the State of Hawai'i, while the other 25% are classified as non-resident. Around 60% of students identify as Asian or a Pacific Islander, while 19% identify as Caucasian, 16% as two or more races, and 2% as African American or Black. Several of the campuses have been recognized in recent years as being among the most ethnically diverse campuses in the nation by *U.S. News and World Report.*

We believe that promoting diversity not only aligns with the values inherent in Hawai'i's culture but also contributes significantly to the overall academic and personal growth of our students. The proposed three-year pilot program is a commendable initiative that will provide open and inclusive activities for students and the general public.

Please note that UH already offers a variety of successful diversity programs across its campuses. A partial list of events can be found at https://www.hawaii.edu/calendar. Examples include cultural events celebrating various ethnic traditions, workshops promoting awareness of disabilities and inclusion, educational programs addressing LGBTQ+ issues, and initiatives supporting minority communities. These programs have proven effective in fostering a sense of community and respect among our diverse student body, and funding from this measure will allow expansion of these programs.

In conclusion, we support HB 2063 and express our gratitude for the recognition of the importance of diversity within UH.

TESTIMONY IN OPPOSITION TO HB2063 CURRENT LANGUAGE BUT SUPPORTING IF LANGUAGE IS AMENDED

The best thing about this bill is that it seeks to promote demographic diversity of the races, ethnicities, nationalities, and genders of student and community activities. The worst thing about this bill is that it totally fails to promote the most important kind of diversity necessary for any ACADEMIC institution or university which wants to foster intellectual inquiry and academic freedom -- DIVERSITY OF VIEWPOINT. I have attended numerous events at UH-Manoa and UH-Windward led by panels of professors and students who were demographically diverse but conceptually parochial: biased, bigoted, prejudiced, shallow, disrespectful toward differing viewpoints which were often excluded from being presented and were publicly ridiculed and dismissed when raised by people in the audience during discussion Q&A periods. It's important for organizers and presenters to have not only a diversity of viewpoints among themselves but also a diversity of viewpoints in the subject matter being presented. Such diversity of viewpoint is most clearly absent in the curriculum and activities in the fields of Hawaii's history, political science, sociology, anthropology, urban and regional studies, teacher education, philosophy, etc.

Section 1 CURRENTLY SAYS "The legislature finds that the University of Hawaii system serves a diverse student and community population across the State. Much like is mirrored in Hawaii's culture, it is important to recognize such diversity and promote an inclusive environment that celebrates those who may have been marginalized in the past. Through student and community activities that enrich diversity, the University of Hawaii has an opportunity to further foster a first-rate education experience. The purpose of this Act is to require and appropriate funds for the University of Hawaii to enrich diversity across its campuses."

Section 1 SHOULD BE AMENDED TO SAY: The legislature finds that the University of Hawaii system serves a diverse student and community population across the State, and teaches a curriculum which includes many controversial topics with widely diverse viewpoints. Much like is mirrored in Hawaii's culture, it is important to recognize such diversity and promote an inclusive environment that celebrates people and ideas which may have been marginalized in the past or are currently excluded from serious consideration. Through student and community activities that enrich diversity of people and viewpoints, the University of Hawaii has an opportunity to further foster a first-rate education experience. The purpose of this Act is to require and appropriate funds for the University of Hawaii to enrich demographic and viewpoint diversity across its campuses.
