1 **Fiscal Implications:** Undeteremined general fund appropriation.

2 **Department Testimony:** The Department of Health (DOH) supports the intent of HB2087.

3 Facilitating access for kupuna for certain public services in the state or county is a laudable goal.

4 Some elderly may not be computer literate, others may be hard of hearing such that telephonic

5 services are difficult, some may not have reliable transporation or be able to stand in line, while

6 still others may have cognitive impairments.

7 Because there are an array of accessibility solutions for the most common public services,

8 including different solutions for the same service depending on location, DOH recommends that

9 the role of the Executive Office on Aging (EOA) be amended to that of convener and fiscal

10 intermediary, and that the scope of the pilot be limited to county services to reduce complexity.

11 HB2087 may be amended to require county programs, for example motor vehicle registration

12 and driver licensing, to review their programs for elderly accessibility and develop plans and

budgets for EOA review. EOA and county Offices on Aging may then award grants to

14 promising projects, and leveraging their expertise on kupuna issues, establish standards and

assure parity. Limiting the scope to county services only will also increase the resources for any

16 given project since there will be fewer programs competing for the same dollar.

Honolulu already has trained volunteers stationed at the Department of Motor Vehicles to
assist walk ins needing help with services.

EOA's purpose is to ensure a comprehensive, person-centered system of supports and services to address the "long-term care" needs of older adults, ages 60 and older, to be able to live in their community of choice and avoiding higher, more expensive levels of care. EOA as well as the Area Agencies on Aging provide linkages to programs and services in the community However, a pilot project to support on-line appointments and scheduling require dedicated staff and resources to stand up a pilot program.

9 Amendment to page 2, line 5, section 2 replace (a) with the following: There is established in 10 the executive office on aging a two-year elder access pilot program. EOA may enter into 11 Memorandums of Agreements (MOAs) with counties and other state agencies to implement 12 this project. The purpose of the project is to improve access to essential services, reduce wait 13 times, and enhance the overall experience for persons sixty-five years of age or older in Hawaii 14 who are seeking public services through state and county government offices.

Recommendation: EOA recommends an amendment for flexibility in the pilot program. In addition, requiring public services to be more "user" friendly meaning that there are multiple ways to help individuals, especially those who do not have access to technology. This would require publicly faced state and county offices to have an individual(s) dedicated to support walk-ins and a dedicated phone line.

Our mission is to promote public health in Hawai'i through leadership, collaboration, education and advocacy. Additionally, HPHA aims to call attention to issues around social justice and equity in areas that extend beyond the traditional context of health (e.g., education, digital equity, cultural sensitivity), which can have profound impacts on health equity and well-being. Therefore, as stewards of public health, HPHA is also advocating for equity in all policies.

HPHA supports HB2087 as the bill aims to establish a two-year senior access pilot program in the Executive Office on Aging to improve access to essential services and reduce wait times for seniors seeking public services through state and county government offices. The pilot program shall work with state and county government offices that offer public services to create dedicated priority lanes, priority online scheduling, or dedicated priority phone lines for persons sixty-five years of age or older.

With the growing increase in the State's senior population, this measure would address senior residents who often face unique challenges when accessing services, including mobility issues, hearing impairments, and limited technological proficiency. Additionally, seniors are often disproportionately impacted by long wait times for services, leading to frustration, anxiety, and delayed access to essential care.

HPHA strongly supports HB2087 and respectfully asks that you pass this measure. Thank you for the opportunity to provide testimony on this important public health issue.
