Chair Nakashima and Members of the Committee:

The Department of the Attorney General (Department) strongly supports this bill.

The purpose of this bill is to establish in the Department a state-wide program responsible for issuing firearm qualification credentials to qualified retired law enforcement officers to carry concealed firearms pursuant to the Federal Law Enforcement Officers Safety Act of 2004 (LEOSA). LEOSA requires qualified retired law enforcement officers to be properly certified before being allowed to carry concealed firearms.

The Department would create a program that would be well regulated and operated uniformly throughout the State with public safety as a priority. Under the LEOSA certification program, retired officers could be certified only if they pass standardized firearms qualification testing, a medical exam every two years, and a mental health clearance every year.

This bill will give the Department statutory authority and the ability to promulgate rules to ensure qualified retired law enforcement officers are properly certified to carry concealed firearms safely.

The Department respectfully requests the passage of this bill.
