### In consideration of HB 2422 RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

Chairs Ichiyama and Evslin, Vice Chairs Poepoe and Aiu, and members of the Committees. The Hawai'i Community Development Authority (HCDA) offers **comments** on HB 2422, that adds the Chair of the Hawaiian Homes Commission (HHC) or the Chair's designee as a nonvoting member to the HCDA Kalaeloa board and general authority board.

Since I first learned of this proposed measure, Kali Watson, Chair of the HHC, and I have had several discussions. Chair Watson said that his personal involvement on the Kalaeloa community development district board will bring his personal expertise and experience, as well as the resources of his agency to bear in the further development of the Kalaeloa community development district.

During those discussions, I expressed concerns. They are noted here for context:

• The addition of another government, ex-officio member, even if nonvoting, would change the "community" nature of the board and make it more "government heavy" which does not seem to align with the intent to have community boards. Currently, there are five (5) community members and four (4) government, ex-officio members on the Kalaeloa community development district board. Adding another government, ex-officio member would change the composition to five (5) government and five (5) community members.

It is not possible for Chair Watson to just have a seat on the Kalaeloa community development district board. Chair Watson would also need to be on the general authority board, which includes the members on all the district boards, and would add an 18<sup>th</sup> member to that board. Should two additional community development districts be established by the Legislature (HB 1781/SB 27666 and HB 2724) and become law, the authority board could grow to 22 members.

As an alternative to the Chair utilizing his valuable time siting on our boards, I have offered Chair Watson open access to me directly.

We have scheduled a monthly cadence of one-on-one, in person meetings, at Chair's office, as an opportunity for us to collaborate on community development. Additionally, Chair knows that he is welcome to call me on my cell phone at any time.

It is my belief that the collaboration between Chair Watson and I will transcend a board seat into a successful working relationship between HCDA and the Department of Hawaiian Home Lands that results in economic, social and housing opportunities for Hawai'i's people.
