HB 353 - RELATING TO HEALTH CARE EDUCATION

Chair Perruso, Vice Chair Kapela, and Members of the Committee:

The University of Hawai'i supports the intent of HB 353, which would provide funds for the expansion of the Certified Nurse Aide (CAN) to Practical Nurse Bridge Program at UH Maui College. This innovative program was developed in partnership with industry employers to streamline entry of currently working CNAs into the Licensed Practical Nurse (LPN) training program.

HB 353 will enable UH Maui College to further expand the program statewide and meet the statewide LPN workforce shortage by supporting instructional costs and student aid. The instructional funding will encourage Registered Nurses in the field to become clinical and lab lecturers for expanded cohorts across the state. The student aid funding will increase access to the LPN program by supporting tuition, fees, supplies, and related costs. According to the Healthcare Association of Hawai'i, the current LPN statewide vacancy rate is at 30%, with 211 LPN job openings statewide.

The University of Hawai'i supports the intent of HB 353, on the condition that any funds appropriated in support of this program does not supplant any portion of the University's budget request.

Comments on H.B. 353

Chair Perruso, Vice Chair Kapela, and Members of the Committee: Thank you for the opportunity to present comments on this measure, H.B. 353, which appropriates funds for the expansion of the certified nurse aide to practical nurse bridge program at the University of Hawai'i Maui College, including funding for instructional costs and student aid.

The Maui College certified nurse aide to practical nurse program is novel in that it retro-fitted the pre-requisites, curriculum, and delivery to target excellent certified nurse aides who both are seeking career advancement and are dedicated to their workplace. By creating cohorts within health settings, this program delivers education where the workforce is.

This program is remarkable because our state's licensed practical nursing (LPN) programs are dwindling, and are in dire condition. In the Hawai'i State Center for Nursing AY 2020-2021 Educational Capacity report¹, we note:

"LPN programs suffered substantial losses in seats for new students... the state lost 35% of its seats for new LPN students in AY 20-21 as compared to the previous academic year. This loss is especially worrisome because of the heavy reliance that many non-acute facilities place on LPNs and the fact that the LPN workforce in the state has been shrinking for several years despite consistent capacity in LPN programs prior to the pandemic" (page 18).

In addition, the Hawai'i State Center for Nursing 2021 Nursing Workforce Supply Report² stated that *"it is certain that the number of LPNs in Hawai'i continues to decline which will exacerbate a critical shortage, especially in postacute/long-term care"* (page 13).

The mission of the Hawai'i State Center for Nursing is that through collaborative partnerships, the Center provides accurate nursing workforce data for planning, disseminates nursing knowledge to support excellence in practice and leadership development, promotes a diverse workforce, and advocates for sound health policy to serve the changing health care needs of the people of Hawai'i.

The 2022 Healthcare Workforce report produced by HAH noted a statewide demand for 211 additional LPNs. Unfortunately, there are not enough opportunities to educate and train for this particular type of clinician, which is why HAH, in partnership with stakeholders and UH Maui College, are creating the first of its kind CNA to LPN Glidepath program. This program coupled with increasing entry-level certification programs and expanding nurse residency programs reflects a concerted effort by the healthcare community to invest in our local workforce.

Investing in our overall healthcare workforce is essential to meeting the need for professionals at all levels in our state - especially on our neighbor islands. Thank you for allowing Queen's to provide testimony in support of this measure.

My name is Michael Robinson, and I am the Vice President of Government Relations & Community Affairs at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers - Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

HPH writes in support of HB 353 which appropriates funds for the expansion of the certified nurse aide to practical nurse bridge program at the University of Hawai'i (UH) Maui college. This important funding will allow the CNA to LPN glidepath pilot program currently ongoing at UH Maui College to continue. The glidepath program has been one of the most visible and successful pilots of the Healthcare Workforce Initiative.

The 2022 Healthcare Workforce Initiative report indicates that there is a statewide demand for 211 additional LPNs. Unfortunately, there are inadequate opportunities to educate and train for this particular type of healthcare worker. The efforts by the Healthcare Association of Hawai'i, in partnership with Ohana Pacific Health/Hale Makua and UH Maui College resulted in the creation of an innovative, first of its kind CNA to LPN Glidepath program. This program enables an "earn and learn" glidepath model that delivers online didactic curriculum and hands-on clinical education at a student's place of work. The program is one year long, and CNAs can double their salary if they successfully complete the program.

This pilot program was launched in January 2023, and serves students through UH Maui College on Maui, Oahu, and Kauai who are employed by Ohana Pacific Health and Kaiser Pemanente. There was a huge demand for participation in the program, which ultimately included 40 students. The funding appropriation in this measure will enable the program to continue and, hopefully, expand to all islands and include more students to meet the demonstrated interest in this glidepath.

I am the Administrator of Pu'uwai `O Makaha (POM), a 93-bed post-acute facility located in Waianae, Oahu, Hawaii. We provide short-term rehab, long-term care and hospice services. We also provide a multitude of services in therapy, clinical and psychological areas. We are a 4-star rated facility with a Quality Measure Rating of 5. Even with these ratings, we are still unable to fully staff our facility and we still experience difficulties retaining staff. Our census has decreased nearly 20% since COVID-19. As of February 6, 2023, we have 2 Resident Care Manager and 1 Charge Nurse position open (all 3 Licensed Nurse positions), and 5 CNA positions open. It has been extremely difficult to fill these positions.

Comments:

Ohana Pacific Health (OPH) / Hale Makua Health Services (HMHS) is the largest provider of post-acute care services and also the largest provider of Medicaid nursing facility services in the State of Hawai'i. Our organization provides short-term rehab, long-term care, adult day health services, home health care, and Care Management/Navigation Services on all four major islands. Our organization also employs approximately 1,500 healthcare workers and manages approximately 950 nursing home beds.

I want to thank you for the opportunity to provide testimony in **SUPPORT for HB 353** and its associated funding to support a pathway to develop critically needed health care professionals. The need for licensed heath care professionals has been at a critical point for some time so I would encourage you to also consider increasing the funding in the bill to expand this much needed program.

The healthcare industry in Hawaii has been significantly impacted by the shortage of qualified workers, especially for Certified Nursing Assistants and Licensed Practical Nurses. This shortage creates a domino effect where the acute care hospitals are unable to release their patients to our facilities, mainly because many of our facilities cannot admit these patients due to the lack of an adequate workforce, which in turn has severely impacted our organization's financial situation.

This pilot program has created an opportunity for entry-level healthcare workers to advance in their careers while still working, an option not often available for students, especially in the healthcare industry. This program is unique - it provides a career path for healthcare workers with very little financial risk and job opportunities at their current place of employment.

The current program supports 40 students on 3 islands – Oahu, Maui and Kauai. Expanding this program to accommodate more students across all of the major islands would help solve the critical need for healthcare workers in Hawaii.

Ohana Pacific Health (OPH) is the largest provider of post-acute care services in the State of Hawai'i and also, the largest provider of Medicaid nursing facility services. Our organization employs almost 1,500 healthcare workers and manages approximately 950 nursing home beds that provide short-term rehab and long-term care, adult day health services and home health care, and Care Management/Navigation Services on all four major islands.

I am part of our company's team to find solutions to the healthcare staffing challenges that Hawai'i is facing. The current landscape of healthcare in Hawaii is significantly affected by a lack of workers, particularly for CNA's and Licensed Nurses. The affect of this shortage is that many of our facilities are unable to admit patients from the acute care hospitals due to the lack of workforce, which has exacerbated our financial situation. This situation is causing record high census in the hospitals to a "crisis point". Additionally, the lack of workforce and the resulting drop in census has severely affected our industry, as evidenced by the recent closure of Wahiawa Hospital's long term care facility, and several mainland operators leaving the market.

This pilot program has been a tremendous success, by providing the ability to recruit new entry level healthcare workers and offer them a pathway to become a licensed practical nurse in an "earn and learn" environment.

This has not only provide a pathway to a living wage for participants, but also is assisting in solving the severe shortage of healthcare workers.

Re: <u>Support</u> <u>HB 353 Relating to Healthcare Education</u>

Hale Makua Health Services and Ohana Pacific Health provide care for Hawai'i's kūpuna throughout the state. The shortage of nurses in long term care settings has deepened in the last two years because of the Great Recession and effects of the COVID-19 pandemic.

The development and launch of the CNA to LPN Bridge Program has closely doubled the Licensed Practical Nurse enrollments in 2022. This means that there will be 36 additional home grown licensed nurses by this time in 2024, that will continue to care for our community on their home islands. These are individuals who already work as Certified Nurse Aides for some of our most vulnerable kūpuna.

This Bridge program allows healthcare workers in these entry-level positions, to grow into professional healthcare workers. The Bridge increases their earning potential, and keeps families from moving away to pursue other educational opportunities. Some of these students have tried and failed to enter Hawai'i's nursing programs over the years. Many have worked in healthcare for over a decade. While academic performance is a crucial component of success in any nursing program, nothing beats seeing someone's potential while they are performing care at work. Some of these CNAs needed that push from their supervisor, encouragement from their employer, and additional support from UHMC, in order to take their potential to the next level.

There are hundreds of nursing applicants throughout the State of Hawai'i that do not get admitted into this highly competative field of study. Many of these individuals are qualified, and ready to answer the call of duty, but the barriers to entry are high. The Bridge Program breaks down some of these barriers, and allows industry and education an opportunity to work closely together, to answer the needs of the community.

I support HB353, to continue and expand the funding of the Bridge Program into 2024 and beyond. This is an invaluable investment in the health of our State.

Thank you for this opportunity to provide strong support for HB353.

I am writing this statement in full and firm support of HB 353 as it relates to Health Care Education.

The Licensed Practical Nurse (LPN) vocational career path has historically been an active individual response to a "call to duty" for our great Country and the psychosocial and preventative health care needs of our population. Just as during and immediately following World War II, LPN training programs were a response to a marked supply and demand mismatch: namely, that there was a great need for nurses with technical and bedside skills; and for educational programs to meet this demand. This same sentiment rings true today, and particularly in the State of Hawaii, where the health care needs of our kupuna must be sacrosanct in order to maintain our rich heritage of health and harmony.

As a Clinical Educator in the CNA to LPN Bridge Program, I have first-hand knowledge of what this program means to our population, and most particularly, the students who have been admitted into the program. This educational program relies heavily on intrinsic drive and the ability to maintain focus, and my students have demonstrated these traits, despite the fact that the world at large might not consider them to be 'traditional' students. The program is a golden opportunity, mutually beneficial to the State of Hawaii and its residents, as well as the students themselves and their families and communities. My cohort of eight students on Oahu is answering the "call to duty" within our neighborhoods, and they are doing so with enthusiasm, grace, and gratitude.

It would seem that the opportunities outlined in HB 353, most particularly to continue and, indeed, expand the funding into 2024 and beyond, would be an invaluable investment to establish and maintain an equilibrium for the nursing supply within the State of Hawaii.
